

**NOTE 1 – PLAN DESCRIPTION**

The following description of the LendingClub Corporation 401(k) Plan (the Plan), which describes the terms of the Plan as of December 31, 2024 and 2023, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan, which began on February 1, 2013, is a defined contribution plan of LendingClub Corporation (LendingClub) and covers all eligible employees of LendingClub and participating affiliates. The Board of Directors of LendingClub has appointed the LendingClub 401(k) Plan Committee to control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Eligible employees may participate in the Plan on the first day of the month coinciding with or following the date the employee satisfies 90 days of service and reaches age 21. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants may elect to have up to 75% of their eligible compensation (generally defined as wages reported on Form W-2) contributed directly to the Plan, not to exceed the limit on 401(k) deferrals under the Internal Revenue Code (IRC) (\$23,000 and \$22,500 for 2024 and 2023, respectively). Such contributions are not currently taxable to participants. The Plan also permits eligible participants who will reach age 50 before the end of the Plan year and eligible participants older than age 50 to make catch-up contributions up to 75% of their eligible compensation subject to the limit on catch-up contributions under section 414(v) of the IRC (\$7,500 for 2024 and 2023).

Employees eligible to participate in the 401(k) salary deferral program are eligible to elect and make Roth 401(k) contributions, which are made on an after-tax basis. Combined pre-tax contributions and Roth 401(k) contributions may not exceed the limit on 401(k) deferrals under the IRC. LendingClub may match Roth 401(k) contributions in the same manner as the pre-tax 401(k) Basic Match. Any of LendingClub's Roth 401(k) match contributions are made on a pre-tax basis and will be taxed to the participant upon distribution from the Plan. Participants could also contribute regular after-tax contributions, up to 10% of compensation. Total pre-tax, Roth, and after-tax contributions from participants and Basic Match and Profit Contributions from LendingClub are subject to annual limits established by the IRC (\$69,000 and \$66,000 for 2024 and 2023, respectively).

Participant contributions may be matched by LendingClub's contribution (Basic Match) equal to 4% of eligible compensation per pay period, up to a maximum of \$5,000 per year. The Basic Match allocation is based on the participant's salary deferral contribution and eligible compensation. The Plan will include catch-up deferrals in the elective deferral amount used to determine the amount of matching contributions. The Basic Match contribution was provided by LendingClub in 2024 and 2023 in the amounts of \$3,144,397 and \$4,014,361, respectively.

At the discretion of LendingClub, an additional contribution (Profit Contribution) based on LendingClub's performance may also be made. The Profit Contribution allocation is based on a participant's eligible compensation during such Plan year. No Profit Contribution was made by LendingClub in 2024 or 2023.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant directs the investment of his or her account to any of the investment options available under the Plan. Each participant account is credited with the participant's contribution, the Basic Match, the Profit Contribution, if any, and Plan earnings. Participant accounts are also reduced by withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan document. The maximum benefit to which a participant is entitled is the participant's vested account balance.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their 401(k) contributions, rollovers, profit contribution, if any, and investment earnings on these amounts. The Basic Match and investment earnings on these amounts vest 100% after one year of service.

Participant Notes Receivable: Participants may borrow a minimum of \$1,000 up to a maximum of 50% of their 401(k) account balances or \$50,000, whichever is less. Loan terms may not exceed 5 years (or 30 years for the purchase of a primary residence). A loan is secured by the balance in the participant's account and bears interest at a commercially reasonable rate at the time the loan application is made. The interest rate remains fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions, or by check for repayments or payments by terminated participants. Loan payoffs can be made with no prepayment penalties. As of December 31, 2024 and 2023, participant loans have maturities through 2047 and interest rates of up to 8.50%, respectively.

Distributions: A participant is entitled to receive a distribution of the vested portion of his or her account upon termination of employment for any reason, including on account of death, disability, or retirement. Distributions may be made in the form of a single lump sum or installments, unless the participant is receiving a minimum required distribution as defined by the Plan. Distributions are also available in the event of certain defined events constituting financial hardship or upon meeting specific criteria. Once distributed to the participant, a hardship distribution cannot be deposited back into the participant's account.

Termination of the Plan: LendingClub has the right under the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. LendingClub has not expressed any intent to terminate the Plan.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by LendingClub and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contract, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable: Participant notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest. Participant loans are considered delinquent upon becoming 90 days past due as to interest or principal.

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

Risks and Uncertainties: The investments of the Plan are exposed to various risks, such as interest rate, credit, and market, including global events, such as the coronavirus pandemic. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan) and Empower Annuity Insurance Company of America.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

#### **NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

As of December 31, 2024 and 2023, the Plan held a fully benefit-responsive investment contract (FBRIC) in the general account of Empower Annuity Insurance Company of America (the “Issuer”). The Issuer maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 0.00%. The Issuer’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The contract value of the FBRIC was \$3,568,239 and \$3,686,820 at December 31, 2024 and 2023, respectively.

The Plan’s investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by LendingClub, and certain other LendingClub-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan’s loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

#### **NOTE 6 – INCOME TAX STATUS**

The Internal Revenue Service (IRS) issued an opinion letter dated November 14, 2022, indicating that the prototype plan adopted by the Plan as of February 1, 2022 through Empower Retirement, LLC, as then designed, was in compliance with applicable requirements of the IRC. The Plan has not been amended from the original prototype document, and Plan management believes that the Plan is currently being operated in accordance with the IRC.

Management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### **NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor’s regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of LendingClub. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by LendingClub. At December 31, 2024 and 2023, the Plan held an unallocated investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is a service provider to the Plan as of and or the years ended December 31, 2024 and 2023, and therefore, these transactions and the Plan’s payment of fees to it qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.
