### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of CIBT 401(k) Retirement Savings Plan Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of the CIBT 401(k) Retirement Savings Plan (the Plan) provides general information about the Plan's provisions. CIBT, Inc. (the Company) is the Plan Sponsor. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution profit sharing plan sponsored by the Company for the benefit of substantially all employees who are twenty-one years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Custodian and Administration of the Plan*

Principal Life Insurance Company (on behalf of Principal Global Investors Trust Company) (Principal) is the custodian and recordkeeper of the Plan. The administrator of the Plan is the Company. Principal Life Insurance Company is the issuer of the insurance products. Principal holds all assets of the Plan in accordance with the provisions of the service provider contract with the Company. The CIBT 401(k) Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Contributions*

Each year, participants may contribute from 1% to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also allows for Roth and Roth catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly hired or re-hired employees are automatically enrolled in the Plan at a default deferral rate set at 3% of eligible compensation, unless the employee specifically elects not to enroll or elects to defer a different percentage.

The Company contributes, as a pretax discretionary matching contribution, 50% of the first 6% of eligible compensation that a participant contributes to the Plan. The discretionary matching employer contributions are invested directly in the participant-directed investment options. Additional amounts may be contributed at the discretion of the Company in the form of additional matching or profit-sharing contributions. Participants are eligible for the discretionary profit-sharing contribution if they are employed on the last day of the plan year. Discretionary profit-sharing contributions are allocated based on the participant's annual pay for the plan year compared to the annual pay for all participants. There were no additional discretionary matching or discretionary profit sharing contributions made in 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, a collective trust, and a guaranteed income fund as investment options for participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and the Company's discretionary matching and discretionary profit-sharing contributions, if any, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are immediately vested in their voluntary and rollover contributions, plus actual earnings thereon. Discretionary employer contributions vest ratably over three years beginning with the first year of completed service with the Company.

### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to the lesser of (a) \$50,000, reduced by the highest outstanding loan balance of loans during the one-year period ending on the day before the new loan is made, or (b) the greater of 50% of the participant's vested account balance, or \$10,000, reduced by any outstanding loan balance on the date the new loan is made. The notes are repaid ratably through payroll deductions over a period of five years or less. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

The maximum number of loans allowed under the Plan is five. However, only one participant loan is allowed in a rolling 12 month period.

### ***Payment of Benefits***

Participants (or their beneficiaries) are eligible to receive Plan benefits upon retirement, disability, termination of employment or death. Distribution of the full value of their contributions and Company discretionary matching and discretionary profit-sharing contributions are available in a lump sum or installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, participants may elect in service withdrawals of their elective deferral account balances after reaching age 59½.

In certain hardship situations, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship.

The Plan also provides for minimum required distributions per the Internal Revenue Code (IRC).

### ***Forfeitures***

Forfeited accounts are utilized first to reduce Plan expenses and second to reduce employer contributions respectively. Forfeitures totaling \$131,690 were used to pay plan expenses and reduce employer contributions during the year ended December 31, 2024. At December 31, 2024 and 2023, the remaining balance of forfeited accounts totaled \$4,322 and \$3,949, respectively.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The CIBT 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, issuer, and custodian. See Note 4 for additional information related to fair value measurements.

The Plan's shares of mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The investment in the collective trust is valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The investment is a direct filing entity.

Pooled separate accounts are valued based on the publicly quoted pricing inputs which is used in determining the net asset value of the pooled separate account, which is not publicly quoted. The value of each pooled separate account is determined at the close of each business day based on fair value of the underlying assets, which can consist of a single mutual fund or multiple securities. The NAV, as provided by the issuer, is used as the practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. These investments are direct filing entities.

The guaranteed interest account is valued at fair market value. This account promises contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. Therefore, the guaranteed interest account is considered non-benefit responsive.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary profit sharing contributions are recorded in the period declared in accordance with the terms in the Plan document.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

## **3. Certified Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes to the valuation methodologies used during the years ended December 31, 2024 and 2023.

## 5. Related Party and Party-In-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Principal or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Principal by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan

operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employees receive compensation from the Plan.

### 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Plan Termination and Partial Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to suspend or discontinue contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of complete or partial Plan termination, participants would become 100% vested in their account balances.

In February 2025, the Plan's management along with Principal, determined that the Plan incurred a partial plan termination in 2024, as a result of certain employer-initiated reductions in force. Affected participants in a partial plan termination are required to become immediately and fully vested as of the effective date of their termination. As the partial plan termination was not identified in 2024, the Plan Administrator determined the impact to the affected participants and made the necessary corrections in 2025.

### 8. Income Tax Status

The IRS has determined and informed Principal by an advisory letter, dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-approved Plan), including related amendments, as designed was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
