### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### NOTE 1 – PLAN DESCRIPTION

The following description of Logan Contractors Supply, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan was initially adopted January 1, 1996 and was restated on August 1, 2014 when a prototype plan sponsored by Epic Advisors, Inc. was adopted. In 2020, Epic Advisors, Inc. provided a pre-approved defined contribution basic plan document replacing the 2014 document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan sponsor is Logan Contractors Supply, Inc. (the Company). The Plan is a defined contribution plan.

##### Eligibility

Participants age 21 and over are eligible to contribute to the Plan through salary deferral. Plan entry and dates for modification of deferrals are January 1, April 1, July 1 and October 1 under the Plan provisions. Participants age 21 and over who have attained one year of service which is defined as 1,000 hours during an eligibility computation period are eligible for a company contribution (if made). Participants are required to be employed on the last day of the Plan year in order to receive an employer contribution. Participants who have terminated employment due to retirement, death or disability are not required to meet the service requirement in the Plan year or be employed at the end of the Plan year in order to receive an employer contribution.

##### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, but not in excess of Internal Revenue Code annual limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions of after-tax dollars (Roth contributions) are allowed up to Internal Revenue Code annual limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers approximately thirty-three registered investment companies (mutual funds) and an option to self-manage investments within a separate brokerage account. If a participant does not make a timely selection for investment allocation, contributions are automatically invested in American Funds Balanced R5 Fund and those funds remain in that fund until changed by the participant.

For 2024 and 2023, the Company contributed a discretionary match contribution of 50% of salary deferrals. The employee salary deferral is limited to 4% for the company match computation. Catch up contributions are not eligible for the Company match contribution.

##### Participant Accounts

Each participant's account is credited with (a) participant elective contributions, (b) Company's discretionary contribution (if made), (c) investment earnings in the participant-directed investment accounts, and (d) charges for fees. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE 1 – PLAN DESCRIPTION, CONTINUED

##### Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the employer contribution portion of the account is as follows: 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service.

##### Notes receivable from participants

The Plan allows participants to borrow a portion of their account balance subject to limitations set forth by the Plan and the Internal Revenue Code. The loans are generally made for a term of five years or less, except for loans for a principal residence. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates at the time of the loan origination and are determined by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll withholding. Participant loans have stated interest rates in a range from 4.25% to 9.50% which is compounded bi-weekly. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial payments based on life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

##### Forfeited accounts

Forfeitures are available to reduce employer contributions or to pay administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,129 and \$3,200 respectively. Employer contributions made in 2025 for 2024 were reduced by \$4,620 from forfeited nonvested accounts.

##### Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to Plan provisions. Upon such termination of the Plan, participants would become 100% vested and each participant's account will be distributed in a manner permitted by the Plan and subject to the provisions of ERISA as soon as administratively feasible.

#### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

##### Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes

therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments of the Plan are stated at fair value as determined by the custodian of the Plan assets using market quotations and other available information. Money market funds and mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Stocks are valued at the closing price on the active market for the security. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation-depreciation also includes the Plan's gains and losses on investments bought and sold during the year and reflected separately is the net appreciation-depreciation in fair value of self-directed brokerage accounts.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account and are recorded as administrative expenses when incurred.

Contributions receivable

Receivable balances are unsecured. Receivable balances were deposited into the Plan subsequent to year end. Therefore, no allowance for uncollectible accounts is recorded.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation-depreciation of fair value of investments.

Subsequent events

Management has evaluated subsequent events through October 14, 2025 the date the financial statements were available to be issued.

#### **NOTE 3 – TAX STATUS**

The Plan has adopted a non-standardized form of a prototype Plan sponsored by Epic Advisors, Inc., the third-party administrator. The IRS has determined and informed the prototype plan by an opinion letter date March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). In 2020, Epic Advisors, Inc. provided a pre-approved defined contribution plan basic plan document.

The prototype documents have received a favorable IRS advisory letter stating that the Plan is qualified and the trust established under the Plan is tax exempt under the appropriate sections of the Code. The IRS has stated that employers who are word for word adopters of documents that have received the favorable IRS Advisory Letter may rely on the prototype plan's determination letter as to the form of the plan and qualification under Code section 401(a). The Plan has been amended since the opinion letter date; however, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and the Plan was qualified and related trust was tax exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 4 – PARTY IN INTEREST TRANSACTIONS**

Administration expenses of \$66,066 were recorded as follows: \$1,750 to Epic Advisors, Inc. and \$64,316 to City State Bank (trustee of the plan). Additional fees paid by the Plan for investment management services are netted against the net appreciation-depreciation in fair value as they are paid through investment returns rather than a direct payment.

#### **NOTE 5 – RISKS AND UNCERTAINTIES**

The Plan provides for investment in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 6 – CERTIFICATION**

The fair value of the registered investment companies' investments and money market investments at December 31, 2024 and 2023 and the related investment income and investment expenses for the year ended December 31, 2024 were certified as complete and accurate under 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 by Matrix Trust Company, custodian.

**NOTE 7 – ADMINISTRATION OF PLAN ASSETS**

The Plan's assets, which consist of a cash account, money market account, registered investment companies and participant loans at December 31, 2024 and 2023, are held by the custodian of the Plan, Matrix Trust Company. Company contributions are held and managed by the Custodian, which invests cash received and investment income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Plan sponsor. No such officer or employee receives compensation from the Plan.

**NOTE 8 – INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The generally accepted accounting principles framework for measuring fair value establishes a fair value hierarchy based on the quality of inputs used to measure fair value, and requires expanded disclosures about fair value measurements. The Plan accounts for its investments at fair value or considers fair value in their measurement.

In accordance with generally accepted accounting principles, the Plan has categorized its financial instruments based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available (if any). Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.
