INDEPENDENT AUDITORS' REPORT

To the Trustees of
H.D. Hudson Legacy Defined Benefit Pension Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of H.D. Hudson Legacy Defined Benefit Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years then ended, the statement of accumulated plan benefits as of December 31, 2023, the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of H.D. Hudson Legacy Defined Benefit Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the financial statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2023 Financial Statements section of our report. We are required to be independent of H.D. Hudson Legacy Defined Benefit Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 7 to the financial statements, the Board of Directors of the Plan and Plan Sponsor, approved on August 7, 2024, to terminate the plan with a proposed effective date of September 30, 2025, subject to regulatory approval. Liquidation was not considered imminent by management prior to regulatory approval to terminate the Plan. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about H.D. Hudson Legacy Defined Benefit Pension Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about H.D. Hudson Legacy Defined Benefit Pension Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the H.D. Hudson Legacy Defined Benefit Pension Plan (Plan), formerly known as the Employees' Retirement Plan of H.D. Hudson Manufacturing Company, is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined benefit pension plan covering salaried employees of H.D. Hudson Legacy Defined Benefit Pension Plan who are 21 years of age and have completed one year of service, for employees not covered by a collective bargaining agreement (as defined by the Plan). The Plan also covers hourly employees of H.D. Hudson Manufacturing Company and Root-Lowell Manufacturing Co. (together, the Company) who are 21 years of age and completed 1,000 hours of service during a 12-consecutive-month period (as defined by the Plan). Employees of the Hastings, Minnesota location are eligible on the employment commencement date, provided the employee as covered under a collective bargaining agreement (as defined by the Plan). The Company closed the Hastings location in September 2014. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective December 31, 2006, the Plan was frozen for new accrued benefits for salaried employees of H.D. Hudson Manufacturing Company and employees of Root-Lowell Manufacturing Co. and Quality Products. Effective May 31, 2007, the Plan was frozen for new accrued benefits for employees of the Hastings location.

Pension and Death Benefits

A vested participant who retires at the normal retirement date (the first day the participant attains age 65) is entitled to normal retirement benefits in the form of a life annuity payable in monthly installments or a single lump-sum payment. The annual amount of the annuity is determined by a formula as defined by the Plan.

A participant who has attained the age of 55 and has completed at least 15 years of eligible service may elect early retirement. The annual amount of early retirement benefits is determined by a formula as defined by the Plan.

The spouse of a vested participant, upon the death of the vested participant, is entitled to 50% of the benefits which would have been payable to the vested participant unless the form is waived. For a participant who is not married, the retirement benefit will be paid in the form of a single-life annuity.

Vesting

No vesting occurs until completion of five years of service at which time full vesting occurs.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of plan net assets available for benefits and the actuarial present value of accumulated plan benefits as of the date of the financial statements. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Pension Plan Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and trustees. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided in the plan documents.

Payment of Benefits

Benefits are recorded when paid.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated benefits are those future periodic payments including lump-sum distributions that are attributable under the Plan's provisions to the services employees have rendered. Accumulated benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of the employees who have died, and (c) present employees or their beneficiaries. Accumulated benefits under the Plan are based upon employees' years of service, multiplied by a periodically determined fixed benefit rate. The accumulated benefits for active employees are based on their compensation as of the valuation date.

The actuarial present value of accumulated plan benefits is determined by an actuary from Principal under the unit credit method, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The actuarial valuations are done using the beginning of the year method. Therefore, the accumulated plan benefits as of December 31, 2023 are presented from information provided by the actuary as of January 1, 2024. There have been no significant changes in the Plan's provisions or coverage from December 31, 2023 to January 1, 2024.

The significant actuarial assumptions used in the valuations were (a) life expectancy of participants based upon the Pri-2012 employee and annuitant tables with no collar adjustment and generational projection using scale MP-2021, (b) retirement age based upon a normal retirement age of 65, (c) rate of return on plan assets of 6.10%, and (d) interest rate used to value liabilities of 5.75%.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue.

NOTE 3 – FUNDING POLICY

The Company has agreed to contribute such amounts as are necessary to meet the benefits to be paid to the plan participants and to annually fund the Plan's current service costs and initial past service costs plus interest over a reasonable period. For the Year ending December 31, 2024 and 2023, the Company made contributions of \$283,028 and \$500,187, respectively, of which \$0 and \$264,491 were paid subsequent to December 31, 2024 and 2023, respectively.

NOTE 4 – CERTIFIED INVESTMENTS

All information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

The separate account noted in Note 5 is included in the certification from Principal; however, the allocated assets (guaranteed annuities) of the separate account are not segregated from unallocated assets in the certified trust statement.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Update 820 are described below:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology includes quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of pooled separate accounts: Valued at the total of the net asset value (NAV) of shares of mutual funds held by the account at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based on the underlying investments comprising the pooled separate accounts. This practical expedient is not used when it is probably that the fund will sell for an amount different from the reported NAV. The pooled separate accounts can be redeemed at NAV as of the measurement date and can be redeemed on a daily basis. There are no unfunded commitments.

The separate account provides a benefit index purchase option issued by Principal Life Insurance Company. The Plan has purchased this option, which is a non-participating group annuity contract, to settle benefits for a subset of participants. The annuity contract transferred the obligation for future benefit payments for 115 retirees to Principal Life Insurance Company, and the Plan no longer has further obligation for those participants. The Plan has excluded the allocated funds from the annuity from the unallocated funds that are under the Plan's obligation. For the year ended December 31, 2024, the purchase of the contract annuity was recorded as a benefit payment in the statement of changes in net assets available for benefit.

At year-end, the difference between the trust balance reported by Principal Trust Company and the net assets available for benefits per these financial statements represents the cumulative present value adjustment.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – RELATED-PARTY TRANSACTIONS

Principal held the Plan's investments during 2024 and 2023. Therefore, any investment transactions qualify as party-in-interest transactions. Investment expenses were \$114,413 and \$113,000 for the years ending December 31, 2024 and 2023, respectively.

PBGC premiums paid from the plan assets in 2024 and 2023 were \$99,941 and \$253,572, respectively.

Rehmann Financial Group LLC provided investment advisory services over the investments in the Plan for the years ended December 31, 2024 and 2023, and related transactions qualify as party in interest transactions. Fees paid by the Plan to Rehmann Financial Group LLC totaled \$40,000 for each of the years ended December 31, 2024 and 2023. The fees for investment advisory services

are included in net appreciation (depreciation) in fair value of investments on the statements of changes in net assets available for benefits.

NOTE 7 – PLAN TERMINATION

On August 7, 2024, the Company's Board of Directors approved a resolution to terminate the Plan with a proposed termination date of September 30, 2025, subject to regulatory approval. As of December 31, 2024, the Company has not yet filed a notice with the Pension Benefit Guaranty Corporation (PBGC), applied for an IRS determination letter, provided a notice of plan benefits to participants, or began a formal bid process for annuities and therefore does not deem termination imminent. The Plan liabilities will be settled in either a lump sum payment or a purchased annuity.

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
- Other vested benefits insured by the PBGC, a U.S. Government agency, up to the applicable limitations discussed below.
- All other vested benefits, that is, vested benefits not insured by the PBGC.
- All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling on the amount of an individual's monthly benefit that the PBGC guarantees. For plan terminations, that ceiling is adjusted periodically. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination, whichever comes later. For younger annuitants, or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

Whether all participants receive their benefits should the Plan terminate will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits, and may also depend on the level of benefits guaranteed by the PBGC.

NOTE 8 – INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated February 10, 2017, that the Plan is qualified and the trust established under the Plan is tax exempt under the appropriate sections of Internal Revenue Code (IRC). The Company believes that the Plan is designed and operating in accordance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that the changes could materially affect the amounts reported in the financial statements. Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 10 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through the date of the independent auditors' report, October 14, 2025, which is the date the financial statements were available to be issued.

Subsequent to December 31, 2024, the Company issued a notice of intent to terminate the Plan to all participants, beneficiaries, retirees, and alternate payees of the Plan with a proposed termination date of September 30, 2025. The Company has not yet filed a notice with the Pension Benefit Guaranty Corporation (PBGC), applied for an IRS determination letter, or began a formal bid process for annuities and therefore does not deem termination imminent (Note 7).

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Total dataset base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.

Mortality improvement MP-2021 is the most recent improvement scale published by the SOA in October 2021.

In selecting this assumption, we considered the other parameters available in the MIM-2021-v4 application tool issued by the SOA in October 2023 and consider the selections in MP-2021 reasonable. Based on the sponsor's input, plan experience does not show a need for long-term excess death or Covid death load adjustments.

Interest rate used to value liabilities	5.75% The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes' arithmetic returns of the plan's target asset allocation, and then converted to the geometric under lognormal distribution assumption. For details, see Long-Term Capital Market Assumptions link.
Treatment of administrative expenses	No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses. Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer. Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
