Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Dorchester Collection 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Dorchester Collection 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1988. It is a defined contribution plan covering all employees of Sajahtera, Inc. dba: The Beverly Hills Hotel (the Company) who are not covered by a collective bargaining agreement, have completed one year of eligible service, and are age 21 or older. The Plan is subject to the provisions of ERISA. The Plan's administrative committee oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Although it has not expressed the intention to do so, the Company has the right under terms of the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA provisions.

Contributions

Employee contributions to the Plan (voluntary contributions) are deferrals of the employee's compensation made through a direct reduction of compensation in each payroll period of up to 60% of compensation. Subsequent to meeting eligibility requirements, employees are automatically enrolled in the Plan at a 6% deferral rate unless they elect to opt out. After a full year is completed of deferring contributions at this automatic rate, the deferral rate is increased by 1% at the beginning of each year until a maximum of 9% is reached or the participant elects to stop or change the deferral amount. Upon enrollment in the Plan, a participant may direct employee contributions in various investment options. Participants may change their options at any time. The maximum tax deferred contribution may not exceed the Internal Revenue Service (IRS) limit. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as limited by the IRS. Participants may change the percentage they contribute as of the beginning of each month and may stop deferring at any time.

The Company makes a matching contribution of 100% of each participant's deferral for up to 6% of eligible compensation each pay period. The amount of compensation that may be taken into account each Plan year may not exceed the IRS limit. Participants are eligible for Company contributions upon completion of two years of service.

Additionally, the Plan allows for discretionary contributions by the Company. Discretionary contributions are allocated to participants based on a formula using total participants' compensation for the Plan year. There were no discretionary contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and all the Company's matching and discretionary contributions and an allocation of Plan earnings and losses, net of investment management fees and administrative expenses. Allocations are based on participant account balances, as defined, and the specified investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Each participant's interest in all contributions is vested immediately.

Payment of Benefits

Upon termination, death, disability, or retirement, participants or their beneficiaries are entitled to payment of the total vested value of their account balances. Account balances less than \$1,000 are distributed in a single lump sum cash payment to the participant or beneficiary. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59-1/2, participants are allowed to withdraw portions of their funds from the Plan.

Forfeited Accounts

Amounts of nonvested matching contributions may be used to pay Plan administrative expenses or to reduce future matching contributions. For the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or reduce Plan expenses. The forfeited nonvested account balances totaled \$3,551 and \$2,017 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their total vested account balance. Loan transactions are treated as a transfer to (from) the respective investment fund from (to) the participant's loan fund. A participant must repay the loan within five years, unless he or she is terminated, retires, or becomes disabled, in which case the loan becomes immediately due and payable. Loans taken for the purpose of buying a primary residence must be repaid within 10 years. Loans bear a reasonable rate of interest as determined by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions and credited to the participant's fund balance. The loans are secured by the vested account balance in the participant's account, and a participant can only have one loan outstanding at any time.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses incurred by the Plan are absorbed by the Company, except for fees related to the administration of withdrawal processing fees, recordkeeper fees, and trustee fees, which are deducted from the applicable participants' accounts. Participant fees are allocated to participant accounts based on relative account balance.

Administrative Expenses (Continued)

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation on investments.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. References to the "ASC" hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board (FASB) as the source of authoritative accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. At December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and/or losses are reported the day after the trade date. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits in net appreciation in fair value of investments.

Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

Contributions Receivable

Contributions receivable represent amounts that have been contributed prior to year-end, but not received by the Plan until subsequent to year-end.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur and that such changes in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and earnings on investments and interest and dividends for the Plan year ended December 31, 2024 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan.

NOTE 5 INVESTMENTS AND FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this FASB framework are described as follows:

Level 1 – Defined as observable inputs such as quoted prices in active markets.

Level 2 – Defined as inputs other than quoted prices in active markets that are either directly or indirectly observable.

Level 3 – Defined as unobservable inputs in which little or no market data exists therefore requiring an entity to develop its own assumptions.

The Plan uses the appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There were no Plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on the quoted price of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements

Pooled separate accounts and common collective trusts are valued using the net asset value of units, which are based on observable market prices for the underlying assets, held by the Plan at year-end. NAV is a readily determinable fair value and is the basis for current transactions.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 TAX STATUS

The Plan adopted the Volume Submitter Profit Sharing Plan with a cash or deferred arrangement sponsored by Fidelity Management & Research Company (FMRC). The IRS has determined and informed FMRC by a letter that the volume submitter plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the volume submitter plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan; it has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants represent loans to employees and therefore qualify as party-in-interest transactions. The Plan also has a number of service providers. Such providers are parties in interest under ERISA.

NOTE 8 SUBSEQUENT EVENTS

The Company has evaluated subsequent events through October 10, 2025, which is the date the accompanying financial statements were available to be issued.
