Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Foundation Physicians Medical Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 - DESCRIPTION OF PLAN

The Plan is a defined contribution plan covering substantially all full-time employees of Foundation Physicians Medical Group, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC), and has been amended at various dates through December 31, 2024 to comply with applicable laws and regulations.

An employee becomes eligible to participate in the Plan on the entry date immediately following the date the employee is hired. For eligibility and vesting purposes, service time with Dignity Health Medical Foundation, Dignity Health and Catholic Healthcare West Medical Foundation will be applied. Effective May 1, 2023, Identity Medical Group 401(k) Plan was merged into the Plan.

Plan Administration

The Company is the administrator of the Plan and is responsible for managing its day-to-day operations. The Plan's trustee, Fidelity Management Trust Company (Fidelity), is responsible for the recordkeeping, custody, and management of the Plan's assets.

Contributions

The 401(k) salary deferral option allows employees to defer a portion of their salaries for income tax purposes through contributions to the Plan. Participants may contribute up to 80% of eligible Plan year compensation up to the maximum allowed under the IRC, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants from Dignity Health Medical Foundation, Dignity Health and Catholic Healthcare West Medical Foundation are eligible for employer contributions as follows:

- *Non-discretionary matching contributions:* The Company will match 50% of the participant's contributions up to 6% of the participant's total eligible compensation. This is only available for highly compensated employees, as defined by the IRC, after completing one year of service, equivalent to 1,000 hours of service.

NOTE 1 - DESCRIPTION OF PLAN – CONTINUED

Contributions – Continued

- *Safe harbor matching contributions:* The Company will match 100% of the participant's contributions up to 3% of the participant's total eligible compensation, and 50% of the next 2% of eligible compensation. This is only available for non-highly compensated employees upon entry into the Plan.
- *Nonelective contributions:* The Company provides for nonelective contributions to eligible participants (both highly and non-highly compensated employees) who have completed one year of service, equivalent to 1,000 hours of service. Participants must continue to complete at least 1,000 hours of service each Plan year to be eligible for nonelective contributions. Contributions to Company physicians range from 3% to 8% of participant's eligible compensation based on each participant's age. Contributions to non-physicians range from 4% to 6% of participant's eligible compensation based on each participant's age.

Participants from Identity Medical Group receive Company nonelective contributions at a flat rate of 5%.

For the year ended December 31, 2024, the Company made non-discretionary matching contributions of \$1,555,339, safe harbor matching contributions of \$777,214, and nonelective contributions of \$3,606,046. Non-discretionary matching contributions of \$25,293, safe harbor matching contributions of \$32,410, and nonelective contributions of \$3,669,255 are included in employer contributions receivable on the accompanying statement of net assets available for benefits as of December 31, 2024.

Participants may also make a rollover contribution to the Plan that is not matched by the Company. Rollover contributions are assets transferred to the Plan from a qualified plan in which an employee participated prior to employment with the Company. During the year ended December 31, 2024, there were \$1,912,433 in rollover contributions transferred to the Plan.

Participants direct the investment of their contributions and their share of the Company's contributions into various investment options offered by the Plan, and they may change their investment elections anytime.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions (including those rolled over from another qualifying plan or trust) and related employer contributions, as well as the participant's share of the Plan's income and expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings or losses thereon as well as Company safe harbor matching contributions. Vesting in the Company's non-safe harbor related contribution portion of their accounts is based on years of continuous service. Participants are 0% vested in Company nonelective contributions until they have completed three years of service, at which time, they become 100% vested. The participant vesting schedule for Company non-discretionary matching contributions are as follows:

Participants become 100% vested in non-discretionary matching contributions upon reaching age 65, death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum limited to the lesser of: (1) \$50,000 or (2) 50% of the participant's vested account balance. Each note receivable is secured by the balance of the participant's account and bears a reasonable rate of interest that is determined by the plan administrator, and must be repaid on an installment basis via ACH payments over a period not to exceed five years, unless the loan is used by the participant to acquire a primary residence. The interest rates ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant (or participant's beneficiary in the event of death) will receive either a lump-sum amount or a series of installments over a period of time equal to the value of the participant's vested interest in his or her account. Participants should refer to their Plan agreement for more information.

Hardship Withdrawals

Participants may withdraw their vested contributions in the event of hardships as defined by the Plan document. Hardship distributions are distributed as a lump-sum.

Forfeitures

Any participant who terminates employment prior to the normal retirement date for reasons other than death or disability, forfeits all nonvested contributions. Forfeitures of terminated participants' nonvested accounts may be used to pay administrative expenses or to reduce any Company contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$283,515 and \$190,837, respectively. Forfeitures in the amount of \$60,190 and \$150,135 were used to offset administrative expenses and the Company's contributions, respectively, for the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements, and the reported amounts of additions and deductions during the reporting period. The most important of these estimates and assumptions relate to fair value measurements of the Plan's investments. These and other estimates and assumptions are based on the best available information but actual results could be materially different from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Valuation of Investments

In accordance with GAAP, all assets of the Plan are stated at fair value or amounts approximating fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees.

The Plan's investment in stable value fund, which is considered to be fully benefit-responsive, is required to be reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses, as allowed by the Plan.

Stable Value Fund

The Plan has entered into an investment contract with Lincoln National Life Insurance Company (Lincoln) through its Stable Value fund (the Fund), which is a fully benefit-responsive investment contract that is reported at contract value, and is available as an investment option to Plan participants. The Fund is a guaranteed fixed annuity contract managed by Lincoln that invests in the general account assets of Lincoln. The account is credited with earnings on the underlying investments and charged for participant withdrawals. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value. The crediting interest is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with Lincoln. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

Stable Value Fund – Continued

The Plan administrator believes no events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The Plan mandates specific rules regarding the movement of funds between accounts. As such, once a participant transfers funds from the Fund, they must keep those funds in a non-competing fund for a minimum of 90 days before they can transfer them to a competing fund. Additionally, if a participant decides to transfer funds from a non-competing fund to a competing fund, they will not be allowed to make any further transfers from the Fund for a consecutive 90-day period.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a distribution based on the terms of the Plan document.

Recognition of Income

Sales and purchases are accounted for on a trade date basis, and interest income is recorded on the accrual basis. Dividends, if declared, are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well as held at year-end.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

All reasonable expenses related to Plan administration are paid from Plan assets, except to the extent expenses are paid by the Company. Expenses paid directly by the Company are excluded from these financial statements. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Recent Accounting Pronouncements

In the normal course of business, the Plan evaluates new accounting pronouncements to determine the potential impact they may have on its financial statements. Based upon this review, the Plan does not expect any of the recently issued accounting pronouncements, which have not already been adopted by the Plan, to have a material impact on its financial statements.

Subsequent Events

The Plan evaluated for recognition or disclosure subsequent events through the report issuance date and determined that no such events were identified.

NOTE 3 - TAX STATUS

The Company had adopted a prototype plan that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the prototype plan was in compliance with the applicable requirements of the IRC. The plan administrator had determined that it was eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes that the Plan operates in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In accordance with GAAP, the Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

NOTE 4 - PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the participants' account balances fully vest, and they would be distributed.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Pursuant to that regulation, the plan administrator has instructed the independent auditors not to perform any auditing procedures with respect to information certified by the trustee. Accordingly, the trustee of the Plan has certified to the completeness and accuracy of investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, as well as the related investment activity reflected in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6 - FAIR VALUE MEASUREMENTS

The fair value hierarchy prioritized the inputs to valuation techniques used to measure fair value into three levels, with the highest priority given to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority given to unobservable inputs (Level 3). The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Interest-bearing cash*: Valued at cost plus accrued interest, which approximates fair value.

- *Mutual funds*: Valued at quoted market prices of shares held by the Plan at year-end.
- *Self-directed brokerage accounts*: The self-directed brokerage accounts are comprised of interest-bearing cash, common stock, and mutual funds, which are valued at the closing price reported on the active market in which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
