Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PC Services, Inc. dba Paradise Cove 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Substantial Doubt About the Plan's Ability to Continue as a Going Concern

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 1 to the financial statements, the Plan Sponsor expects to cease its operations at December 31, 2025 upon expiration of their existing operating lease, and has stated that substantial doubt exists about the Plan's ability to continue as a going concern. Management's evaluation of the events and conditions and management's plans regarding these matters are also described in Note 1. The financial statements do not include any adjustments that might result from the outcome of this uncertainty. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the PC Services, Inc. dba Paradise Cove 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering substantially all employees of PC Services, Inc. dba Paradise Cove (the Company and Plan Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Prior to December 31, 2020, Massachusetts Mutual Life Insurance Company ("Mass Mutual") was the recordkeeper of the Plan, and administrative agent and attorney-in-fact for Talcott Resolution Life Insurance Company ("Talcott") (formerly Hartford Life Insurance Company), the custodian of the Plan. On December 31, 2020, Empower Annuity Insurance Company of America and its subsidiaries ("EAIC"), including Empower Retirement, LLC and Empower Trust Company, LLC ("ETC") acquired the retirement business of Mass Mutual. Effective January 1, 2024, Reliance Trust Company (Reliance) and ADP Retirement Services (ADP) became the Plan's custodian and recordkeeper, respectively. The transfer of assets from EAIC and ETC to Reliance and ADP occurred on January 18, 2024. The Plan document was amended and restated as of January 1, 2024.

The Company has indicated their intention to cease operations upon the termination of their operating lease on December 31, 2025. Management plans to retain some staff for the purpose of ceasing the Company's operation in 2026 and have represented no plans to continue thereafter. There are no formal plans or notices to terminate the Plan as of the date of this report; however, there is substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

b. Eligibility

All employees of the Company are eligible to participate in the Plan and receive profit sharing contributions upon attaining age 21 or older and completing one year of service with at least 1,000 hours of service during the year.

c. Contributions

Participants may elect to defer up to 100 percent of their annual compensation, subject to certain limitations defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company contributes dollar-for-dollar of employee deferrals up to five percent of compensation to participants who are eligible to receive contributions under the safe harbor matching provision in the Plan. For the years ended December 31, 2024 and 2023, the Company did not make a discretionary profit sharing contribution.

d. Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching and profit sharing contribution, and an allocation of Plan earnings and expenses. Earnings and losses from the Plan's investments are allocated to participants' accounts in proportion to the balances of such accounts, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

e. Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions made by the Company, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions, plus actual earnings thereon, is based on years of service. A participant is 100 percent vested after six years of credited service.

f. Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum distribution equal to the value of his or her vested account balance or periodic installments over a defined period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

g. Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. Forfeited balances of terminated participants' nonvested accounts are first applied to the payment of Plan administrative expenses and then used to reduce the amount of Company non-elective contributions. There were no significant unallocated account balances at December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

b. Contributions

Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

c. Management's Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

d. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

e. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

f. Payment of Benefits

Benefits paid to participants are recorded upon distribution.

g. Administrative Expenses

Administrative expenses are recorded when incurred. To the extent any expenses of the Plan are not paid from the Plan, the Company pays such expenses.

h. Subsequent Events

The Company has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued, and it was determined that all subsequent events had been properly accounted for.

4. Fair Value Measurements

US GAAP and Accounting Standards Codification Topic 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; and inputs that are derived principally from or can be corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in Registered Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – Valued based on net asset value (NAV) of shares held by the Plan at year end as provided by the custodian. The NAV is based on the fair value of the underlying investments. The NAV is not a publicly-quoted price in an active market. In accordance with Accounting Standards Board Accounting Standards Codification Topic 820, these investments measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy.

5. Contract with Insurance Company

As of December 31, 2023, the Plan invested in an unallocated fixed income group variable funding agreement with Talcott Resolution Life Insurance Company (“Talcott”). This investment provided for a guaranteed crediting rate. Guarantees were based on the claims paying ability of Talcott and not the value of the securities within the insurer’s general account. The credit rating of the issuer as of August 4, 2024 was Baa1 as reported by Moody’s Investors Service. Deposits made to the fixed account were deposited in Talcott’s general account. Payment obligations under the fixed account represented an insurance claim supported by all the general account assets.

Under the contract that supported this product, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at this contract value. Contract value represented deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The contract was effected directly between the Plan and the issuer. The repayment of principal and interest credited to participants was a financial obligation of the issuer. There were no reserves against contract value for credit risk of the contract issuer or otherwise. Given these provisions, the Plan considered this contract to be fully benefit-responsive. As of December 31, 2024 and 2023, the investment amounted to nil and \$80,883, respectively.

6. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants affected by the termination shall become fully vested. See Note 1 for further discussion of management’s intentions regarding the Plan.

7. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan (Pre-Approved Plan) and has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the Pre-Approved Plan’s qualified status. The Plan has been amended since receiving the opinion letter. The Pre-Approved Plan’s opinion letter has been relied upon by the Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the qualification requirements of the IRC and that the Plan continues to be tax-exempt. Hawaii income tax law conforms to the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements. Administration errors, if any, which are insignificant or operational in nature are handled by the Plan Administrator in accordance with applicable IRS correction policies.

7. Tax Status (continued)

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan years from December 31, 2021 are open for examination for federal tax purposes.
