### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedules Required by ERISA**

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## **House Foods Holding USA Inc. Profit Sharing Plan Notes to Financial Statements**

### **1. DESCRIPTION OF PLAN**

The following brief description of House Foods Holding USA Inc. Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, effective April 1, 1997, and most recently amended and restated effective December 20, 2024, under the provisions of Section 401(a) of the Internal Revenue Code ("IRC") which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of House Foods America Corporation ("Company" or "Employer") and two related parties, El Burrito Mexican Food Products Corporation, and Keystone Natural Holdings, LLC, as participating employers. All salaried employees (classified as Group 1 and Group 2 by the Company), excluding Japanese national executives, upon reaching the age of 21 and completing one year of service (employee must work at least 1,000 hours during 12 consecutive months of employment) are eligible to participate in the Plan. Employees enter the Plan on the first day of the calendar quarter coinciding with or next following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Contributions

Participants may contribute a certain amount of their annual compensation as defined in the Plan through salary deferral payroll deductions. Participants who have attained age 50 before the Plan year-end are also eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or an individual retirement account as rollover contributions. The Employer may make a discretionary profit sharing contribution to the Plan for participants who are employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year. In 2024, the approved profit sharing contribution was 3% of eligible compensation. The Employer may also make qualified non-elective contributions. Contributions are subject to certain limitations.

#### Participant Accounts

Participants direct the investment of their accounts into various investment funds offered by the Plan. Each participant's account is credited with the participant's contribution and an allocation of the Employer's profit sharing contribution, Plan earnings and expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. DESCRIPTION OF PLAN (Continued)**

Vesting

Participants are 100% vested in their own contributions to the Plan and actual earnings thereon. Vesting in the Employer's profit sharing contribution is based on years of service wherein a participant works at least 1,000 hours during the year, with participants becoming 100% vested only after completing three years of service. A participant becomes fully vested in all profit sharing contribution accounts in the event the participant reaches normal retirement age, dies or becomes totally disabled.

Forfeited Accounts

At December 31, 2024, and 2023, there was a \$9,270 and \$5,672 forfeited nonvested account balance, respectively. Forfeited accounts are used to pay Plan administrative expenses or as a credit to reduce future Employer's contributions. In 2024, no forfeitures were used to offset employer contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are permitted only for certain specific purposes, as defined. Loan terms are up to 5 years, except in the case of a purchase of a primary residence, which may have a loan term up to 10 years. The loans are secured by the balance in the participant's account and bear interest at a prime rate plus 2%. Principal and interest are normally paid ratably through bi-weekly payroll deductions. Interest rates range from 10.00% to 10.50% at December 31, 2024.

Payment of Benefits

Participants are eligible for distribution of benefits when there is one of the following distributable events - termination of employment, death, disability, or retirement. Benefits are paid in a lump-sum cash payment. In addition, in-service withdrawals are allowed under certain conditions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contribution portion of their account.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)**

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosures regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, which approximates when interest is received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in mutual funds and money market funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are stated at the unpaid principal balance. Interest income associated with the notes receivable is recorded when interest payments are received, usually semi-monthly. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company, at its option, and are excluded from these financial statements. Asset charges are paid to cover expenses incurred in the administration of the Plan, including distribution and processing loans and are reflected as administrative expenses. Expenses related to the investment advisory fees are charged directly to the participant's accounts. Other investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid or upon distribution.

**3. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, which includes investments from participants at December 31, 2024 and 2023, interest, dividends and net appreciation in fair value of investments and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan, in accordance with Section 2520.103-5(c) of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.

Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.

Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds

Mutual funds are valued at their quoted market prices.

Money Market Funds

Money market funds are valued at the daily closing net asset value of the respective fund.

**5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and money market funds managed by Fidelity. Fidelity is the Trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as allowable party-in-interest transactions. Fees incurred by the Plan for investment management services are in net appreciation in fair value of investments. These fees are paid to the investment fund manager and may include certain revenue sharing fees that are paid to Fidelity, other investment custodians and investment advisors.

As mentioned in Note 2, certain administrative, loan and investment expenses are paid directly to service providers and totaled \$62,747 for 2024.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Notes to Financial Statements (Continued)**

**7. INCOME TAX STATUS**

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the trustees believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the plan year, certain participant contributions totaling \$1,517 were not remitted to the Plan within the time frame required by the Department of Labor regulations. These contributions were deposited late but have since been remitted to the Plan. As a result of the late deposit, lost earnings of \$5 were calculated. The Plan Administrator is in the process of correcting this matter.

**9. SUBSEQUENT EVENTS**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 22, 2025, which is the date the financial statements were available to be issued.
