### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Lane Powell PC 401(k)/Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lane Powell PC 401(k)/Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lane Powell PC 401(k)/Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Termination***

As further discussed in Note 1, the Plan was terminated, effective December 31, 2024. As a result, the Plan has changed its basis of accounting from the ongoing basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lane Powell PC 401(k)/Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

### Note 1 – Description of Plan

The following brief description of the Lane Powell PC 401(k)/Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for complete information.

**General** – The Plan is a defined contribution, participant-directed plan, established on January 1, 1995, to provide benefits to eligible employees and shareholders of Lane Powell PC and its affiliates (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the Plan’s sponsor and serves as plan administrator.

**Plan termination** – In 2024, the Company entered into a purchase and sale agreement with a third party. Per the terms of the agreement, the Company terminated the Plan, effective December 31, 2024. Effective with the Plan’s termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan’s termination also ceased employee and employer contributions into the Plan. All Plan assets will be liquidated and distributed in accordance with the Plan provisions under ERISA in 2025.

**Eligibility** – Eligible employees and shareholders may make contributions upon commencement of employment. The Plan excludes temporary and seasonal employees, self-employed individuals, “Of Counsel” attorneys, non-resident aliens, leased employees, residents of Puerto Rico, retired partners whose sole source of income received from the Company is payment under a grandfathered retired Partner plan, and members of a collective bargaining unit from the Plan. Part time employees do not receive profit sharing contributions until they have one year of service in which they work 1,000 hours or three consecutive years of service in which they work at least 500 hours. Associate attorneys and counsel to Firm are not eligible to receive profit sharing contributions.

### Contributions

*Participant contributions* – Each year, participants may defer up to 100% of compensation, not to exceed the statutory limitations. Participants may also make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an automatic enrollment and automatic escalation feature for newly hired employees, which withholds 4% from eligible employees’ compensation, increased by 1% each year up to 10%, unless otherwise directed by the employee. Equity shareholders are excluded from the automatic annual increase. Contributions from participants are recorded in the year in which the participant contributions are withheld from compensation.

*Profit sharing contributions* – The Company made discretionary profit-sharing contributions of \$3,109,938 for the year ended December 31, 2024, which were allocated to eligible participant accounts based on employee type and compensation as defined in the plan document. Profit sharing contributions are recorded in the year in which the participant contributions are withheld from compensation.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant’s account is credited with the participant’s contribution, an allocation of the Firm’s elective contributions, expenses, and investment earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

The Plan allows for participants to invest in funds approved by the Plan’s retirement committee or to establish self-directed brokerage accounts. The Plan’s retirement committee does not approve investments in self-directed brokerage accounts.

**Vesting and forfeitures** – Participants are immediately vested in their contributions and earnings or losses thereon. There is a three-year cliff vesting period for profit sharing contributions to participants designated as “Shareholder” or “Counsel to the Firm” to the extent they received contributions prior to exclusion from the Plan. Other employees are subject to a six-year graded vesting schedule for the profit sharing contribution. As of December 31, 2024, all participants became 100% vested as a result of the termination of the Plan.

Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are used to reduce the Company’s profit sharing contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19 and \$185,352, respectively. During the year ended December 31, 2024, \$406,604 of forfeiture balances was used to reduce the Company’s profit sharing contributions.

**Withdrawals and distributions** – Terminated participants with vested balances less than \$7,000 receive a full distribution upon termination of service. Participants with account balances of \$7,000 or more may elect to leave their vested account balance in the Plan or to have their account balance distributed directly to them or to another qualified plan. Participants who have attained retirement age may choose among various distribution options. Withdrawals may also be made in the case of hardship or certain other circumstances described in the Plan documents.

**Notes receivable from participants** – Participants may borrow up to 50% of their account balances, not to exceed \$50,000. Loans will not be made in a principal amount less than \$1,000 and only one loan may be outstanding to a participant at any time. The maximum loan term is five years unless the loan qualifies as a home loan, in which case the term of the loan is not to exceed 20 years. The loans are secured by the balance in the participant’s account and bear interest at the current prevailing rate. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.25% to 9.50% with various maturities through April 2042.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. As a result of the termination of the Plan, the Plan’s financial statements as of and for the year ended December 31, 2024 have been prepared on the liquidation basis of accounting and the financial statement as of December 31, 2023 has been prepared on the ongoing basis of accounting.

**Use of estimates** – The preparation of the financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – Investments are stated at fair value as certified by the Plan’s trustee. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized depreciation and appreciation of those investments. No income has been accrued as of December 31, 2024, as a result of the adoption of the liquidation basis of accounting.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

**Benefit payments** – Benefits are recognized when paid.

**Administrative expenses** – Most expenses of maintaining the Plan are paid directly by the Company and excluded from these financial statements. Certain fees related to the administration of self-directed brokerage accounts and the administration of notes receivable from participants are charged directly to the participant’s accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. No expenses have been accrued as of December 31, 2024, as a result of the adoption of the liquidation basis of accounting.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trusts* – Units held in collective trusts are valued using the NAV practical expedient of the fund. The NAV practical expedient is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. As of December 31, 2024 and 2023, none of the collective trusts have redemption restrictions.

*Self-directed brokerage accounts* – Self-directed brokerage accounts include investments directed by individual participants in a variety of investment options, primarily common stock and mutual funds, which are valued using quoted prices in the active markets in which they trade.

#### **Note 7 – Income Tax Status**

The Plan document is a pre-approved defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on August 19, 2020, which stated that the pre-approved plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the opinion letter date, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities that changes in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.
