**NOTE 1 DESCRIPTION OF PLAN**

The following description of the TURCK Inc. Employee Savings and Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a qualified defined contribution profit sharing plan with elective deferral and employer-matching features. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. For purposes of making elective deferrals, receiving employer matching contributions, and a profit sharing contribution, a nonunion employee of TURCK Inc. (the Company) enters the Plan after two months of employment and reaching age 18.

**Contributions**

Participants may elect to defer up to 50% of their compensation, not in excess of the limits imposed by Internal Revenue Code (IRC). Participants may elect deferrals to be all pretax, all post-tax, or a combination of both. The Plan has an automatic increase feature for elective deferrals for participants who are enrolled into the Plan. New employees are automatically enrolled in the Plan with a contribution rate of 3% of eligible compensation, unless the participant declines enrollment or elects a different rate. The elective deferral increases by 1% each year until the deferral rate reaches 10%, unless the participant opts out or elects a different rate.

The Company makes a discretionary employer-matching contribution equal to 100% of the first 1% deferred by an eligible employee plus 50% of the next 5% deferred. The Company may also make a discretionary profit sharing contribution in an amount determined by the Company. The Plan also allows rollover contributions. To receive an allocation of any profit sharing contribution, a participant must have worked 500 hours, plus two months during the Plan year and be employed by the Company on the last day of the Plan year. The 500-hour and last day rule does not apply when termination of employment occurred during the Plan year because of death, disability, or retirement. An eligible participant's share of a profit sharing contribution is equal to the ratio of the participant's compensation to the compensation of all participants eligible to share in the contribution. There were profit sharing contributions of \$615,298 for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. If a participant is auto enrolled into the Plan, contributions are invested into the Qualified Default Investment Alternative. Company contributions are invested in those same investment options.

**Vesting**

The Plan uses the elapsed-time method for vesting, which states that a year of vesting service is earned when an employee completes at least one hour of service during the year. Vesting shall be computed by reference to the 12-consecutive month period of the Plan year. The elective deferrals and matching contributions are 100% vested at all times, and the profit sharing contributions are 50% vested after two years of service and 100% vested after three years of service. The Plan first applies forfeitures resulting from termination that occurs before full vesting to reinstate previously cashed out participants who buy their way back into the Plan, and then as an additional profit sharing contribution. Excess matching contributions, if any, will be used to reduce employer matching contributions.

**Notes Receivable from Participants**

The Plan provides for loans to be made to participants from their vested accounts. The loan cannot exceed 50% of the participant's vested account, with a \$1,000 minimum and \$50,000 maximum considering any prior loans made. Interest on the loans is charged based upon prevailing bank rates.

Loans must be repaid within five years in substantially level amounts, with payments made at least quarterly. An exception to the five-year repayment period may be made if the loan is for the purchase of the participant's principal residence.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan Sponsor as provided in the Plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Forfeited Accounts**

During 2024, forfeited nonvested accounts of \$4,039 were allocated to qualifying participants' accounts. There were \$185,203 and \$138,016 of unallocated forfeitures as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Subsequent events were evaluated through September 4, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFIED INVESTMENT INFORMATION**

Vanguard Fiduciary Trust Company (Vanguard), the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund* – The stable value collective trust fund is valued at NAV as reported by the investment manager at year-end. The NAV, as provided by the investment manager, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The investment in the stable value collective trust fund can be redeemed on a daily basis without restriction and is not subject to redemption notification provisions. There were no unfunded commitments related to the stable value fund as of December 31, 2024 and 2023.

**NOTE 6 EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Vanguard, who is the qualified institution for the Plan. Therefore, these transactions qualify as party-in-interest transactions.

**NOTE 7 TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
