Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of LBA Realty 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established effective February 12, 1996, and is administered by LBA Realty LLC (the “Plan Sponsor” or “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan covers substantially all of the employees of the Company.

Eligibility

The Plan covers all nonunion employees on the first day of the month following their date of hire. The Plan excludes, subject to minimum coverage requirements of Code section 410(b) (“Code”), union employees, temporary employees or interns as eligible employment for participation in the Plan.

Contributions

Each year, participants may elect to make voluntary 401(k) contributions from 1% to 65% of their eligible compensation, as defined by the Plan, up to the annual maximum allowed under the Code. All employees who were eligible to make pretax or after-tax deferrals under the Plan and had attained age 50 before the close of the plan year were eligible to make catch-up contributions in accordance with, and subject to, the limitations of the Code. Participants may rollover contributions from other retirement plans. Effective January 1, 2016, the Company may make a discretionary matching contribution of participant contributions. Effective May 1, 2018, the Plan was amended to permit Plan participants to make after-tax Roth contributions and allow for plan participants to set up a self-directed brokerage account. Effective December 9, 2019, the Plan was amended to provide for an automatic enrollment of an initial pretax deferral contribution of 5% for newly eligible employees 35 days after such employee’s date of hire. The Plan excludes bonuses, auto allowances, and severance payments from compensation. For the Plan year ended December 31, 2024, employer matching contributions were \$1,002,557.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's pretax or after-tax contributions, the Company's matching contributions, and allocations of investment earnings or losses, and is charged with withdrawals. Allocations of investment earnings or losses are based on investment selections and account balances, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions. Vesting in the Company's matching contributions, plus earnings thereon, is based on years of continuous service. A participant is 20% vested after two years of credited service. The vesting percentage increases ratably at 20% per year, reaching 100% after six years of credited service.

Investment Options

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

Payment of Benefits

Upon termination of service, death, retirement, or disability, each participant or the participant's beneficiaries may receive the balance in the participant's account in a lump sum payment, less any loans outstanding and any unvested Company contributions. Account withdrawals are permitted by participants who suffer certain financial hardships and meet criteria established by the Internal Revenue Service ("IRS").

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000, up to \$50,000 or 50% of their vested account balance, whichever is less. Such loans bear interest at prevailing interest rates and are repaid to the participant's account over no more than five years, except in the case of loans used to acquire a primary residence. Participant loans are secured by the balance in the participant's account. Principal and interest are paid ratably through bi-weekly payroll deductions.

Forfeited Accounts

Under the Plan agreement, forfeitures of terminated unvested accounts are to be used to offset the Company's matching contributions and Plan expenses. Unvested forfeiture accounts totaled \$5 and \$17 at December 31, 2024 and December 31, 2023, respectively. Forfeitures used to reduce Company contributions for 2024 were \$116,722. The Company used \$3,078 of forfeitures to pay Plan expenses during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

LBA Realty 401(k) Plan

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Investment Asset Valuation

The Plan's investments are stated at fair value. Investments in mutual funds, common stock and other investments are valued at quoted market price. Investments in interest-bearing cash are stated at cost, which approximates fair value. Investment income consists of interest income, dividends, and net appreciation in the fair value of investments, which includes the Plan's gains and losses on the investments bought, held and sold during the year. See Note 3 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are reflected on the trade date. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Capital gains distributions are recorded as dividends.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant loans is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Risks and Uncertainties

The Plan invests in investment securities that may be selected by the participants in any combination. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies (continued)

Administration of Plan Assets

Contributions made by the Company and participants are held and administered by Fidelity Management Trust Company (the “Plan Trustee”), which invests the cash received, interest, and dividends in accordance with participants’ instructions. Distributions to participants are made by the Plan Trustee. The Plan Trustee also administers the payment of principal and interest on participant loans.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives additional compensation from the Plan. Administrative fees associated with the Plan are deducted from the Plan’s forfeiture account with any balance paid by the Plan Sponsor.

3. Investments

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement* (“ASC 820”), establishes a hierarchy for measuring fair value under U.S. GAAP for all financial assets and liabilities that are being measured and reported at fair value on a recurring and non-recurring basis. Fair value is measured in levels, which are described in more detail below, and are determined based on the observability and reliability of the assumptions used to determine fair value.

Level 1: Valuation for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2: Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or comparable assets or liabilities.

Level 3: Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models, and similar techniques, and not based on market exchange, dealer, or broker traded transactions. These valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

4. Information Certified by the Plan Trustee

- c. All information on the supplemental schedule of assets (held at end of year).

5. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

The Plan invests in various funds managed by the Plan Trustee and affiliates of Fidelity Investments Institutional Operations Company, Inc., the Plan Recordkeeper, and therefore, they qualify as “party-in-interest” transactions, which are permitted by the Department of Labor’s Rules and Regulations; however, they are exempt from the prohibited transaction rules under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth by ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. Reconciliation of Financial Statements to Form 5500

The information contained in the financial statements prepared on an accrual basis does not agree to the information contained in the Form 5500, which is prepared on a cash basis. The differences are due to the recording of receivables for employer and participant contributions in the financial statements.
