Independent Auditors' Report

Board of Directors
Shriners Hospitals for Children Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Shriners Hospitals for Children Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

(1) **Description of Plan**

The following description of Shriners Hospitals for Children Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

(a) **General**

The Plan is a defined contribution plan with an Internal Revenue Code 403(b) provision covering all eligible employees of the Shriners Hospitals for Children (the “Company”). The Plan was amended and restated on January 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (“ERISA”).

The Plan operates under agreements with Transamerica Life Insurance Company (“TLIC”), Transamerica Financial Life Insurance Company (“TFLIC”) and State Street Bank and Trust Company (“SSBT”) as the Plan custodians and Transamerica Retirement Solutions, LLC as the plan recordkeeper. SSBT serves as a sub-advisor for certain funds managed by Variable Annuity Life Insurance Company (“VALIC”) and provides the certification for said funds.

(b) **Contributions**

Participants are automatically enrolled in the Plan upon eligibility, which is defined as one day of employment, with a default deferral percentage of eligible compensation. Participants are able to opt-out of the automatic enrollment by contacting the custodian directly. Participants choosing to contribute do so based on a percentage of eligible compensation on a pre-tax basis to the Plan, not to exceed \$23,000 and if applicable, \$7,500 of catch-up elective deferrals for participants over age 50 as allowed by the Internal Revenue Service for 2024.

The Company may, at its discretion, make matching contributions of 50% of the participant’s voluntary contribution, not to exceed the first 6% of the participant’s compensation, as defined. Employees who are not enrolled in the Shriners Hospitals for Children Employees’ Retirement Plan are eligible to receive matching contributions of 100% of the participant’s voluntary contribution, not to exceed the first 6% of the participant’s compensation, as defined. All employees of the Company who have completed one year of employment are eligible to receive the employer matching contribution.

The Plan allows participants to direct investment of their elective deferrals and the Company matching contributions into various investments offered by the Plan.

The Plan accepts rollovers and direct transfers from other tax-qualified plans.

(c) **Participant Investment Account Options**

The Plan currently offers various registered investment companies, a self-directed brokerage account, general accounts, and a guaranteed interest fund as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

(1) Description of Plan - Continued

(d) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's matching contributions, as well as earnings thereon. Allocations are based on participant earnings or account balances, as defined.

(e) Vesting

Participants are immediately vested in their contributions; their allocation of the Company's matching contribution, plus actual earnings thereon.

(f) Payment of Benefits

On termination of service due to death, permanent disability or retirement, a participant may elect to receive either a lump sum, partial or installment distribution of the participant's vested account balance. A participant whose vested account balance does not exceed \$1,000 will receive a single lump sum distribution. In-service withdrawals of vested portions of participant account balances are permitted upon attainment of age 59½ or in the event of disability. In the event of financial hardship, participants may request a distribution from the Plan to the extent required to satisfy the immediate financial needs of the participant. Such distributions are limited to the vested account balance of the participant. Qualifications to receive a hardship distribution are outlined in the Plan's provisions.

(g) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and may borrow up to the lesser of 50% of their vested account balance or \$50,000. Loan terms range from one to five years or up to fifteen years for the purchase of a primary residence. Notes receivable from participants are secured by the balance in the participant's account and bear a fixed rate of interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

(b) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive guaranteed interest fund which is reported at contract value). Shares of registered investment companies are valued at the net asset value of shares held by the Plan at year end based on quoted market prices.

(2) Summary of Significant Accounting Policies - Continued

(b) Investment Valuation and Income Recognition - Continued

The TFLIC General Account and VALIC General Account are valued based on observable inputs and are valued at fair value.

The TLIC Guaranteed Investment Option is a stable value product that guarantees principal and interest, valued at contract value. Guarantees are provided to participating retirement plans through a group annuity contract issued by TLIC. Guarantees are backed by the financial strength of TLIC's general account. See Note 5 for additional information about the TLIC Guaranteed Investment Option.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(c) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

(d) Administrative Fees

Certain administrative and recordkeeping expenses are allocated proportionately to each participant. These expenses are allocated proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Processing fees for items such as hardship distributions, in-service distributions, distributions at termination of employment and loans are charged against the account of the participant responsible for the expense.

(e) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(f) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities as stated in the plan agreement. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

(g) Payment of Benefits

Benefits are recorded when paid.

(h) **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(3) **Information Prepared and Certified by the Custodians**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly TLIC, TFLIC and SSBT, the custodians of the Plan, have certified that the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) is complete and accurate:

- Total investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Total investment income and related investment activity, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- The Schedule of Assets (Held at End of Year) as of December 31, 2024 as shown in the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedule.

(4) **Fair Value Measurements**

The Company uses a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value as follows:

Level 1: Observable inputs such as quoted prices in active markets;

Level 2: Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly;

Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

Each asset's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

(4) Fair Value Measurements - Continued

Registered Investment Companies: shares of registered investment companies are valued at the net asset value of shares held by the Plan at year end based on quoted market prices and are classified as Level 1 as determined by TFLIC.

Self-Directed Brokerage Account: self-directed brokerage accounts are invested in various cash and money funds and mutual funds; Level 1 classification is considered appropriate based on readily determinable fair value of the investments.

TFLIC General Account and VALIC General Account: based on observable inputs and are classified as Level 2 as determined by TFLIC and VALIC.

(5) TLIC Guaranteed Investment Option

Investments in the guaranteed investment option allow participants to invest money in a general account of TLIC which earns interest. Participant contributions are commingled with TLIC's other assets and TLIC assumes the risk of principal and accrued interest. An effective annual rate of interest is established the day prior to January 1st and July 1st each year. Interest is credited to the guaranteed investment option daily based on its daily balance, at a rate of interest that is the daily equivalent of the effective annual rate of interest applicable for the semiannual period. The guaranteed investment option is reported at contract value at December 31, 2024 and 2023. All participant transactions are at contract value.

(5) **TLIC Guaranteed Investment Option - Continued**

Certain events limit the ability of the Plan to transact at contract value with TLIC. Such events include the following: (1) amendments to the plan documents (including complete or partial termination); (2) bankruptcy of the Company; (3) other Company events that cause a significant withdrawal from the Plan; or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Company does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(6) **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, at any time, subject to provisions of ERISA.

(7) **Tax Status**

The Plan adopted a volume submitter 403(b) plan, which obtained a favorable opinion letter dated March 31, 2017. The Plan is required to operate in conformity with the Internal Revenue Code to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator and the Plan's management believe that the Plan is being operated in compliance with the Internal Revenue Code, and as such, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) **Party-in-Interest**

The Plan invests in certain funds managed by TFLIC. The Plan paid approximately \$626,000 of administrative fees to TFLIC during 2024. These transactions qualify as party-in-interest transactions, but are expressly exempted from prohibited transaction rules.

(9) **Subsequent Events**

The Plan's management has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 14, 2025, the date the financial statements were available to be issued.
