Note 1 - Description of Plan:

The following brief description of the Landmark Health Solutions Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan, which was adopted by Landmark Health Solutions, LLC (currently named Landmark Management Solutions, LLC) effective July 1, 2002 and amended from time to time thereafter, is a defined contribution plan covering all eligible full and part-time employees, who have attained the age of 21, of Landmark Management Solutions, LLC, Essex Pavilion, LLC, Ashmont Hill, LLC, Bentley Saint Francis, LLC, Landview Therapy Resources, LLC, and, effective August 1, 2023, Bentley Casa de Ramana, LLC (collectively "the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Recent Legislation

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. Secure Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 or will thereafter.

(b) Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, money markets, and one pooled separate account as investment options for participants. The Company may match eligible employee contributions using a discretionary formula. For the years ended December 31, 2024 and 2023, the Company matched 25% of the participants first 6% of compensation. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. Participants are eligible to share in any discretionary profit-sharing contributions if they have completed one year of service and are employed on the last day of the Plan year. There were no discretionary profit-sharing contributions in 2024 and 2023. Contributions are subject to certain limitations.

The maximum allowable calendar-year pre-tax voluntary contribution, as determined by the Internal Revenue Service was \$23,000 and \$22,500 during the years ended December 31, 2024 and 2023, respectively, in addition to a maximum allowable catch-up contribution of \$7,500, for each year.

Note 1 - Description of Plan (continued):

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested amount.

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 6 years of credited service or if the participant has reached the early retirement age of 55 and completed 5 years of credited service. Participant accounts become fully vested upon death, disability, attainment of normal retirement age, or upon termination of the Plan.

(e) Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect on the date the loan was made plus 1.00%. Principal and interest are paid ratably through regular payroll deductions.

(f) Payment of Benefits

In-service withdrawals may be made from a participant's employee contributions account based on financial hardship or upon reaching age 59½. On termination of service due to death, disability, or retirement, a participant, or his/her beneficiary, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited Accounts

At December 31, 2024 and 2023 forfeited non-vested amounts totaled \$44,580 and \$106,500, respectively. These accounts will be used to pay administrative expenses of the Plan and may be used to reduce future employer contributions. During 2024 and 2023, forfeitures totaling \$91,237 and \$0 were used to pay administrative expenses and to reduce employer contributions, respectively.

Note 2 - Summary of Significant Accounting Policies:

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value, except for the pooled separate account, which is recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements and Note 6 for discussion on contract value of the pooled separate account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The pooled separate account with underlying investments in fully benefits responsive investment contracts, the Lincoln Stable Value (LSV) is valued at the fair market value of the underlying investment and then adjusted by the issuer to contract value. The contract value of the LSV at December 31, 2024 and 2023 was \$786,129 and \$892,831, respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded as a deemed distribution on the statements of changes in net assets available for benefits. Deemed distributions amounted to \$19,961 and \$26,215 during the years ended December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies (continued):

(e) Corrective distributions

Amounts paid to participants for contributions in excess of amounts allowed by the IRS are recorded as corrective distributions on the statements of changes in net assets available for benefits. Corrective distributions for the years ended December 31, 2024 and 2023 amounted to \$44,399 and \$0, respectively.

(f) Payment of Benefits

Benefit payments to participants are recorded when paid.

(g) Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in the Plan's investments. Management believes that the trustee maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

(h) Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

(i) Merger

Effective August 1, 2023, the Bentley Casa de Ramana 401(k) Retirement Plan merged with the Landmark Health Solutions Savings Plan. All employees under the former Bentley Casa de Ramana 401(k) Retirement Plan are eligible to participate in the Landmark Health Solutions Savings Plan once their eligibility requirements have been met. Investments transferred from the Bentley Casa de Ramana 401(k) Retirement Plan into the Landmark Health Solutions Savings Plan amounted to \$498,657 during the year ended December 31, 2023.

(j) Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3 - Information Prepared and Certified by the Plan's Trustees (Unaudited):

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's trustees, Fidelity Management Trust Company for the year ended December 31, 2024 and for the period of August 1, 2023 through December 31, 2023 and Lincoln Financial Group Trust Company for the period January 1, 2023 through July 31, 2023.

Note 4 – Investments:

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$953,139 and \$1,316,534, respectively.

Note 5 - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 6 - Investment in Pooled Separate Account:

The Plan has entered into a fully benefit-responsive investment contract with Lincoln Financial Group Trust Company, Inc. ("Lincoln") at December 31, 2024 and 2023. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Lincoln. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Because the pooled separate account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the pooled separate account. Contract value, as reported to the Plan by Lincoln are equal to the sum of all of the benefits owed to the participants in that fund (invested principal and accrued interest). The fair value of a pooled separate account is equal to the sum of the market value of all of the fund's investments. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 6 - Investment in Pooled Separate Account (continued):

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the ability of the Plan to transact with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-off's of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 7 - Related Party Transactions and Party in Interest Transactions:

Certain Plan investments are shares of mutual funds managed by Lincoln Financial Group Trust Company, Inc. ("Lincoln") for the period January 1, 2023 through July 31, 2023, and Fidelity Management Trust Company ("Fidelity") for the period August 1, 2023 through December 31, 2024. Lincoln and Fidelity are also the investment trustees, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan participants paid administrative fees of \$28,380 to Lincoln during 2023, and \$38,966 and \$11,542 to Fidelity during December 31, 2024 and 2023, respectively. In addition, the Plan paid audit fees of \$32,520 and \$15,250 during the years ended December 31, 2024 and 2023, respectively. Lastly, the Plan paid advisor fees of \$25,000 to Lion Street Financials during the year ended December 31, 2024.

Note 8 - Benefit Claims Payable:

Benefit claims payable are benefit payments requested by Plan participants prior to the plan year end that have not yet been disbursed. The total amount of benefit claims payable as of December 31, 2024 and 2023 amounted to \$0.

Note 9 - Concentrations:

As of December 31, 2024, the Plan held investments in Fidelity FDM Index 2030 IPR with a fair value of \$2,093,471, Fidelity FDM Index 2035 IPR with a fair value of \$2,071,846, and Fidelity FDM Index 2025 IPR with a fair value of \$1,562,878, each of which represented more than 10% of the Plan's net assets available for benefits. As of December 31, 2023 the Plan held investments in Fidelity FDM Index 2030 IPR with a fair value of \$1,833,700, Fidelity FDM Index 2035 IPR with a fair value of \$1,753,401, and Fidelity FDM Index 2025 IPR with a fair value of \$1,529,799, each of which represented more than 10% of the Plan's net assets available for benefits.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts, and the net assets of the Plan must be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

Note 11 - Tax Status:

The Plan is based on a "prototype" plan drafted by Fidelity Management Trust Company, Inc. The prototype received an Internal Revenue Service ("IRS") "prototype" letter on June 30, 2020. The letter states the prototype plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the "prototype" letter. However, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Service. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 12 - Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
