Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Horizon House 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of Plan

The following description of the Horizon House 403(b) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution retirement plan covering all eligible employees of Horizon House, Inc. (the Company or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration

Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan.

American United Life Insurance Company (AUL) serves as the custodian and recordkeeper of the Plan.

Contributions

Employees are eligible to participate into the Plan immediately upon hire. Participants are automatically enrolled in the Plan with a 1% deferral. Participants may decline automatic enrollment, stop, or increase their deferral at any time subject to certain Internal Revenue Code (IRC) limitations. All participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions in addition to the statutory limit. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Company matches 50% of employee contributions up to 3%. To be eligible to receive the Company match, a participant must have attained 21 years of age, one year of service, and 1,000 hours of service during the Plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and investment earnings, and are charged with investment losses and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in variable annuity contracts and a guaranteed interest account managed by AUL. Participants may change their investment options at any time.

Vesting and Forfeitures

All participants are immediately 100% vested in their contributions and rollover contributions plus actual earnings thereon.

A participant is 100% vested in Company contributions after five years of credited service, after the attainment of normal retirement age (65), or upon death or total disability, as defined by the Plan. Vesting in the Company's matching contributions plus earnings thereon is based on years of service, as follows:

Forfeitures attributable to matching contributions are used to reduce future employer matching contributions. During the year ended December 31, 2024, forfeitures of \$18,049 were used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the value of the vested balance of the participant's account. Terms of the loan may not extend beyond five years except loans for the purchase of a primary residence. Repayments of principal and interest are paid through level payroll deductions over the life of the loan. Interest rates are based on the commercial rates for similar loans at the inception of the loan.

Payment of Benefits

The Plan provides that under certain conditions, participants may withdraw their vested benefit. A participant is entitled to receive his or her account in a lump-sum distribution, annuity, or in monthly, quarterly, or annual installments, under the conditions described in the Plan document, in the event of retirement, termination, hardship, death, or reaching age 59½ as an active employee. Upon the death of a participant, the remaining portion of the benefit will be distributed to the beneficiary using the same payment method elected by the participant.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts are stated at net asset value (NAV) as a practical expedient to estimate fair value and have not been categorized in the fair value hierarchy. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes dividend income and the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fully Benefit-Responsive Investment Contract

The Plan is invested in a fully benefit-responsive investment contract through the AUL Stable Value Account, which is reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed where they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution is recorded.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses and Expense Offset Arrangements

The Plan pays the administrative costs of the Plan associated with professional services provided to the Plan. Recordkeeping fees are paid by the Plan.

Revenue Credits

The Plan's trust agreement with AUL provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. Unallocated revenue credits at December 31, 2024 and 2023 were \$0. During 2024, the Plan received credits of \$12,427, which was used to pay administrative expenses. Administrative expenses are presented net of revenue credits in the statement of changes in net

assets available for benefits.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL (the Custodian of the Plan), a qualified institution.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedules, including assessing whether the supplemental schedules are in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used or transfers between levels at December 31, 2024 and 2023.

Pooled Separate Accounts

Pooled separate accounts (PSAs) are valued at the NAV of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by American United Life Insurance Company, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments at December 31, 2024 and 2023.

5. Fully Benefit-Responsive Investment Contract with Insurance Company

The Plan invests in the Stable Value fund with AUL. AUL maintains the contributions of the Stable Value Account in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of these investments was \$1,456,245 and \$1,469,831 at December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit AUL to terminate the agreement prior to the scheduled maturity date.

6. Parties-in-Interest and Related Party Transactions

AUL, the custodian of the Plan, manages the Stable Value Account. Therefore, these transactions within the Stable Value Account qualify as party-in-interest transactions and are denoted as such on the supplemental Schedule of Assets (Held at End of Year). The Plan also receives revenue credits

from AUL. Fees incurred by the Plan for investment management services were included as a reduction of the return earned on each investment fund and included in net appreciation in fair value of investments.

Notes receivable from participants qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

7. Tax Status

The Plan adopted a new volume submitter plan effective January 1, 2020, which has obtained a favorable opinion letter dated March 31, 2017, from the Internal Revenue Service (IRS) program on pre-approved plans as outlined in Revenue Procedure 2013-12. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently operating, in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, contributions cannot be made to the Plan, and participant balances will remain vested in accordance with Plan provisions and may be distributed. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Prohibited Transactions

During the year ended December 31, 2024, the Plan Sponsor failed to remit certain participant contributions and loan repayments totaling \$875,311 to AUL within the period prescribed by Department of Labor regulations. These transactions constitute prohibited transactions, as defined by ERISA. As of December 31, 2024, all such delinquent participant contributions had been remitted to the Plan. The Plan Sponsor has made a payment during 2025 in order to compensate those participants for lost income resulting from the delay in remittance of contributions.
