## Notes to Financial Statements

---

### 1. Description of Plan

The following description of the Horizon House, Inc. Employer Retirement Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a discretionary defined contribution plan which was established on January 1, 1997. The Plan covers all eligible employees of Horizon House, Inc. (the Company or Plan Sponsor) who have worked 1,000 hours within a consecutive twelve month period, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Administration*

Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan.

American United Life Insurance Company (AUL) currently serves as the custodian, and record keeper of the Plan.

#### *Contributions*

Each year, the employer may elect to contribute an amount not to exceed 25% of the total salary of all participants for the year. Participants may direct contributions in variable annuity contracts and a guaranteed interest account managed by AUL. Participant contributions are not permitted under the Plan. Contributions are allocated among eligible participants who worked at least 1,000 hours during the Plan year and were employed on the last day of the Plan year. Contributions are subject to certain limitations.

The Plan Sponsor determined that there would be no discretionary contributions to the Plan during 2024.

#### *Participant Accounts*

Each participant's account is credited with an allocation of (a) the employer's contribution, (b) Plan earnings, and (c) forfeitures of certain participants' non-vested accounts, if any, and is charged with an allocation of Plan investment losses and administrative expenses. Allocations are based on participant compensation, years of service, and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

***Payment of Benefits***

Upon termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Death benefits will be paid to a surviving spouse or, with spousal approval, to a designated beneficiary as a lump-sum distribution.

The plan administrator may elect to authorize an automatic lump sum distribution for terminated participants whose vested account balances are less than or equal to \$5,000.

***Forfeitures***

Forfeitures may be used to pay administrative costs of the Plan, offset employer contributions and/or to restore previously forfeited participant account balances. If reallocated to participant accounts, forfeitures of nonvested amounts are allocated pro-rata based upon the same method used to allocate the Employer's contribution. For the year ended December 31, 2024, there were no forfeited, non-vested amounts reallocated to the participants. For the year ended December 31, 2024, forfeitures were not used to pay administrative costs of the Plan. There were no unused or unallocated forfeited balances at December 31, 2024 and 2023.

**2. Summary of Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments in pooled separate accounts are stated at net asset value (NAV) as a practical expedient to estimate fair value. Fair value is the price that would be received to sell an asset or

paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees, determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

### ***Fully Benefit Responsive Investment Contracts***

The Plan is invested in a fully benefit-responsive investment contract through the AUL Stable Value Account which is reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses and Expense Offset Arrangements***

Most expenses incurred in the administration of the Plan, including fees and expenses connected with providing administrative services by external service providers, are paid by the Plan. The administrative expenses totaled \$4,214 for the year ended December 31, 2024.

### ***Revenue Credits***

The Plan's trust agreement with AUL provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. Unallocated revenue credits at December 31, 2024 and 2023 were \$0. During 2024, the Plan received credits of approximately \$2,925, which was used to pay administrative expenses. Administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

## **3. Certified Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL (the Custodian of the Plan).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used or transfers between levels at December 31, 2024 and 2023.

***Pooled Separate Accounts (PSAs):*** Pooled separate accounts are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by American United Life Insurance Company is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments.

*Equity* - Seeks long-term growth of principal and income. The fund invests primarily in a diversified portfolio of equity securities.

*Bond* - Seeks to either increase returns based on anticipated changes in these bond-pricing factors or to maintain a certain return regardless of changes in those factors. Investments are made primarily in a diversified portfolio of investment grade, fixed-income securities of various types of bonds and other securities.

*Target based* - Invests the assets of each target retirement fund into underlying funds according to a proprietary asset allocation strategy. The investment objective is to seek capital growth and income over the long term.

*Diversified* - Seeks a return through an investment of a diversification of equity, fixed income and other investments.

## **5. Fully Benefit-Responsive Investment Contract with Insurance Company**

The Plan invests in the Stable Value Account with AUL. AUL maintains the contributions of the Stable Value Account in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of these investments was \$228,522 and \$252,569 at December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant

withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit AUL to terminate the agreement prior to the scheduled maturity date.

### 6. Parties-In-Interest and Related Party Transactions

AUL, the custodian of the Plan, manages the Stable Value Account. Therefore, these transactions within the Stable Value Account qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year). The Plan also receives revenue credits from AUL. Fees incurred by the Plan for investment management services were included as a reduction of the return earned on each investment fund and included in net appreciation in fair value of investments.

### 7. Tax Status

Effective January 1, 2022, the Plan adopted a non-standardized pre-approved profit sharing plan in order to maintain compliance with the IRC. The IRS ruled on June 30, 2020 that the pre-approved plan was in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to the participant accounts and distributed in such a manner as the Plan Sponsor may determine.

### 9. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 10. Subsequent Events

Events and transactions subsequent to year end have been evaluated for potential recognition or disclosure in the financial statements through October 14, 2025 which is the date these financial statements were available to be issued.
