Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Spartech LLC 401(k) Savings & Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Spartech LLC 401(k) Savings & Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of Spartech LLC 401(k) Savings & Investment Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution plan covering all employees of Spartech LLC (the Company), except those included in collective bargaining units, unless the agreement requires the employees to be included in the Plan, and certain leased, temporary, co-op, or seasonal employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees are eligible to begin making salary deferral contributions and to receive Company contributions immediately upon hire. The Plan provides for automatic enrollment upon satisfying the eligibility requirements. The default deferral rate upon automatic enrollment is 3%. For participants who are automatically enrolled, the deferral rate is increased annually by one percentage point until a maximum rate of 6% is achieved.

Contributions

Participants may defer up to 100% of eligible compensation, as defined by the Plan Document, not to exceed Internal Revenue Service (IRS) limits, on a pre-tax, Roth or after-tax basis. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

The Company safe harbor matching contribution equals 100% of the amounts contributed by each participant that do not exceed 3% of the participant's eligible compensation, with an additional 50% matching contribution of the amounts contributed by each participant that do not exceed the next 3% of the participant's eligible compensation.

The Plan provides the option for the Company to contribute discretionary profit sharing contributions each Plan year. There were no such discretionary profit sharing contributions made during the years ended December 31, 2024 or 2023.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of the Plan's earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

A participant may direct contributions to a variety of investment options provided by the Plan. Participants may change their investment elections or future contributions or balances any time during the year.

Notes Receivable From Participants

A participant may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are for a period not to exceed five years. Notes are secured by the participants' account balances and bear interest at the prevailing prime rate plus 1%. Principal and interest are repaid through payroll withholdings. A participant may not have more than one note outstanding at any time.

Vesting

Participants are immediately vested in their salary deferral contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon.

For the Company profit sharing contribution, a participant is 20% vested after one year of credited service, increasing 20% each year to 100% after five years of credited service. Participants also become 100% vested upon death or becoming disabled.

Forfeitures

Forfeited nonvested accounts are used to pay expenses of the Plan to the extent not paid by the Company without claim for reimbursement from the Plan or to offset the Company's matching contributions or discretionary contributions. For the years ended December 31 2024 and 2023, forfeitures amounting to \$7,749 and \$33,861, respectively, were used to offset Company contributions. Forfeited amounts available for future use amounted to \$1,734 and \$9,233 as of December 31, 2024 and 2023, respectively.

Notes To Financial Statements (*Continued*)

Payment Of Benefits

Upon termination of employment, retirement, disability, or death, a participant's vested balance may be distributed in a lump sum or substantially equal installment payments.

In-Service Withdrawals

Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

Active participants who experience a qualifying financial hardship may withdraw all or part of their vested accounts. Hardship withdrawals will be approved only if they conform to Plan and established IRS safe harbor provisions.

Administrative Expenses

Salaries and related benefits of employees who administer the Plan are provided by the Company. Other administrative expenses, primarily transaction fees and account fees, are shared by the Plan and the Company. Expenses incurred on the purchase or sale of investments are added to the cost or deducted from the proceeds of the respective investment.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Notes To Financial Statements (*Continued*)

Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account

Valued at the NAV of units held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The pooled separate account may be redeemed daily, and files an annual report on Form 5500 as a direct filing entity. There are no capital commitments related to the Plan's pooled separate account.

Collective Trust Funds

Valued at the NAV of units of the individual funds. The NAV, as provided by the trustees of the invested funds, is used as a practical expedient to estimate fair value and is calculated daily by the trustees. The NAV of each fund is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. All collective trust funds have daily redemption frequencies at NAV with no redemption notice periods, and file annual reports on Form 5500 as direct filing entities. There are no capital commitments related to any of the Plan's collective trust funds.

Individually Directed Brokerage Accounts

Self-directed brokerage accounts are comprised primarily of common stocks, mutual funds, corporate bonds and U.S. Government fixed income securities. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Corporate bonds and U.S. Government fixed income securities are valued at either the closing price reported on the active market on which the individual securities are traded or valued by a pricing service which determines the valuation of normal institutionalized trading units of such securities using methods based upon market transactions for comparable securities and various relationships between securities which are generally recognized by institutional traders.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party In Interest Transactions

The Plan pays administrative fees to John Hancock Retirement Plan Services for recordkeeping services. In addition, certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as allowable party in interest transactions under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Income Tax Status

The Plan uses a pre-approved defined contribution plan document sponsored by John Hancock Retirement Plan Services, LLC. John Hancock Retirement Plan Services, LLC obtained an opinion letter dated June 30, 2020, in which the IRS states that the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Transfers

During 2021, the Company acquired Crawford Industries LLC. Effective January 1, 2023, the assets of Crawford Industries Retirement Savings Plan, totaling approximately \$3,028,000, were merged into the Plan.
