We have performed audits of the accompanying financial statements of Traxys North America, LLC 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

The following description of the Traxys North America, LLC 401(k) and Profit-Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a safe harbor plan established on January 1, 1989. The Plan is available to all employees of Traxys North America, LLC (the “Company”) who meet the eligibility requirements. The Plan provides deferred compensation benefits and is subject to the applicable regulations of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan investments were administered and held in a trust by Fidelity Management Trust Company (“Fidelity”) (the “Trustee”). On December 31, 2024, all assets of the Plan were transferred from Fidelity to Reliance Trust Company (the “Custodian”) and Transamerica Retirement Solutions, LLC (the “Recordkeeper”). The Trustee and the Plan administrator are appointed by the Company.

Eligibility

Participants are eligible to enter the Plan on the first day of the month coinciding with or next following their date of hire. The Plan excludes those employees who are (1) union employees, as defined, or (2) nonresident aliens with no earned income from sources within the United States, (3) leased employees, (4) part time, temporary, or seasonal employees, or (5) independent contractors. Effective January 1, 2025, the plan was amended to include long-term part-time employees who have been credited with at least three consecutive years of service beginning after December 31, 2020 with at least 500 hours of service in each year and have attained the same age as the other participants who are eligible to defer. They are eligible to make pre-tax contributions, after-tax (Roth) contributions, or rollover contributions, but are not eligible to receive employer contributions.

Participants are eligible for matching contributions and profit sharing upon entrance into the Plan.

Contributions

Each year, under the 401(k) feature, participants may contribute a percentage or specific amount from their eligible compensation on a pre-tax or after-tax (Roth) basis, as defined by the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code (“IRC”).

A participant shall be permitted to irrevocably designate a portion of their elective deferral contributions allowed under the Plan as a Roth contribution and are permitted to make Roth direct rollover contributions to the Plan. Participants can change the amount of their elective deferral contributions prospectively on the first of each month.

Contributions (continued)

A Plan participant may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as a rollover, with certain restrictions.

The Company may make a profit sharing and/or matching contribution to the Plan based on a discretionary percentage of each participant's elective deferral contribution. During the 2024 plan year, the Company made a profit sharing contribution at rates that ranged from 0% to 11.04% based upon the participant's group.

To maintain safe harbor status, the Company must make a safe harbor nonelective contribution equal to 3% of compensation paid to participants annually.

During the 2024 plan year the Company made safe harbor nonelective contributions, matching contributions in the amount of 50% of a participant's contribution for those contributing up to 6%, or 3% of eligible compensation for participants contributing more than 6%, and profit sharing contributions based on the following groups: group 1 – senior managers; group 2 – eligible staff under TNA; group 3 – eligible staff under TCPI; group 4 – terminated staff with more than 500 hours of service; group 5 – terminated staff with less than 500 hours of service.

Participant Accounts

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, Company discretionary matching contributions, Company discretionary profit sharing contributions, Company safe harbor contributions and Plan earnings. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant's account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately and fully vested in their pre-tax or Roth contributions and Company safe harbor contributions plus actual earnings thereon. Participants are always fully vested in their rollover contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. A borrower is limited to having a maximum of one outstanding loan under the Plan at any given time. Loans are secured by the balance in the participant's account and bear interest as determined at the time of the loan origination. Principal and interest are paid ratably through monthly payroll deductions over a period of time not to exceed five years. If the proceeds are used to purchase a participant's principal residence, the Plan administrator may permit a longer repayment term. Principal and interest repaid is reinvested based on the participant's present investment allocation selection.

Delinquent participant loans are classified as distributions based upon the terms of the Plan document. During 2024 there were no participant loans that became delinquent.

Payment of Benefits

Participants are eligible to receive distributions of their account without penalty upon reaching age 59 ½. Upon retirement, hardship, termination, death, or disability, vested benefits are distributed at the participant's or beneficiary's election via a lump sum payment or partial withdrawals or installments if the vested balance is in excess of \$5,000.

Forfeitures

Forfeitures of terminated participants' non-vested accounts serve to reduce employer contributions or Plan expenses. As allowed by the Plan, the Company elected to use \$1,800 from the forfeited non-vested accounts to pay Plan expenses and \$161,295 were used to reduce employer contributions during the year ended December 31, 2024. At December 31, 2024 and 2023, the balance of the forfeited non-vested accounts amounted to \$27,417 and \$91,167, respectively.

Revenue Credit Account

The Plan and Fidelity have entered into a revenue sharing arrangement whereby a portion of the revenue earned by Fidelity from certain funds is allocated to the Revenue Credit Account on a quarterly basis. In order for the Plan to receive credits as a result of this arrangement, the Company created the Revenue Credit Account under the Plan. The Revenue Credit Account is a nonparticipant directed account within the Plan, and is used to record the redistribution of plan-generated fund revenue based on the agreed rate for each fund multiplied by the average quarterly balance. The Revenue Credit Account balance was \$140,092 and \$176,806 at December 31, 2024 and 2023. During 2024, \$40,553 from the Plan's revenue credit account were used to pay plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP"), using the accrual basis of accounting, which recognizes revenue when it is earned and expenses as they are incurred.

Use of Estimates

In conformity with US GAAP, the Plan's management makes estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan's investments in mutual funds are considered to be valued based on Level 1 inputs.

Investment Valuation and Income Recognition

The mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded. These funds were required to publish their daily NAV and to transact at that price. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are paid. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is deemed to be a benefit distribution.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company and by Fidelity Investments Institutional Operations Company LLC (certified the common/collective trust at December 31, 2024), qualified institutions.

4. Due from Broker

Due from broker at December 31, 2024 represents the investments of the Plan that transferred out of Fidelity on December 31, 2024 but were not received by Reliance Trust Company until January 2, 2025. These investments were held by Fidelity in a holding account at December 31, 2024.

5. Fidelity Managed Income Portfolio Class II Account

The Managed Income Portfolio II (“MIP II”) is a common/collective trust. Fidelity is the trustee of the MIP II. The MIP II invests in assets (typically fixed income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters wrap contracts issued with third parties, and invests in cash equivalents represented by shares in money market funds. Wrap contracts are purchased from issuers rated in the top three long-term rating categories (A- or the equivalent and above).

Investment contracts are designed to permit the use of book value accounting to maintain a constant \$1 unit price and to provide for the payment of participant-directed withdrawals and exchanges at book value (principal and interest accrued to date) during the term of the investment contracts. However, withdrawals prompted by certain events (e.g., termination of the portfolio, changes in laws or regulations, substantive modification to the portfolio or the administration of the portfolio that is not consented to by the wrap issuer, etc.) may be paid at market value which may be less than book value.

5. Fidelity Managed Income Portfolio Class II Account (*continued*)

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the MIP II at NAV.

NAV per unit is determined each business day. Issues and redemptions of units are recorded, upon receipt of unitholder's instructions in good order, based on the next determined NAV per unit normally each day. In unusual market conditions, the trustee may impose restrictions on issues and redemptions of units.

The balance in the MIP II at December 31, 2024 was transferred to Reliance Trust Company in February 2025.

6. Tax Status

The IRS has determined and informed the Company by issuing an opinion letter dated June 30, 2020, that the Plan and the related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter from the IRS. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, all amounts credited to participant accounts shall become fully vested and non-forfeitable. Accordingly, assets will be distributed to the participants and beneficiaries in proportion to their respective account balances.

8. Non-exempt Party-in-Interest Transactions

The Employer failed to transmit to the Plan contributions and loan repayments for participants totaling \$521,132 (\$153,575 related to the 2024 plan year, \$218,051 related to the 2023 plan year, and \$149,506 related to the 2022 plan year) within the period prescribed by Department of Labor regulations. The Employer has corrected contributions totaling \$470 and is in the process of making the remaining necessary corrections.

9. Party-in-Interest Transactions

Certain investments of the Plan were managed by Fidelity as defined by the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
