**NOTE 1: DESCRIPTION OF PLAN**

The following description of the CustomInk, LLC 401(k) Savings Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan, effective February 1, 2005 and most recently restated July 31, 2022, that was adopted by CustomInk, LLC (the "Company" and the "plan administrator") to provide employees the opportunity to accumulate savings that provide benefits in the event of retirement, disability, or death. Other employers who have adopted the provisions of the Plan are Apparel Media Group, Inc., Booster, LLC, Spark Commerce, CustomInk Retail, LLC, Represent Holdings, LLC, CustomInk Stores, LLC, Swag.com, LLC, and Printfection Group, LLC. The Plan is structured to comply with the requirements of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility** - All employees, except for leased employees, are eligible to enter the Plan upon employment and attaining 18 years of age. All eligible employees are automatically enrolled in the Plan to defer 3% of compensation unless they elect otherwise. Entry into the Plan is the first day of the month following the completion of the eligibility requirements.

**Contributions** - Participants may elect to contribute up to 100% of compensation, as defined in the Plan, subject to maximum limits established by the Internal Revenue Code (IRC). Participants may elect to contribute to the Plan on a pretax basis or to contribute Roth elective deferrals on an after-tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into a diversified menu of investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Each year, the Company may contribute, at its discretion, a matching contribution to the Plan based on the deferral contribution percentage. The Company will determine its matching contribution based on deferral contributions made during each plan year. For the year ended December 31, 2024, the discretionary matching contribution was equal to 25% of each participant's deferral up to a deferral of 6% of eligible compensation.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of earnings from the participant-directed investment selections. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Additionally, some administrative expenses are paid from the annual operating expenses of the Plan's designated investment alternatives, which are netted against the investment earnings for the relevant participant-directed investments. Allocations are based on participant earnings, account balances, or specific participant-initiated

*Participant Accounts - Continued* - transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* - Participants are immediately vested in their salary deferral contributions and actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of service. A year of service for vesting purposes is a plan year during which the participant completes 1,000 hours of service. Employer matching contributions made with respect to participant-elective deferrals are 100% vested after three years of credited service.

*Notes Receivable from Participants* - Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000, reduced by the highest outstanding loan balance during the prior twelve-month period. The vested account balance is used as collateral for any loan. All loans bear a reasonable rate of interest consistent with the interest rates charged by persons in the business of lending money for loans under similar circumstances. Unless otherwise determined, the interest rate is the prime rate plus 1%. All loans must be repaid in level payments on at least a quarterly basis through payroll deduction within a five-year period, unless the loan is for the purchase of a principal residence, in which case it can be repaid over a ten-year period. Loans will only be granted in the event of a participant's hardship or to meet specified financial situations, as defined by the loan agreement. Only one loan may be outstanding at one time.

*Payment of Benefits* - Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested balance, and partial withdrawals or installments for required minimum distributions. A participant may elect to withdraw the vested account balance after reaching the Plan's normal retirement age, 65. Terminated participants with a vested account balance less than \$1,000 who do not elect a form of distribution will automatically receive a lump-sum distribution. Participants with a vested account balance between \$1,000 and \$5,000 who do not elect a form of distribution will have their vested account balance rolled over to an individual retirement account selected by the Plan. A participant who has reached age 59½ may elect to withdraw all or a portion of his or her vested account balance while still employed. As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the calendar year following the year in which the participant reaches age 73, or (ii) the calendar year in which the participant retires.

*Hardship Withdrawals* - Participants may withdraw their vested account balance in the form of a hardship withdrawal to satisfy an immediate and heavy financial need, as defined by the Plan. The distribution may not exceed the amount of the participant's immediate and heavy financial need. The amount of immediate and heavy financial need may include any amounts necessary to pay any federal, state, or local income taxes or penalties reasonably anticipated to result from the distribution. The participant must exhaust all other avenues prior to obtaining a hardship withdrawal.

**NOTE 1: DESCRIPTION OF PLAN - CONTINUED**

*Forfeitures* - Upon termination from service, the nonvested portion of a participant's account is forfeited. Forfeitures are used to pay the Plan's ordinary and necessary administrative expenses for the plan year or to reduce any employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$188,782 and \$203,839, respectively. During the year ended December 31, 2024, \$35,627 of administrative expenses were paid.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits* - Benefits are recorded when paid.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Costs associated with participant-initiated transactions are paid by the respective participants' accounts. Some administrative expenses are paid from the annual operating expenses of the Plan's designated investment alternatives, which are netted against the investment earnings for the relevant participant-directed investments. *Administrative Expenses - Continued* - administrative expenses of \$282,203 consisted of \$25,466 for custodial and trustee services, \$44,000 for advisory services, and \$212,737 for recordkeeping and third-party administration services.

*Subsequent Events* - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The plan administrator has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED**

The following is a description of the valuation methodology used for assets measured at fair value. There has been no changes in methodology used as of December 31, 2024 and 2023.

**Registered Investment Companies (Mutual Funds)** - Registered Investment Companies (Mutual Funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan has not considered normal plan operations such as participant and employer contributions or benefits accrued or paid by the Plan for participants as party-in-interest transactions that require separate disclosure. Certain plan investments are shares of registered investment companies managed by the Trustee. Fees for professional services rendered by parties in interest are partially absorbed by the Company. Participant loan origination fees are paid out of the relevant participants' accounts. Administrative expenses paid from the annual operating expenses of the Plan's designated investment alternatives were disclosed to the Company. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

**NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts. Any unallocated forfeitures would be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7: TAX STATUS**

Effective July 31, 2022, the Plan was restated to adopt the Sentinel Benefits Group, Inc. non-standardized pre-approved profit-sharing plan with Cash or Deferred Arrangement, which has received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the form of the Plan is qualified under the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal Form 5500 is subject to examination by the IRS and DOL, generally for the three years after it was filed.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9: COMMITMENTS AND CONTINGENCIES**

In the normal course of business, there may be various commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of the plan administrator, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

**NOTE 10: PLAN AMENDMENT**

Effective January 1, 2023, the Plan was amended to include Printfection Group, LLC as a participating employer in the Plan.

Also, effective January 1, 2023, employer-matching contributions transferred from the Swag.com, LLC and Printfection Group, LLC plans shall be 100% vested.

**NOTE 11: PARTIAL PLAN TERMINATION**

As a result of a reduction in the Company's workforce effective on December 31, 2023, the Plan experienced a partial plan termination. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the plan sponsor. If a partial plan termination occurs, full vesting in the Company's contributions is required for the affected participants, but the remaining participants' vesting continues to be determined per the plan provisions.

All participants affected by the mass termination effective December 31, 2023, resulting in a partial plan termination, became fully vested in their accounts.
