## INDEPENDENT AUDITORS' REPORT

To The Trustees  
New Jersey Urology, LLC 401(k) Profit-Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of New Jersey Urology, LLC 401(k) Profit-Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of New Jersey Urology, LLC 401(k) Profit-Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Principal Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

## **Basis for Opinion**

Note 1 - Description of Plan

The following description of the New Jersey Urology, LLC 401(k) Profit-Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of New Jersey Urology, LLC (the “Company”) who have 60 days service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

An eligible employee is one who is not: governed under a collective bargain agreement, a non-resident alien, a leased employee, or an employee of an affiliate who has not adopted the Plan. In addition, there are specific excluded employees who are not direct or indirect owners of UMA Physician Holdings LLC, or non-physician employees who are employed at specific locations and divisions as noted in the plan adoption agreement.

Plan Merger

Effective June 15, 2022, the Plan, including substantially all assets, was merged into and with Summit City MD 401(k) Plan. Remaining assets in the Plan consist of primarily guaranteed investment contract balances which have withdrawal restrictions.

Contributions

Effective June 15, 2022, participants are neither required nor permitted to make contributions to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollover contributions, if applicable, and allocations of the Company’s contribution and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in the Company’s match and non-safe harbor profit-sharing contribution portion of the participant’s account, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service. For all other types of contributions, participants are vested 100% upon receipt of contributions.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1 to 5 years or up to a reasonable period of time for the purchase of a primary residence, which will be determined at the time that the loan is made. The loans are secured by the balance in the participant's account and bear a reasonable interest rate which is to be determined at the time of the loan. Principal and interest are repaid ratably through bi-weekly payroll deductions. There were no loans outstanding at December 31, 2024 and 2023.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may receive a lump-sum, installment or a partial distribution amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

At December 31, 2024 and 2023, unallocated forfeited nonvested accounts totaled \$88,170 and \$86,332, respectively. This account is used to reduce future employer matching, future employer non-safe harbor profit-sharing contributions, or administrative expenses. There were no forfeitures used for the year ended December 31, 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's fully benefit-responsive investment and insurance contracts, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note 5 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions once the participant is no longer employed by the Company. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Company pays for certain administrative expenses of the Plan, including various professional fees. Administrative expenses incurred by the Plan include account maintenance fees and loan processing fees charged directly to participants' accounts and investment management fees that are netted against investment returns.

Note 4 - Fully Benefit-Responsive Investment Contract

In 2021, the Plan entered into a fully benefit-responsive guaranteed contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.25%. Crediting rates are reviewed on a quarterly basis for resetting. Beginning six months after notification of the Plan’s intention to terminate the contract, the contract balance will be returned in six annual installments.

Note 5 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued at the official closing prices (typically last sale) on the exchange on which the securities are primarily traded or, if no closing price is available, at the last bid price.

*Cash:* The fair value is equal to the cost.

Participant-directed brokerage accounts, which consist primarily of cash and money market funds, are valued at the quoted net asset value ("NAV") of shares held at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Party-In-Interest Transactions

Principal Trust Company is considered to be a Plan trustee as defined by the Plan and, therefore, transactions with this entity qualify as party-in-interest transactions.

The Plan is managed by a third-party administrator, Danziger & Markhoff, LLP (the "TPA"). The TPA aids the Company in the administration of the Plan; therefore, transactions with this entity qualify as party-in-interest transactions. All costs associated with such recordkeeping are paid by the Company.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 7 - Income Tax Status

The Internal Revenue Service has determined and informed the Plan administrator by a letter dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Plan Transfer

During the year ended December 31, 2024, assets totaling \$218,557 were transferred to the VillageMD 401(k) Retirement Savings Plan. The transfer represents an installment payment from the fully benefit-responsive investment contract, made in accordance with the contract's terms and applicable plan provisions.

Note 10 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after December 31, 2024 through October 14, 2025, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.


