Notes to Financial Statements

Note 1: Description of Plan

The following description of the We Care Senior Care, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of WCSC Holdings, LLC (the "Company") who are at least 21 years of age. Employees are immediately eligible for Company contributions upon meeting the age requirement for elective participant contributions. The Plan's entry dates are January 1, April 1, July 1, and October 1 of each year upon meeting the age requirement for elective participant contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Officers of the Company are responsible for the administration of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Participants may elect to contribute to the Plan up to 100% of pretax annual eligible compensation. The Plan also allows for Roth contributions. Contributions cannot exceed the maximum amount allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from other qualified plans. Rollover contributions are not matched. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides a safe-harbor matching contribution equal to 100% of the participant's elective deferrals up to 4% of the participant's compensation. The Company may also provide a discretionary qualified nonelective contribution ("QNEC") to eligible nonhighly compensated employees, as defined by the plan document.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe-harbor matching contributions, and allocations of (a) the Company's discretionary QNEC contribution and (b) plan earnings and losses. Participant accounts are reduced by withdrawals and charged with an allocation of expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings thereon.

Note 1: Description of Plan (Continued)

Payment of Benefits

Plan benefits are available upon normal retirement (age 60), disability retirement, death, or termination of employment with vested interests. Benefit payments are in the form of a lump-sum distribution or installments. Hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing laws for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Principle areas of the act address participant saving assistance, required minimum distributions (RMD), catch-up contributions, and lost participants. There are provisions which are currently part of the plan design, including the provisions designed to assist with participant savings and the RMD provisions required for 2023 which have already been adopted by the Plan. All provisions of SECURE 2.0 will be evaluated and implemented in accordance with future regulations and guidance, and the Plan will be amended as needed.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: Summary of Significant Accounting Policies (Continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Advisory Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment advisory fees paid directly by the Plan are allocated proportionately to the plan participants based on their respective account balances and are included in net investment income on the accompanying statement of changes in net assets available for benefits. Distribution fees are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common/collective trust funds: Valued at the net asset value ("NAV") of units of a bank common trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The NAV is based on the NAV of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions as to the redemption of these funds or unfunded commitments as of December 31, 2024 and 2023. The funds are able to be redeemed with written notice, on a daily basis.

Note 3: Fair Value Measurements (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: The majority of underlying security has observable Level 1 quoted pricing inputs. The pooled separate account has a readily determinable fair value that is quoted and available to current investors via Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company's ("Principal") website. Because the pooled separate account is valued similarly to mutual funds, it is considered a Level 1 investment.

Note 4: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodians of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6: Party-in-Interest Transactions

Certain plan investments are managed by Principal. Principal is a custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Principal by the Plan for administrative expenses totaled \$24,798 for the year ended December 31, 2024. Certain plan investments are managed by Global Retirement Partner, LLC, investment advisor of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Global Retirement Partner, LLC for investment advisory services were \$16,609 during 2024.

Note 7: Tax Status

The Plan has adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan document has been amended since receipt of the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
