Opinion

We have audited the accompanying financial statements of Southern Newspapers, Inc. NOTE A -- DESCRIPTION OF PLAN

The following description of the Southern Newspapers, Inc. Media Employees' Medical Plan Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan provides health, disability and death benefits covering all eligible employees of Southern Newspapers, Inc. and affiliated companies (Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides health benefits (including medical, hospital, surgical, emergency, mental and dental), disability benefits and death benefits to full-time employees of the Sponsor and to their beneficiaries and covered dependents.

Disability and death benefits are covered by group insurance policies with independent insurance carriers.

Eligibility - Employees are eligible to participate in the Plan if they are a regular full-time employee for at least 1 month and regularly scheduled to work a minimum of 30 hours per week. An employee's eligible dependents may also participate.

Contributions - The employers and employees make monthly contributions to the Plan to fund the Plan's benefits. The contribution rates are evaluated annually by the Plan's actuary, based upon claims experience, and adjusted when necessary. The Sponsor's policy is to contribute the amounts not to exceed maximum amounts allowed as a tax deduction by the Internal Revenue Code. Under present law, the Sponsor is not permitted to deduct amounts for future benefits to employees.

Plan termination - If the Plan is terminated, the rights of the Plan Participants are limited to expenses incurred before termination. The Employer intends to maintain this Plan indefinitely, however, it reserves the right at any time to amend, to discontinue its contributions and to suspend or terminate the Plan in whole or in part subject to the provisions set forth in ERISA. This includes amending the benefits under the Plan or the Trust agreement.

Date of Management's Review - Management has evaluated subsequent events through August 29, 2025, the date on which the financial statements were available to be issued.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Plan Benefits - Plan liabilities for health claims incurred but not reported as of December 31, 2024 and 2023, are estimated using claims payment experience during the fiscal year and any other matters that may affect the reasonableness of the estimated liability.

NOTE C -- REINSURANCE (Excess Risk Insurance)

The Plan purchased an excess risk insurance policy which limits the Plan's liability for claims for individuals and the Plan in excess of agreed upon limits. The individual excess risk level was \$125,000, with an additional aggregate specific deductible of \$350,000 for the policy periods ending September 30, 2024 and 2023, for all individual claims. The Plan's excess risk level had a minimum aggregate attachment point of \$2,435,750 and \$2,947,896 for the policy periods ending September 30, 2024 and 2023, respectively.

NOTE D -- PARTIES-IN-INTEREST AND PLAN EXPENSES

The Plan Sponsor may pay administrative and trust expenses in whole or in part. All expenses not paid by the Sponsor shall be paid by the Plan. Plan expenses paid by the Sponsor include audit fees and legal fees to Conner & Winters, which are not charged to the Plan, amounted to \$22,883 and \$27,405 for the years ended December 31, 2024 and 2023, respectively.

The Sponsor also pays the salaries of the benefits coordinator and other personnel who perform services for the Plan as part of their duties. These salaries and wages are not recorded as Plan expenses.

NOTE E -- ERISA BOND REQUIREMENTS

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the year or \$500,000. At December 31, 2024 and 2023, the Plan's sponsor maintained bond coverage in the amount of \$1,000,000.

NOTE F -- TAX STATUS

The trust established under the plan to hold the plan's assets obtained its latest determination letter on April 11, 1989, in which the Internal Revenue Service stated that the trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The trust has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Effective January 1, 2009, the Plan adopted guidance issued by the Financial Accounting Standards Board regarding accounting for uncertainty in income taxes. This guidance clarifies the accounting for income taxes by prescribing the minimum recognition threshold an income tax position is required to meet before being recognized in the financial statements and applies to all income tax positions. Each income tax position is assessed using a two-step process. A determination is first made as to whether it is more likely than not that the income tax position will be sustained, based upon technical merits, upon examination by the taxing authorities. If the income tax position is expected to meet the more likely than not criteria, the benefit recorded in the financial statements equals the largest amount that is greater than 50% likely to be realized upon its ultimate settlement.

The Plan is organized as a not-for-profit entity for federal income tax purposes. As a result there is no federal income tax liability. Therefore, no provision or liability for federal income taxes has been included in the financial statements. The federal income tax returns of the Plan for years 2020 through 2022 are subject to examination by the IRS, generally for three years after they were filed.

The income tax position taken by the Plan for any years open under various statutes of limitation is that the Plan continues to be exempt from federal income taxes by virtue of its not-for-profit entity status. Trustees believe this tax position meets the more-likely-than-not threshold and, accordingly, the tax benefit of this income tax position (no federal income tax expense or liability) has been recognized for the years ended December 31, 2024 and 2023. The Plan does not anticipate any changes in its positions in the next 12 months.
