In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedules Required by ERISA**

The supplemental schedules of assets (held at end of year) and delinquent participant contributions as of and for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of Business Wire 401(k) Savings Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan established in 1969 to provide benefits to eligible employees of Business Wire, Inc. (the “Company”). The plan administrator believes the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**B. Administration and Expenses**

An Administrative Committee manages the operation and administration of the Plan. The Company designated Ascensus Trust Company (“Ascensus”) to serve as directed trustee and third party administrator responsible for maintaining participant records. Effective January 1, 2025, the Company designated Schwab Retirement Plan Services, Inc. (“Schwab”) and Charles Schwab Trust Bank (“Charles Schwab Trust”) to serve as recordkeeper and trustee, respectively, of the Plan. Record keeping, administrative and investment management fees are paid by the Plan.

**C. Eligibility**

Employees are eligible to participate for purposes of salary deferrals and Company matching contributions on their date of hire. Any employee of the controlled group of companies of which Business Wire, Inc. is a member who is not an employee of Business Wire, Inc., any employee temporarily assigned to Business Wire, Inc., from any of its non-U.S. locations or non-U.S. entities, and interns are excluded from the Plan.

**D. Participant Contributions**

Participants may elect to contribute their pre-tax compensation and/or elect to make Roth after-tax contributions. Each participant’s pre-tax deferrals and Roth contributions are subject to applicable Code limits. Participants of age 50 and older may make additional catch-up contributions for 2024. The Plan provides an option to participants to auto-escalate their elective contribution percentages by 1% annually on January 1 of successive years to a maximum of 15% of compensation.

Participants may make rollover contributions of amounts received from other tax-qualified retirement plans subject to the approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s investment directions.

**E. Company Contributions**

The Company is allowed to make discretionary matching contributions as defined in the Plan and as approved by the Board of Directors. For the year ended December 31, 2024 the Company matched 30% of participant pay deferrals. The Plan also allows for employer

discretionary profit sharing contributions. For the year ended December 31, 2024 the Company made profit sharing contributions equal to 3.00% of each eligible participant's compensation.

**F. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Company contributions and an allocation of Plan earnings or losses and expenses. Plan assets are invested based on instructions received from participants. Contributions of participants who decline to make an investment election are invested in the Vanguard Target Retirement Fund appropriate for the individual's age and projected date of retirement.

**G. Vesting and Forfeitures**

Participants are immediately 100% vested in their accounts attributable to pay deferrals, rollovers and Company matching contributions. Participants vest at the rate of 20% annually in Company profit sharing contributions and become fully vested upon completion of five years of service. Forfeitures of terminated participants' non-vested accounts may be used to pay Plan administrative expenses, reduce Company contributions, or allocated as additional profit sharing contributions. During 2024, approximately \$230,000 of available forfeitures were used to fund Company contributions during 2024. The unapplied forfeitures balance was approximately \$68,000 and \$47,000 at December 31, 2024 and 2023, respectively.

**H. Notes Receivable from Participants**

The Plan allows a participant to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of his or her vested account balance. Principal and interest are paid ratably through payroll deductions. The plan administrator establishes the specific terms and conditions of participant loans. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 5.25% to 10.50%, with various maturities through November 2054. Notes are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**I. Payment of Benefits**

Normal retirement age under the Plan is age 65 and five years of service. Upon termination of service, death, disability or retirement, a participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits. A lump sum is the primary form of benefit. An annuity form of benefit is available for participant money purchase pension plan accounts that were merged into the Plan in a prior period. The accounts of terminated participants valued at \$5,000 or less may be distributed by the plan administrator subject to applicable provisions of the Code. Benefits are recorded when paid.

**J. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**B. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year. Mutual fund capital gains distributions are included in dividend income.

**C. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

**D. Risks and Uncertainties**

Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS**

Payments of direct and indirect administrative fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 4 - INCOME TAX STATUS**

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies as tax-exempt. The Company believes that the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets held at end of year, including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Ascensus, LLC as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the trustees of the Plan.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at the closing market prices for shares held by the Plan at year end. Cash include all monies held at banks in interest and non-interest bearing accounts. Cash is valued at fair value because of the short maturities of those financial instruments.

Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

**NOTE 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS**
