## Report of Independent Auditors

To the Administrator of Selendy Gay PLLC 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Selendy Gay PLLC 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the “financial statements”).

#### 1. Description of Plan

The following description of the Selendy Gay PLLC 401 (k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all eligible employees of Selendy Gay PLLC (formerly known as Selendy Gay Elsberg PLLC) (the “Plan Sponsor” or “Firm”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal” or the “Trustee”) serves as the trustee and recordkeeper of the Plan.

##### **Eligibility**

Employees are eligible to participate in the Plan on the first day of the month coinciding with or following the later of such employee’s date of hire and his or her attainment of age 21. A participant becomes eligible for elective deferral percentage discretionary employer contributions and safe harbor nonelective contributions when the participant attains age 21. A participant then becomes eligible for profit sharing contributions following the completion of 3 months of service. Effective January 1, 2023, participants become eligible for safe harbor contributions the first quarterly date coincident with or next following the completion of 3 months of service.

##### **Contributions**

Participants may elect to have tax-deferred savings and/or Roth 401 (k) contributions deducted for each pay period up to 100% of their compensation, subject to limitations as determined by the Internal Revenue Code. Participants may also rollover previous funds representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan provides for an automatic enrollment feature at a rate of 6% for participants without a deferral election in place unless they elect not to make elective deferral contributions. Pre-tax deferral rates for automatically enrolled participants are increased by 1% annually on January 1 each year until the participant’s pre-tax deferral rate reaches 10%.

The Firm makes a safe harbor nonelective contribution of 3% of total compensation for eligible participants. The Plan further allows for a discretionary matching contribution, at the Firm’s election. Discretionary matching contributions were not made in 2024. In addition, the Plan may make profit sharing contributions at its sole discretion. For the year ended December 31, 2024, the Plan made profit sharing contributions of \$1,161,027. Associates are not eligible for the profit sharing contribution.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Firm’s contributions and (b) Plan earnings. Each participant is charged with his or her withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

#### **Vesting**

Participants are immediately 100% vested in their elective deferral contributions, safe harbor nonelective contributions, and rollover contributions plus actual earnings thereon. The Plan's other contributions are subject to the following vesting schedule:

In addition, if a participant receives severance from employment as a result of death or disability or reaches normal retirement age (as of December 31, 2024), that participant will automatically become 100% vested.

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or rollover into another qualified retirement plan or leave as is until reaching normal retirement age. In addition to the above, if the vested account balance of his or her account does not exceed \$5,000, the participant will receive a distribution of his or her total vested account balance automatically. Participants are also entitled to receive a distribution upon the attainment of age 59.5 while employed.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. The terms of the loans may not exceed five years. As of December 31, 2024 and 2023, loans outstanding bear interest rates ranging from 5.25% to 10.50% with maturity dates ranging through 2028.

#### **Forfeitures**

Forfeitures of profit sharing contributions are used to pay Plan administrative expenses or reduce future employer contributions. Forfeitures of \$176,178 were used to reduce employer contributions and pay administrative expenses during 2024. Forfeiture account balances were \$240,788 and \$176,178 at December 31, 2024 and 2023, respectively.

#### **Administrative and Investment Management Expenses**

Loan origination fees associated with notes receivable and distribution charges are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Firm.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable From Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received primarily through payroll deductions and the notes are collateralized by the participants' account balances. Interest income is recorded on an accrual basis. If the participant loan still has an outstanding balance 90 days after its due date, the participant loan shall be in default. The participant loan balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

## **3. Fair Value Measurements**

Accounting Standards Codification Topic 820 ("ASC 820"), "Fair Value Measurements and Disclosures", establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

**Mutual Funds**

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. Information Certified and Provided by the Trustee**

In accordance with 29 CFR 2520.103-5 and 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Trustee has certified that the following information per the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 is complete and accurate: investments, at fair value; notes receivable from participants; investment income from interest and dividends and net appreciation in fair value of investments; and interest income on notes receivable from participants; which has been used to prepare the Plan's financial statements and notes.

#### **5. Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their discretionary employer contributions and earnings thereon.

#### **6. Tax Status**

The Internal Revenue Service has issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **7. Party-In-Interest Transactions**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan's payment of direct and indirect fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan. Notes receivable from participants also reflect party-in-interest transactions.

#### **8. Subsequent Events**

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued. No subsequent events have been identified that are required to be accounted for or disclosed.
