**Note 1. Description of Plan**

The following description of Micro Matic USA, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan established to provide employees of Micro Matic USA, Inc., (collectively referred to as the Company), with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

***Eligibility***

All employees of the Company, as defined, except for leased employees, employees under a collective bargaining agreement, and nonresident aliens, are eligible to participate in the Plan if they have attained the age of 18 and have completed six months of service as defined in the plan document. Eligible participants may enter the Plan on the first day of the month following the date eligibility requirements are met.

The Plan includes an automatic enrollment provision. Therefore, when an employee becomes eligible to be a participant in the Plan, the Company will automatically, on behalf of that participant, defer 3% of the participant's eligible compensation (as defined). In accordance with the automatic enrollment provision, the deferral rate will increase 1% annually up to a maximum of 10% of compensation for those participants who have been automatically enrolled. Participants may cancel, modify, or otherwise change any of the automatic elections.

Effective December 31, 2024, the assets of Taprite Inc. 401k Retirement Plan were legally assets of the Company. At December 31, 2024, the assets were not yet merged into the plan and have been recorded as receivable at year end.

***Participant Contributions***

Eligible participants may make voluntary contributions through salary reductions from 1% to 100% of their eligible annual pre-tax compensation, as defined by the Plan. The Plan allows participants to defer funds into a "Roth 401(k) deferral", which are subject to federal income taxes. These contributions, combined with pre-tax deferrals, are limited to the maximum amounts allowed under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional "catch up" contribution (\$7,500 in 2024). Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options including various mutual funds, pooled separate accounts and a guaranteed interest contract offered by the Plan.

***Employer Contributions***

The Plan includes a discretionary employer matching contribution. For 2024, the Company made a discretionary employer matching contribution of the lesser of 50% of either the employee's salary reductions or 50% of the first 5% of eligible compensation. The discretionary employer matching contributions will be made on behalf of all participants who had salary reductions during the plan year. Discretionary employer matching contributions totaled \$318,849 for the year ended December 31, 2024. The Company may also make discretionary profit sharing contributions. There were no discretionary profit sharing contributions made for the year ended December 31, 2024.

***Participants' Accounts***

Each participant's account is credited with their respective contribution and allocation of (a) employer contributions and (b) plan earnings or losses.

***Vesting***

Participants' voluntary contributions and any earnings thereon vest immediately. Participants vest in discretionary employer matching contributions and discretionary profit sharing contributions ratably over a five-year period. In the event of death, disability, or the attainment of early retirement age, participants' accounts become fully vested. The early retirement age is the attainment of age 55 and completion of the fifth anniversary of the participant's employment commencement date.

***Payment of Benefits***

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or other options as defined in the plan document. Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons (as defined) or after attaining the age of 59½. Distributions to participants are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and the interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the administrator may permit a longer repayment term. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

***Forfeitures***

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will serve to pay plan expenses and then may be applied to reduce future Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,976 and \$11,785, respectively, and are invested in the guaranteed interest account. Forfeitures and their earnings for the year ended December 31, 2024 totaled \$10,721 and amount withdrawn during the year ended December 31, 2024 is \$54,762. During the year ended December 31, 2024, administrative expenses of \$52,232 were paid from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed by the Plan.

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Plan investments are stated at fair value, except for the fully benefit-responsive investment contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 9 for disclosures on fair value measurements.

Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

***Administrative Expenses***

Administrative expenses of the Plan are paid by either the Company or the Plan, as provided in the plan document.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants in the subsequent plan year.

***Subsequent Events***

The Company has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, there was an amendment to the adoption agreement, reducing the service requirement for eligibility from 6 months to 1 month.

**Note 3. Financial Information Certified by the Plan's Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Trust Company (ETC) (trustee), a qualified institution, has certified the remaining investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Tax Status**

The Plan operates under a volume submitter plan which has received a favorable opinion letter, dated June 30, 2020, from the Internal Revenue Service, indicating that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Financial Accounting Standards Board has issued a standard regarding the accounting and recognition of income tax positions taken or expected to be taken by the Plan. The plan administrator assesses the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5. Related-Party Transactions**

Certain plan investments held are managed by Empower Annuity Insurance Company which serves as a record-keeper, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower for trustee, recordkeeping and administrative services amounted to approximately \$78,000 for the year ended December 31, 2024. Fees paid to the investment advisor, auditor, and third-party administrator also qualify as party-in-interest transactions. Total fees paid to the investment advisor, auditor, and third-party administrator were approximately \$62,000 for the year ended December 31, 2024.

**Note 6. Risks and Uncertainties**

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all accounts will be valued as of the termination date, participants will become 100% vested in their accounts and the account balances will be distributed in full to the participants.

**Note 8. Fully Benefit-Responsive Investment Contract**

The Plan holds an investment contract that meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact with plan participants is not probable.

**Note 9. Fair Value Measurements**

Accounting standards require that financial assets and liabilities, recognized or disclosed in financial statements on a recurring basis (at least annually), be measured at fair value. These standards define fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset and liability in an orderly transaction between market participants on the measurement date. These standards also establish a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. These standards describe three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities that are accessible at the measurement date
- Level 2** Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in markets that are not active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for the assets or liabilities
- Level 3** Unobservable inputs for the asset or liability that are significant to the fair value measurement. These inputs reflect the Plan's assumptions about the assumptions a market participant would use in pricing the asset or liability

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at its accumulated unit values which are based on the net asset values as reported by the custodian based upon the underlying assets, primarily equity and fixed income mutual funds, included in the pooled separate account. The underlying funds held by the Plan's pooled separate account are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
