Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following brief description of the Strategix Management, LLC Health & Welfare Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan provides health and other benefits to substantially all employees and eligible dependents of Strategix Management, LLC (the Company), who are employed for thirty or more hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust.

Benefits.

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Plan Contributions

Participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop loss insurance.

The Company pays a portion of the cost of medical, dental and vision coverage. Employees who elect coverage contribute an amount based on amounts set during annual open enrollment periods. Employees also contribute the full cost of elective benefits such as voluntary life, accident, and critical illness. Employee contributions are funded through payroll withholdings.

1. Description of the Plan (continued)

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Insured Benefits.

The Plan fully insures the dental and vision insurance, life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for all fully insured benefits are paid from the assets of the Company and are recorded in the Plan's financial statements.

Self-insured Benefits.

Medical and pharmacy benefits under the Plan are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Flexible Spending Account

The Plan also contains a flexible spending feature that enables participants to receive reimbursements for eligible medical expenses not otherwise reimbursable under any other health care coverage. Prior to the beginning of each plan year, participants may elect to designate a portion of their compensation to provide for health, dental, or dependent care benefits. Amounts designated to pay for basic health and medical coverage are excluded from the employee's taxable income. The balance in the flexible spending accounts totaled approximately \$710 and \$1,970, as of December 31, 2024, and 2023, respectively.

Stop-Loss Coverage

The Plan has entered into a stop-loss arrangement to limit exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums are paid from the assets of the Company and are recorded in the Plan's financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of the benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than the exclusive benefit of the Plan's participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on accrual method of accounting.

Investment Valuation and Income Recognition.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Benefits paid under the fully insured contracts are not paid by the Plan and are not included in the Plan's financial statements.

Claims Payable and Claims Incurred But Not Reported

Plan liabilities for claims payable and claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year-end. Plan liabilities for medical and pharmacy claims incurred but not reported are estimated based upon the weighted average of monthly claims and weighted average lag time for the claim to be processed and paid. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year-end and the Plan is obligated to pay for the care regardless of continued participation in the Plan. These claims incurred but not

reported are not recorded in the financial statements, as they are reported within Note 4 — Benefit Obligations.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Stop-Loss Insurance

Premiums for stop-loss insurance are included in the accompanying statement of changes. In certain circumstances, per the insurance contract, the insurance company will assume the claims management process for catastrophic claims. When this occurs, the insurance company deals directly with the healthcare providers and pays the adjudicated claims directly. Such amounts are not included in the financial statements because the Plan does not pay the claims initially and thus does not receive a stop-loss recovery.

Flexible Spending Accounts

Included in the accompanying statements of net assets are amounts available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023, totaling \$1,970 and \$710, respectively. Forfeited amounts were used by the Company to offset Company contributions in the year forfeited.

Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and other service providers. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Risk and Uncertainties

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least

reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

3. Fair Value Measurements

The Plan follows accounting standards which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety. There have been no changes in the techniques and inputs used to measure fair values at December 31, 2024.

Money market funds are valued at the daily closing price as reported by the fund.

4. Benefit Obligations

5. Income Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated September 25, 2023, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party Transactions

As noted in Notes 1 and 2, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

7. Subsequent Events

Management has evaluated all subsequent events through October 8, 2025, which represents the date the financial statements were available to be issued.
