## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Employees Profit Sharing Retirement Plan of Servco Pacific Inc. and Subsidiaries (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to financial statements – modified cash basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2 to the financial statements.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 to the financial statements, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. **(1) Description of Plan**

The following description of the Employees Profit Sharing Retirement Plan of Servco Pacific Inc. and Subsidiaries (the Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all eligible employees of Servco Pacific Inc. (the Company). The Plan was established effective October 31, 1951 and is subject to the provisions of the Internal Revenue Code (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Substantially all employees may participate in the Plan except for employees of Servco Australia Pty, Ltd.

***Plan Administration***

Fidelity Management Trust Company (the Trustee) is the trustee of the Plan and manages a trust fund for the Plan on behalf of the Company. The trust agreement provides that the Trustee also act as the investment manager for the trust fund and provide administrative services to the Plan.

***Eligibility***

Employees of the Company become eligible to participate in the Plan upon the employee's date of hire (or date of rehire). Employees become eligible to participate in the employer matching contribution portion of the Plan upon hire. Employees become eligible to participate in additional employer matching contributions after earning at least 1,000 hours of service and contributing at least 3% during the Plan year. Additionally, employees must be employed by the Company or a related employer on the last day of the contribution period to receive employer matching or additional employer matching contributions.

There are no age requirements for eligibility in the Plan.

***Contributions***

The Plan contains an automatic contribution arrangement; whereby eligible employees are automatically enrolled in the Plan, unless elected otherwise. Eligible employees are enrolled at a pre-tax contribution rate of 6% of eligible compensation per pay period.

Participants may elect to defer up to 100% of their eligible compensation and contribute up to the amounts prescribed under the IRC on a pre-tax basis. Unless elected otherwise, plan participants are subject to an automatic rate increase of 1% annually, until a deferral rate of 10% is reached.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for the Plan year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company matches 50% of elective deferrals up to 6% of eligible compensation. Employer matching contributions are subject to a true-up calculation as if the employer matching contributions were calculated on an annual basis.

The Company may make an additional employer matching contribution or a discretionary non-elective employer contribution on behalf of eligible participants. During the year ended December 31, 2024, the Company made an additional discretionary non-elective employer matching contribution of \$500,000.

***Participant Accounts***

Contributions are invested in participant-directed accounts, as determined by the Plan Administrative Committee (the Committee).

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's matching contributions, (b) the Company's additional matching and discretionary non-elective contributions, and (c) plan earnings or losses, net of administrative expenses. Allocations are based on the participant's years of service or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting of Benefits***

Participants are immediately vested in their elective deferrals and non-elective contributions plus actual earnings thereon. Vesting in employer matching contributions and additional employer matching contributions are based on years of continuous service. A participant is fully vested after completion of three years of service with at least 1,000 hours in each year, the attainment of normal retirement age of 65, or termination by death or permanent disability.

***Notes Receivable from Participants***

Participants may borrow from their plan accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at a reasonable rate of interest as determined based on prevailing interest rates. Principal and interest are generally paid ratably through semi-monthly payroll deductions not to exceed five years, unless loans were used to purchase or construct a primary residence in which case loan repayments may be extended. The interest rates of notes receivable from participants at December 31, 2024 range from 4.25% to 9.50%.

***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant or beneficiary has the option to receive the value of the participant's vested interest in his or her account in a lump sum or periodic installments, as defined in the Plan. Additionally, under certain circumstances, a participant is allowed to withdraw funds from the Plan while still employed.

***Forfeitures***

At December 31, 2024 and 2023, forfeiture balances amounted to approximately \$104,000 and \$74,000, respectively. Forfeited amounts of approximately \$102,000 and \$24,000 were used to pay employer contributions and administrative expenses, respectively, for the year ended December 31, 2024.

**(2) Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this method, additions to net assets available for benefits except for certain investment transactions and interest income on notes receivable from participants, are recognized when received rather than when earned, and deductions from net assets available for benefits are recognized when paid rather than incurred.

***Use of Estimates***

The preparation of the Plan's financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements, the changes in net assets available for benefits during the reporting period, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis and the statement of changes in net assets available for benefits – modified cash basis.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income, other than interest income on notes receivable from participants, and dividends are recorded as received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no significant elections to withdraw funds which remained unpaid.

***Administrative Expenses***

Certain expenses of the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from the financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Participant fees, fees related to the administration of notes receivable from participants, and special handling fees are charged directly to the participant's account and are included in administrative expenses.

The Plan’s independent auditors did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**(4) Fair Value Measurements**

The accounting guidance for fair value measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage* – The self-directed brokerage account consists primarily of mutual funds which are stated at fair value based on quoted market prices, which represent the NAV of units held by the Plan on the last trading day of the Plan year and cash equivalents that are valued at carrying amount which is equivalent to fair value due to the short-term nature of the fund. The investments held in the self-directed brokerage account are generally categorized as Level 1 in the fair value hierarchy.

*Common collective trust fund* – The Plan invests in the Galliard Retirement Income Fund, which is a common collective trust stable value fund that is composed of traditional investment contracts and security-backed contracts issued by third parties, which are intended to maintain a constant NAV while permitting participant-initiated benefit-responsive withdrawals for certain events. The underlying investments in the stable value fund qualify as fully benefit-responsive investment contracts. Fair value was estimated using the cost approach at the unit share value as determined by the stable value fund and is generally categorized as Level 2 in the fair value hierarchy.

The preceding measurements described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will be fully vested in their accounts and are entitled to the balances of their accounts.

**(6) Tax Status**

The Plan is based on the non-standardized pre-approved profit sharing plan sponsored by FMR LLC, an affiliate of the Trustee. The Internal Revenue Service (IRS) informed FMR LLC by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan upon which the Plan is based is designed in accordance with the provisions of the IRC. The Plan has been subsequently amended; however, in the opinion of the plan administrator, the Plan is currently being operated in compliance with the applicable requirements of the IRC and thus qualifies the Plan for tax exempt status.

The modified cash basis of accounting requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**(7) Related-Party Transactions**

Certain plan investments represent units of mutual funds managed by an affiliate of the Trustee. Any purchases and sales of these funds are performed on the open market at fair value. Fees paid by the Plan for trustee and recordkeeping services amounted to \$65,392 in 2024. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**(8) Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued, and determined there are no other items to disclose.
