**Note 1. Description of the Plan**

***General***

The following description of Charon Shared Services, LLC Welfare Benefits Trust (Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

The Plan is sponsored by Charon Shared Services, LLC (the Company). The Plan provides health benefits covering all employees of the Company, Lincoln Surgery Center, LLC, Nebraska Surgery Center, LLC, Physicians Surgical Services, LLC, Eye Surgical Associates, LLC, Physicians Surgical Services Impact, and Sutton Skin and Eye Clinic, P.C., who work at least 48 hours per pay period and to their covered dependents and beneficiaries. In addition, the Plan also covers all partners of Eye Surgical Associates, LLC. Coverage is effective on the first day of the month following 30 days of service after the date of hire. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

***Benefits***

The Plan provides health benefits (medical and prescription drugs). The Plan also provides continuation of health benefits to participants who no longer meet the eligibility criteria due to a reduction in employment hours or termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

***Self-Insured Benefits***

The Plan self-insures health benefits. The claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative services only (ASO) arrangement. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan's trust or the general assets of the Company. Despite the Plan's utilization of a third-party claim's processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

***Stop-Loss Coverage***

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured health benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

***Contributions***

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit election through payroll deductions. The Company makes contributions to the plan to fund premiums, administrative expense and claims in excess of participant contributions for self-funded benefits. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company through employer contributions on a pay-as-you-go basis.

***Plan Termination***

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants; to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants and their covered dependents. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States America requires management to makes estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims (IBNR), claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Payment of Benefits***

Premiums paid by either the Company or the Plan trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Payment of health benefits are provided by a third-party under an administrative service agreement. Claim payments are recorded when paid by the third-party claim's processor. Amounts due to the claims processor that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of Plan's benefit obligations. The third-party claims processor processes health benefits for participants, dependents and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan.

### ***Stop-Loss***

Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$2,517,101 and \$677,490, have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ending December 31, 2024 and 2023, respectively.

### ***Refunds***

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date, if any, have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$507,477 and \$264,628 have been netted with health claims paid directly to participants in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

### ***Administrative Expenses***

Substantially all costs of the plan administration, including miscellaneous, general and administrative expenses, are paid by the Plan. The Company provides certain administrative services at no cost to the Plan.

## **Note 3. Benefit Obligations**

The Plan's benefit obligations include the Plan's liability for claims payable and claims incurred but not reported for health benefits. The Plan's liabilities for claims incurred but not reported are estimated by the third-party administrator utilizing prior claims experience, past claims payment patterns, and employee demographics. The Plan is obligated to pay for the care of covered claims regardless of future participation in the Plan. The liability for claims payable is based on invoiced amounts.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Service Providers are parties in interest under ERISA. Funds in the amount of \$257,850 and \$242,275 for the years ended December 31, 2024 and 2023, respectively, were paid by the Plan to United Medical Resources (for the year ended December 31, 2024 only), Centivo T. Holdings, LLC and Express Scripts for administrative expenses.

The Company provides certain administrative services at no cost to the Plan.

**Note 6. Risk and Uncertainties**

The Plan's benefit obligations are reported based on certain assumptions related to prior claims experience, past claims payment patterns and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 7. Plan Tax Status**

The Charon Shared Services, LLC Welfare Benefits Trust was established January 1, 2020, to provide health benefits to eligible employees. The Plan includes a Welfare Benefit Trust. The trust was not established as a tax-exempt trust. Federal and State income taxes were not significant in 2024 and 2023. The Plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Subsequent Events**

Effective January 1, 2025, the Company's vendor for pharmacy claims became Medimpact.

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.


