Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pharmaceutical Research and Manufacturers of America Deferred Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of Plan

The following brief description of Pharmaceutical Research and Manufacturers of America Deferred Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Pharmaceutical Research and Manufacturers of America (PhRMA or the Plan Sponsor) under the provision of Section 401(k) of the Internal Revenue Code (the IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). All PhRMA employees regularly employed on a salaried basis are eligible to participate in the Plan as of their date of hire. The Finance and Audit Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Administration of the Plan

During 2022, and through March 31 2023, Prudential Bank & Trust, F.S.B. was the trustee of the Plan (Trustee or Prudential). On April 1, 2022, Empower Annuity Insurance Company of America (EAICA), formerly known as Great-West Life & Annuity Insurance Company, the parent company of Empower Retirement, LLC (Empower) acquired the full-service retirement business of Prudential Financial, Inc. In connection with the transaction, EAICA acquired all shares of Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, FSB. On October 3, 2022, Prudential Retirement Insurance and Annuity Company was renamed Empower Annuity Insurance Company of America. Empower Trust Company, LLC was the trustee of the Plan from April 1, 2023 through June 30, 2023. Empower held all assets of the Plan in accordance with the provisions of the trust agreement and annuity contract during these periods.

Effective July 1, 2023, Principal Life Insurance Company, a member of the Principal Financial Group, was engaged to provide recordkeeping services to the Plan, and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, a member of the Principal Financial Group (Principal), became the trustee and custodian replacing Empower.

The Plan administrator and Plan Sponsor is PhRMA. The Finance and Audit Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Contributions

PhRMA employees electing to participate in the Plan make contributions to the Plan via payroll deductions. Each active participant may contribute up to the lesser of the statutory legal limit or 100% of pre-tax compensation for the contribution period. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan also includes an auto-escalation provision whereby participants are subject to an annual automatic deferral rate increase of 1% until their deferral rate reaches 12% of eligible compensation. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time.

PhRMA will make the following employer contributions on behalf of its participants:

- A safe harbor, non-elective contribution equal to 3% of each participant's compensation.
- An age-based non-elective contribution equal to the following amounts:
 - Under age 35 during the plan year: 2% of each such participant's compensation for the Plan year
 - Between ages 35 and 44 during the plan year: 3% of each such participant's compensation for the Plan year
 - Age 45 and older during the plan year: 4% of each such participant's compensation for the Plan year
- For each calendar year beginning in 2014 and ending in 2023, PhRMA made an additional employer contribution (the transition contribution) for each participant who was an employee on December 31, 2013. The transition contribution to each participant was equal to 1% of the participant's compensation for the Plan year.
- A matching contribution equal to 50% of the pre-tax elective contributions or Roth elective contributions was made on behalf of each participant that did not exceed 6% of the participant's compensation for the Plan year.
- PhRMA may make additional discretionary contributions for participants from time to time. PhRMA did not make a discretionary contribution in 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (the IRS) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

A separate account is established and maintained in the name of each participant and reflects the participant's and employer's contributions invested in, and the earnings and losses attributable to, each investment fund. Participants' account balances are invested in one or more of the investment options based on instructions from each participant. The participant may transfer his or her investments from any investment fund to another fund at any time. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Participants may also withdrawal an amount at age 59½ if certain criteria are met.

Vesting

Participants are immediately fully vested in their voluntary contributions, all employer contributions, and actual earnings thereon.

Forfeitures

Forfeitures are used to reduce future employer contributions or to pay any administrative expenses at the discretion of the Plan Sponsor. Forfeited non-vested accounts totaled \$27,184 and \$40,831 as of December 31, 2024 and 2023, respectively. During 2024, forfeitures totaling \$14,516 were used to offset administrative expenses. During 2023, forfeitures totaling \$49,910 were used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their vested accounts an amount that may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Finance and Audit Committee. The notes are to be repaid by salary deductions over periods no longer than five years or over a reasonable period of time for the purchase of a participant's primary residence, not to exceed thirty years. Each participant may not have more than one note receivable outstanding at any time. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimated amounts.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's investment in fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance and Audit Committee determines the Plan's valuation policies utilizing information provided by the trustees. See Note 5 for additional information related to fair value measurements.

The Plan's fully benefit-responsive investment contracts (Note 7) are valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan.

Contributions

Contributions from Plan participants and employer contributions from the Plan Sponsor are recorded in the year in which the contributions are earned. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued. There were no events noted that required adjustment to or disclosure in these financial statements.

3. Plan Termination

Although it has not expressed any intent to do so, PhRMA as the Plan Administrator, has the right to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA by resolution of the board of directors. Upon termination of the Plan, after payment of all expenses and proportional adjustment of accounts of participants to reflect such expenses, investment profits or losses, and allocations of any previously unallocated funds to the date of termination, the participants, participants with rollover amounts, or their beneficiaries shall be entitled to receive the amounts then credited to their respective accounts in the Plan.

4. Income Tax Status

The IRS has determined and informed PhRMA by a letter dated September 18, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

GAAP requires Plan management evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; there are currently no audits for any tax periods in progress.

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under FASB ASC 820 are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, and for period from July 1, 2023 through December 31, 2023, were obtained by management and agreed to or derived from information certified as complete and accurate by Principal.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 through March 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Prudential Bank & Trust, FSB, a qualified institution. For the period from April 1, 2023 through June 30, 2023, this information was certified by Empower Trust Company, LLC, a qualified institution.

7. Fully Benefit-Responsive Investment Contracts

The Plan has traditional, fully benefit-responsive guaranteed investment contracts (GIC) with Principal and EAICA that are reported at contract value of \$4,476,186 and \$8,359,334 at December 31, 2024 and 2023, respectively. Principal and EAICA maintain the contributions in a general account. The accounts are credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contracts cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

In May 2023, EAIC conveyed its decision to enforce a put on the Prudential Retirement Institutional GIC (Prudential GIC) prior to the transition of recordkeeping services. The disbursement and transfer of funds in the Prudential GIC are scheduled to take place over a two-year period with the final disbursement occurring in May, 2025.

8. Related Party and Party-In-Interest Transactions

Certain investments are in mutual funds, and an investment contract managed by affiliates of EAICA and Principal which act as the trustees for the Plan and maintain participant accounts. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transactions rules of ERISA. Administrative fees paid by the Plan directly to EAICA, Principal and other service providers totaled \$900 and \$1,805 for the years ended December 31, 2024 and 2023, respectively. The Plan has a revenue sharing agreement and proceeds of \$37,686 and \$23,079 from that arrangement during the years ended December 31, 2024 and 2023, respectively, are netted with administrative expenses in the statements of changes in net assets available for benefits. The Plan Sponsor also paid certain administrative expenses of the Plan.
