Schedule SB, Part V - Summary of Actuarial Assumption/ Methods

The valuation of a defined benefit pension plan involves estimates and assumptions about the probability of events occurring far into the future. Examples include assumptions about future employment, mortality, and retirement. Below is a description of the actuarial assumptions and methods used in the valuation.

Actuarial Cost Methods

Funding Target Liability: As required by PPA, the Traditional Unit Credit Cost Method is used.

Actuarial Value of Assets: Market Value, as provided by the Trustee.

Funding Target Liability

Valuation Date: December 31, 2024

Demographic Information: The demographic information was provided as of December 31, 2024 by Comas & Revuelta, LLC. Although we did not audit the data, we did review the data for reasonableness.

Actuarial Valuation Software: For purposes of developing the projected future benefit payments as well as determining attributed liabilities and normal costs as of the valuation date, we utilized the ASC software platform developed by Actuarial Systems Corporation. We believe this externally developed valuation system is appropriate, was used for its intended purpose, and did not produce unreasonable results.

Interest Rates for Minimum Required Contribution and Maximum Alternative Contribution: The adjusted 24-month average December 2024 funding segment rates using 25-year average segment rate corridors were utilized as prescribed by 29 US Code Section 1083, after reflection of interest rate stabilization provisions included in various legislation.

Segment 1 is applied to benefit payments expected to be made in the first 5 years, segment 2 is applied to benefit payments expected to be made in the next 15 years and segment 3 is applied thereafter.

Effective Interest Rate: 5.14%

Interest Rates for determining the Low-Default Risk Obligation Measure (LDROM) Liability: The December 2024 funding segment rates were utilized as prescribed by IRC Section 430(h), without reflection of the interest rate stabilization provisions included in various legislation. These rates were utilized to determine the LDROM calculations for annuities and lump sums. Please note that the LDROM liability could be determined using other rates which could result in a higher or lower liability for such purpose.

Retirement Rates: Employees were assumed to retire at normal retirement age (age 65).

Post-retirement Mortality: The base mortality tables are the blended sex distinct Pri-2012 mortality tables. The base mortality table is adjusted as described in Internal Revenue Regulation 1.430(h)(3)-1(c)(2) by projecting mortality improvements using the 2024 Adjusted Scale MP-2021 Rates from the year 2012 through 2024, with an additional projection period of 8 years for males and 9 years for females. For ages below 80, the additional projection period is increased by 1 year for each year below age 80. For ages above 80, the additional projection period is reduced (but not below zero) by 1/3 year for each year above 80.

Administrative Expenses: Actual plan expenses, not including investment advisory fees, paid out of the trust during the plan year - \$0.

Form of Benefit: 100% of active participants are assumed to receive a deferred lump sum distribution at their assumed retirement age. 100% of terminated vested participants are assumed to receive an immediate lump sum distribution.

Eligibility for Participation:

21 years old, and completed one Year of Eligibility Service. All eligible employees employed on January 1, 2021 shall become eligible to participate in the plan as of January 1, 2021. No Employee shall participate in the Plan while he is considered Employees who are not owners.

Normal Retirement Age:

The 65th anniversary of his birth.

Early Retirement:

N/A

Compensation:

Total salary, including overtime, bonuses, commissions and incentives compensation.

Years of Service:

Whole and fractional years of employment.

Accrued Benefit:

A single life Annuity which is the actuarial equivalent of the participant's Cash Balance Account projected to Normal Retirement Age at 5.00%.

Cash Balance Account:

The account established for each participant to receive Principal Credits and Interest Credits.

COMAS & REVUELTA CASH BALANCE PLAN

Interest Credits:

The interest that is credited to a participant's Cash Balance Account on the last day of the Plan Year, based on fixed interest crediting rate of 6.00%.

Principal Credits:

A credit depending on membership in an allocation group. The groups and the credits are:

Group	Members	Credit
Group A	All Company Owners	45% of compensation
Group B	All Other Employees	0% of compensation

1,000 hours of service is required to receive a credit for a year.

Vesting on Termination of Employment:

100% vesting upon the completion of 3 years of service.

Normal Form of Benefit:

A single life Annuity which is the actuarial equivalent of the participant's Cash Balance Account based on all Employer Credits and Interest Credits through the determination date.

Optional Form of Benefit:

All of the following option forms are computed to be the actuarial equivalent of a straight life annuity:

1. Life annuity
2. Certain and life (5 years)
3. Joint and survivor Option, with 50%, 75% or 100% of the reduced pension continuing to the surviving spouse or the lineal descendant for life upon the death of the participant.
4. Lump sum

Death Benefit:

Beneficiary shall receive a death benefit which is the Actuarial Equivalent of his Accrued Benefit, computed as of the date of his death.

Employee Contribution: None

Employer Contributions: Entire cost of the plan
