Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ohana Pacific Management Company Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

1. Description of Plan

The following description of the Ohana Pacific Management Company Retirement Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution retirement plan, which covers substantially all employees of Ohana Pacific Management Company, Inc. (Company), Ohana Pacific Foundation, Hale Kupuna Heritage Home, LLC, Integrated Health Resources, LLC, Garden Isle Healthcare, LLC, Ann Pearl Care Home, Inc., Liliha Kupuna SNF, LLC, Stay at Home HealthCare Services, LLC, Hilo SNF, LLC, Liliha Kupuna ALF, LLC, Prime Care Services Hawaii, Inc. and Kalele Care Services, LLC that meet the Plan's eligibility requirements.

The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Talcott Resolution Life Insurance Company (Talcott) and Empower Trust Company, LLC (ETC) are the trustees and custodians of the Plan. Talcott and ETC are affiliates.

b. Eligibility

All employees who have earned one year of service, are at least twenty-one years of age, and have worked at least 1,000 hours of services within a twelve month consecutive period, are eligible to participate.

c. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan, up to the permissible 401(k) limit as defined by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additional matching contributions, profit sharing amounts, or qualified non-elective contributions may be contributed at the option of the Company's board of directors. The Company did not make any contributions to the Plan for the year ended December 31, 2024.

1. Description of Plan (continued)

d. Participants' Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, if any, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon as well as in contributions from rollovers and qualified non-elective employer contributions. Vesting in the Company's matching, profit-sharing and qualified non-elective contributions, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of service. A participant also would automatically become fully vested upon attaining normal retirement age, as defined by the Plan, or total and permanent disability or death.

f. Payment of Benefits

Upon termination of service due to death, disability or retirement, if a participant's vested account balance is greater than \$1,000, the participant may elect to maintain the vested portion of their account in any of the available funds offered through the Plan, receive a lump-sum distribution of the vested amount, receive periodic installments over a fixed period, or transfer the account balance to another plan. Certain participant balances are also eligible for distribution as a qualified joint and survivor annuity. If a participant's vested account balance is \$1,000 or less, the participant will receive a lump-sum distribution. If a participant does not make a timely election and distribution amount is more than \$1,000 but less than \$5,000, the participant will receive notification and an automatic rollover to an individual retirement account.

g. Forfeitures Accounts

Forfeitures are the non-vested amounts in the accounts of participants who terminate employment. Plan forfeitures are to be used to reduce administrative expenses incurred by the Plan or future employer contributions. There were no unallocated forfeiture account balances as of December 31, 2024 and 2023.

h. Notes Receivable from Participants

Participants are allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are made through the custodian of the Plan, are secured by the balance in the participant's account, bear interest at a rate of 4.25 percent to 9.50 percent, and are generally due within 5 years (15 years for the purchase of a primary residence). The loans mature at various dates through February 2036 or on the date of termination of the participant's Plan interest, if sooner. Principal and interest are paid ratably through payroll deductions, and interest is recognized using the interest method.

i. Administration

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America U.S. GAAP.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Summary of Significant Accounting Policies (continued)

b. Management's Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan.

e. Contributions Receivable

Contributions receivable are recognized for amounts due from the employer remitted to ETC after year-end.

f. Benefits

Benefits are recorded when paid.

g. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

h. Subsequent Events

The Plan management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued, and it was determined that all subsequent events had been properly accounted for.

3. Information Certified by Trustees

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-related supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by Talcott and ETC, qualified institutions. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

4. Fair Value Measurements

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under U.S. GAAP are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

At December 31, 2024 and 2023, the Plan's investments consisted of investments in variable annuity contracts of \$10,581,490 and \$8,881,263, respectively, which were valued using Level 2 measurements using the shares held by the Plan and the quoted net asset value of the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract.

There were no changes in the methodologies used as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Group Annuity Contract

The Plan invests in an unallocated, fixed income group annuity contract with Talcott. This investment provides for a guaranteed crediting rate. Guarantees are based on the claims paying ability of Talcott and not the value of the securities within the insurer's general account. The credit rating of the issuer at December 31, 2024 was BBB+ as reported by Standard and Poor's. Deposits made to the fixed account are deposited in Talcott's general account. Payment obligations under the fixed account represent an insurance claim supported by all the general account assets.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Talcott, represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

5. Group Annuity Contract (continued)

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

As of December 31, 2024 and 2023, the investment amounted to \$716,857 and \$484,918, respectively.

6. Tax Status

The Plan has adopted a non-standardized pre-approved plan that received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the non-standardized pre-approved plan's qualified status. The non-standardized pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the non-standardized pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Administrative errors, if any, which are insignificant or operational in nature are handled by the Plan Administrator in accordance with applicable IRS correction policies. Plan years from December 31, 2021 are open for examination for federal tax purposes.

7. Plan Termination

Although it has not been expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would be 100% vested in employer contributions.

8. Exempt Party-in-Interest Transactions

The Plan investments include a group annuity contract managed by Talcott. These transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.
