## Independent Auditor's Report

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We were engaged to perform audits of the financial statements of Calvin University 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Disclaimer of Opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

As described in Note 3, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The Plan has not maintained sufficient accounting records and supporting documents relating to these annuity and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficiently to determine the extent to which the financial statements may have been affected by these conditions.

***Emphasis of Matter***

As explained in Note 6, the financial statements include investments valued at approximately \$44.5 million (19 percent of net assets) at December 31, 2024 and \$48.2 million (22 percent of net assets) at December 31, 2023, whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by TIAA-CREF. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

***Auditor's Responsibilities for the Audits of the Financial Statements***

Our responsibility is to conduct the audits of Calvin University 403(b) Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

***Supplemental Schedule Required by ERISA***

The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

### Note 1 - Plan Description

The following description of Calvin University 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Calvin University (the "University") except for leased employees, independent contractors, and students performing services for the University. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides employees the opportunity to contribute a portion of their compensation as a pretax deferral subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants are eligible to contribute immediately upon hire unless they are considered an excluded employee. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

For participants who have attained the age of 25, the University contributes 6 percent of base compensation, as defined in the plan document. The Plan has met the ERISA minimum funding requirements. During the period from July 1, 2020 to June 30, 2021, the Plan was amended where the University's retirement contributions were 2.5 percent for faculty and 4 percent for other staff. On September 13, 2024, the Plan was amended to no longer require the participant to be age 25 or older to be eligible for retirement contributions.

For participants who have attained the age of 25 and who have completed one year of service, the University makes matching contributions at 100 percent of elective contributions, with a maximum contribution equal to 2 percent of a participant's compensation earned. The Plan was amended September 13, 2024 to no longer require the participant to be age 25 or older to be eligible for matching contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the University's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Participant Notes Receivable**

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

#### **Vesting**

Participants' contributions, the employer contributions, and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### **Benefit Payments**

Distributions of a participant's elective deferrals and any employer contributions are payable upon retirement, death, disability, or termination of employment. Participants' elective deferrals may also be distributed on account of hardship. Distributions may be received in the form of a lump sum or annuity amount. Certain amounts invested in the TIAA Traditional Annuity group annuity contract may not be distributed in a lump sum (see redemption restrictions).

### Note 1 - Plan Description (Continued)

#### ***Redemption Restrictions***

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participants to transfer or withdraw from the fund. Transfers from the Retirement Annuity (RA) and Transfer Payout Annuity (TPA) contracts must be paid out in 10 annual installments. Withdrawals from the RA contract must be paid out in 10 annual installments. Withdrawals from the Retirement Choice (RC) contract are available within 120 days after termination of employment subject to a 2.5 percent surrender charge. Transfers from the RC contract must be paid over 84 monthly systematic payments. The Interest Payment (IP) contract is the contract used when a participant has elected to receive interest-only payments from the RA contract. If the participant chooses to withdraw or transfer from the contract, the IP contract would be subject to the original contract restrictions. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals. The TIAA Stable Value investment is immediately liquid to participants and does not have participant-level withdrawal restrictions. However, there are equity wash provisions that prevent the immediate transfer of amounts to any competing funds available in the Plan.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF); TIAA Trust, N.A.; Fidelity Management Trust Company (Fidelity); Newport Trust Company, LLC (Newport); and The Lincoln National Life Insurance Company (Lincoln) or their affiliates.

TIAA-CREF is a service provider of the Plan, and TIAA Trust, N.A.; Fidelity; Newport; and Lincoln are custodians of the Plan. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Plan Loans***

Effective January 1, 2021, TIAA ceased issuance of any new policy loans. Existing policy loans will continue to be in effect. Prior to June 11, 2020, participants could borrow from TIAA using their Traditional Annuity account balances as collateral for the loan. Participants may still borrow from Lincoln using their Lincoln Fixed Account balances as collateral for the loan. Collateral is required in an amount equal to 110 percent of the outstanding loan balance. Participants could borrow up to a maximum equal to the lesser of \$50,000 or 45 percent of their TIAA Traditional Annuity balances and a maximum equal to the lesser of \$50,000 or 50 percent of their Lincoln Fixed Account balances subject to annuity contract and plan provisions. Loan terms range from 1 to 5 years or up to 10 years for the purchase of the participant's primary residence. Loans bear interest at market rates. Principal and interest are paid ratably by the participant's TIAA Traditional Annuity or Lincoln Fixed Account. The amount of these outstanding loans was \$0 and \$182,738 at December 31, 2024 and 2023, respectively. These loans are not included as assets in the accompanying financial statements.

#### ***Termination***

While it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income***

The Plan's investments are stated at fair value.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

The registered investment companies are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. The pooled separate account is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets, which consist primarily of rental property subject to long-term leases, and has been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. There are no redemption restrictions or unfunded commitments on these investments. See Note 7 for additional information.

The TIAA Traditional Annuity is a guaranteed annuity account issued by TIAA that invests in the general assets of TIAA. TIAA considers the following contracts to be benefit responsive: Supplemental Retirement Annuity (SRA), Group Supplemental Retirement Annuity (GSRA), and Retirement Choice Plus (RCP). TIAA considers the following contracts to be non-benefit responsive: Retirement Annuity, Interest Payment, Retirement Choice, and Transfer Payout Annuity. The non-benefit-responsive portion of the contract is valued at fair value. The benefit-responsive portion is recorded at contract value. Since there are no specific securities in TIAA's general account related to these contracts, and due to the contract terms, including the frequency of the interest rate reset intervals, contract value is the best estimate of fair value for the non-benefit-responsive contracts. For all portions, contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The TIAA Stable Value is a group annuity contract issued by TIAA that invests in a nonunitized separate account of TIAA. The TIAA Stable Value is considered benefit responsive and is presented at contract value. Contract value represents principal invested, plus interest earned, less any withdrawals and fees.

The Fixed Account is a group annuity contract with Lincoln that invests in the general assets of Lincoln. Lincoln considers this contract to be benefit responsive, and it is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid. There were benefit payments requested but not paid (due to redemption restrictions) totaling \$6,405,603 and \$5,612,003 for the years ended December 31, 2024 and 2023, respectively.

***Administrative Expenses***

Various administrative costs are paid by the University.

***Allocated Insurance Contracts***

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and additional contracts have been purchased. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 7, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Excluded Investments**

The Plan has excluded from investments in the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023 certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

**Note 4 - Certified Information**

TIAA-CREF; TIAA Trust, N.A.; Fidelity; Newport; and Lincoln hold certain investments and execute related investment transactions (see Note 3). TIAA has the authority to certify the investment balances and related investment activity on behalf of TIAA Trust, N.A. Additionally, Ascensus, LLC (Ascensus) has the authority to certify the investment balances and related investment activity on behalf of Newport Trust Company, LLC. The investment balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by TIAA-CREF; TIAA, as agent for TIAA Trust, N.A.; Fidelity; Ascensus, as agent for Newport Trust Company, LLC; and Lincoln.

**Note 5 - Tax Status**

The plan administrator has not yet applied for a determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of Internal Revenue Code Section 403(b). Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 6 - Annuity Contracts**

Based on the terms of the contracts, a portion of the TIAA Traditional Annuity and TIAA Stable Value is considered benefit responsive. The total balance in the TIAA Traditional Annuity was \$55,084,289 and \$47,777,137 at December 31, 2024 and 2023, respectively. The benefit-responsive portion of the TIAA Traditional Annuity totaled \$14,988,370 and \$6,559,837 at December 31, 2024 and 2023, respectively. The contract issuers maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintage approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, the rate is between 1.00 and 3.00 percent.

The Plan also has a benefit-responsive investment contract with Lincoln. The benefit-responsive portion totaled \$264,502 and \$461,309 at December 31, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting. When establishing interest crediting rates for this product, Lincoln considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The minimum crediting rate under the contract is 1.75 percent.

For both contracts, generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

**Note 7 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 7 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset. The Plan has no assets measured using Level 3 inputs.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan has excluded certain assets from the statement of net assets available for benefits at December 31, 2024 and 2023 (see Note 3). The following tables present information about the included plan assets measured at fair value on a recurring basis at December 31, 2024 and 2023:
