## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Jarmoc Tobacco 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1: Description of Plan

The following brief description of the Jarmoc Tobacco 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan established effective January 1, 2023, and recently amended effective May 31, 2023 to bring all eligible employees employed on that date automatically in the Plan on that date, without regard to minimum age or service requirement. The Plan covers substantially all employees of Jarmoc Tobacco, LLC (the "Company") and CT Valley Transportation LLC, a related company under common ownership that participates in the Plan pursuant to the plan's multiple employer provisions. Both entities are collectively referred to as the "the Company" for purposes of this report. The Plan's Trustee oversees the governance of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Payment of Benefits and Distributions:**

On termination of employment due to death, disability, retirement, or for any other reason, or on reaching the age of 59 ½ years, a participant or their beneficiaries, as applicable, may elect to receive their account balance in a lump sum, partial withdrawals, or installment payments as permitted under the Plan. If the participant's account balance is \$5,000 or less at the time of termination or retirement, then their account balance will be (1) distributed as a lump sum payment if \$1,000 or less or (2) automatically rolled over to an IRA set up for the participant by the Plan if more than \$1,000 and not greater than \$5,000. Benefits are recorded when paid.

**Eligibility and Contributions:**

All employees of the Company who complete 500 hours in the first 6 months, or complete 1,000 hours in a plan year are eligible for the Plan. Entry is effective the first day of the month coinciding with or following eligibility. All contributions are made by the employees, who may defer up to 100% of their salary up to the maximum limits, as defined by the Plan and allowed by law. Additionally, participants who are fifty (50) years of age are permitted to make additional catch-up contributions as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans. Employees are vested 100% on these contributions. In the event an employee dies, the full value of the account will be paid to their beneficiary.

Eligible participants who make elective deferrals under the Plan are entitled to receive safe harbor contributions and discretionary employer matching contributions. The Company provides a safe harbor matching contribution equal to 100% of the first 3% of compensation deferred by each participant plus 50% of the next 2% of compensation deferred. Participants who contribute at least 5% of compensation therefore receive a total employer match equal to 4% of eligible compensation. The Plan also permits the Company to make discretionary matching contributions in addition to the safe harbor formula. Such discretionary amounts, if made, are allocated to participants based on the same definition of eligible compensation. The Company safe harbor contributions were \$181,871 and \$111,083 for the years ended December 31, 2024 and 2023, respectively.

**Vesting:**

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

Note 1: Description of Plan (continued)

Participant Accounts:

Each participant's account is credited with the participant's contributions, as well as allocations of the Company's contribution and Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 2: Summary of Significant Accounting Policies

Accounting Method:

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments:

All Plan investments are stated at fair values. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses:

Administrative costs for the day-to-day operation of the Plan are covered, in whole or in part, by the investment fees that are deducted directly from investment returns. Any remaining day-to-day costs, as well as costs for certain other administrative services, are typically paid by the Company and excluded from these financial statements.

Tax Status:

The Plan is intended to be a tax exempt "qualified" plan under the Internal Revenue Code and it is therefore exempt from federal income taxes under provisions of Section 501. The Plan was established using a pre-approved plan document sponsored by Definiti LLC. The IRS has issued an opinion letter to Definiti LLC dated June 30, 2020, stating that the form of the pre-approved plan satisfies the applicable qualification requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken certain positions that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income examination from the inception of the Plan.

Contributions:

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation.

**Use of Estimates, Economic Dependency, and Concentrations:**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

The Plan is economically dependent on contributions from the Company and Plan participants.

**Subsequent Events:**

The Company has evaluated subsequent events through October 8, 2025, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements.

Note 3: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions to ERISA.

Note 4: Risks and Uncertainties

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

Note 5: Transactions with Parties in Interest and Related Parties:

Jarmoc Tobacco, LLC provides to the Plan certain accounting and administrative services for which no fees are charged. Other fees paid during the year for administrative services rendered by parties in interest were based on customary and reasonable rates for such services. The Plan's recordkeeper, Empower Annuity Ins Co of America, received direct compensation of \$6,670 and \$1,390 for the years ended December 31, 2024 and 2023, respectively. In addition, the Plan utilizes Definiti, LLC for contract administration who received direct compensation of \$963 and \$0 for the years ended December 31, 2024 and 2023, respectively.

Note 6: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology include unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in active markets;

Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology include prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies or inputs used at December 31, 2024.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the net asset values of shares held by the Plan at year-end, which are determined using quoted prices in active markets. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value common/collective trust (CCT):* A CCT is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank CCT. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the CCT, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
