Opinion

NOTE 1 – PLAN DESCRIPTION

The following brief description of the River Barrel Brewing, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of River Barrel Brewing, Inc. and related entities Pilot House Distilling, Inc. and River Barrel Distributing, LLC (collectively, "the Company"), who meet the eligibility requirements. Employees are generally eligible to participate in the Plan after completing two consecutive months of service and attaining 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Transfer to Standard Pooled Employer Plan - Effective April 30, 2024, the Plan was merged into the Standard Pooled Employer Plan ("Standard Plan"). As a result, on April 30, 2024, the investments of the Plan, in the amount of \$1,464,850, became assets of the Standard Plan. All River Barrel Brewing, Inc. 401(k) Profit Sharing Plan and Trust assets were transferred into the custodial accounts of the Standard Plan on June 18, 2024.

Contributions - Contributions consist of employee pre-tax and Roth elective deferrals, employer matching contributions, and discretionary employer profit sharing contributions. Employee elective deferrals and the employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Employees may voluntarily contribute up to 92% of their compensation, not to exceed the maximum annual limits of \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make an additional \$7,500 catch-up contribution annually. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an Eligible Automatic Contribution Arrangement (EACA), whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of their eligible compensation, and such contributions are invested in an age-based target date retirement fund until changed by the participant. The Company makes matching contributions to the Plan, equal to 50% of each participant's contributions up to a maximum of 5% of the participant's eligible compensation. The Company made employer matching contributions of \$23,607 and \$80,291 in 2024 and 2023, respectively. Participants who have completed one year of service, are employed by the Company at year end and have completed at least 1,000 hours of service during the Plan year, are eligible for discretionary employer profit sharing contributions, which are determined annually by the Company. The Company made no discretionary employer profit sharing contributions during the period January 1, 2024 to April 30, 2024 or during the year ended December 31, 2023. In addition, contributions are subject to other limits under the IRC.

Participant Accounts - A separate account is maintained for each participant, which is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in employer matching and discretionary profit sharing contributions plus actual earnings thereon at a rate of 25% per year of service and are 100% vested after four years of service. Participants are also 100% vested upon death, total and permanent disability or retirement.

Payment of Benefits - Upon termination of service or upon reaching retirement age, disability or death, or upon attainment of age 59½, a participant may elect to receive a lump-sum amount, installments, partial payments, or an annuity contract equal to the value of the participant's vested interest in his or her account. Additionally, prior to termination under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Account balances of terminated participants that are under \$1,000 may be automatically paid out at the discretion of the Company. Terminated participant balances between \$1,000 and \$7,000 may be transferred to an IRA, also at the discretion of the Company.

Expenses - Certain administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from participants' accounts. In addition, certain expenses of Plan administration, including computer services, professional fees, office supplies, and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan.

Forfeitures - Forfeited accounts generally are the result of the non-vested portion of employer matching or discretionary profit sharing contributions from terminated employees. The forfeited accounts are to be used first to pay Plan expenses or restore prior forfeitures, and then to reduce employer contributions. Forfeited accounts totaled \$0 and \$43 as of April 30, 2024 and December 31, 2023, respectively. During the period January 1, 2024 to April 30, 2024 and for the year ended December 31, 2023, respectively, forfeitures in the amount of \$1,691 and \$1,679, were used to pay Plan expenses. During the period January 1, 2024 to April 30, 2024 and for the year ended December 31, 2023, respectively, forfeitures in the amount of \$0 and \$308 were used to reduce employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of April 30, 2024 or December 31, 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At April 30, 2024 and December 31, 2023, there were no amounts payable to participants.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Subsequent Events - The Plan's management has performed an evaluation of subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC No. 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2024 and December 31, 2023.

Mutual Funds and Money Market Mutual Fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no investments held at fair value at April 30, 2024. The following table sets forth, by level within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2023:

NOTE 4 – NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any given time. The loans are secured by the vested balance in the participant’s account. Loan repayments are made ratably through payroll deductions over a period not to exceed four and a half years unless the loans were used to purchase a primary residence in which case the loan terms may not extend beyond 10 years from the date of the loan origination. The loan interest rate is set at 1% above the *Wall Street Journal’s* prime rate at date of issue. All loans were transferred to the Standard Plan effective April 30, 2024.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The recordkeeper, Paychex Inc., provides certain administrative services to the Plan pursuant to an agreement between the Company and Paychex Inc. Such fees are charged by the recordkeeper and are included in administrative expenses for the year. The Plan trustee is an employee of the Company and also eligible to participate in the Plan.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Effective April 30, 2024, the Plan was merged into the Standard Pooled Employer Plan.

NOTE 7 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan holds investments that are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There were no investments held as of April 30, 2024. There were two investments that individually represented more than 10% of the investments held as December 31, 2023. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

NOTE 8 – TAX STATUS

The Plan is an adoption of a non-standardized pre-approved profit sharing plan sponsored by Paychex, Inc. for which a favorable opinion letter was received on August 31, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
