INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Pflow Industries, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Pflow Industries, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by banks or similar institutions or insurance carriers that are regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified to by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Pflow Industries, Inc. 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 2, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Pflow Industries, Inc. is the plan sponsor, employer and plan administrator. Empower Trust Company, LLC is the plan trustee that holds custody of the plan's mutual fund investments. Empower Annuity Insurance Company of America holds custody of the plan's fixed account investment. Empower Retirement, LLC maintains participant records as the plan's recordkeeper. The three Empower entities described above are collectively referred to as "Empower". The Retirement Advantage, Inc. ("TRA") is the third party administrator that maintains plan documents and tax counsel that performs any required compliance testing. Charles Schwab provides brokerage services for the self-directed brokerage accounts. Spectrum Investment Advisors, Inc. is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants, with the exception of the self-directed brokerage accounts. The participants allocate their contributions and transfer existing balances among the available investment options at their discretion. Earnings from investments bought, sold or held during the years is reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following are descriptions of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission ("SEC"), are required to publish their daily net asset value and are regularly traded in active markets.

Self-directed brokerage accounts - The plan offers self-directed brokerage account options which consist of interest-bearing cash and common stocks that are valued at the closing prices as reported by the issuers. The common stocks are registered with the SEC and are regularly traded in active markets.

Investment at contract value - The plan invests in the EI Fixed Account Series Class VI, a general account product of Empower. The investment is a fully benefit-responsive guaranteed portfolio investment through a group fixed annuity contract issued by Empower. As a general account product, participants' principal and interest amounts are fully guaranteed by the general assets of Empower. The fixed account is contractually obligated to repay the principal and a guaranteed interest rate for the life of the contract. The effective annual interest rate will never be less than 0% and is determined by Empower prior to the last day of the previous calendar quarter and resets quarterly.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor can request a lump sum distribution subject to a market value adjustment or an installment payout, at contract value, over a period of years. The contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on Empower's ability to meet its financial obligations. Empower's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with Empower. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with Empower or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective December 31, 1984 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - An employee is eligible for participation in the plan upon completion of one month of service and attaining the age of eighteen. An employee will be allowed to enter the plan on the first day of the month immediately following the date the plan's eligibility requirements are met.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 5% of compensation withheld as deferral contributions. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified retirement plans.
- c. Employer safe harbor matching contributions are made equal to 100% of the first 3% of compensation that a participant contributes to the plan and 50% of the next 2% of compensation that a participant contributes to the plan. All employer safe harbor matching contributions are remitted on an annual basis by the plan sponsor to the Pflow Industries, Inc. Employee Stock Ownership Plan ("the ESOP"), another qualified retirement plan sponsored by the employer.
- d. Employer non-elective contributions may be made at the employer's discretion. No such employer contributions were made in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation) of investments and income (losses) from self-directed brokerage accounts, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's deferral and rollover contributions and an allocation of any employer contributions remitted to the plan. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their deferral and rollover contributions and related earnings and any employer safe harbor matching contributions that are remitted to the plan and related earnings. Participants are not vested in any portion of any discretionary non-elective employer contributions and related earnings until they are credited with three years of service, at which time they are 100% vested. Upon death, disability or attaining normal retirement age (defined as age 59 ½) while still employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attaining the age of 59 ½. Distributions are generally made in the form of a single lump sum. Installment payments are permitted to satisfy Required Minimum Distribution obligations. Hardship withdrawals are not permitted under the plan.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expense include participant directed fees for distribution and loan processing services and nonparticipant directed fees for administrative and advisory services. The nonparticipant directed charges, net of any service credits received from Empower (see Note 3), are allocated to participants on an account value basis.

Forfeitures - Forfeitures may be used to pay administrative expenses or reduce employer contributions. Such accounts exist from discretionary employer contribution programs that existed prior to the plan implementing the safe harbor match provisions. Forfeiture used to pay administrative expenses were \$4,000 in 2024. There were no forfeitures used in 2023. Unapplied forfeitures were insignificant as of December 31, 2024. Unapplied forfeitures were \$4,000 as of December 31, 2023.

Notes receivable from participants - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may only have one loan outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had various repayment schedules through October 2029 with interest rates from 5.25% to 10.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS AND ADMINISTRATIVE EXPENSES

Empower manages the plan's fixed account investment option and also holds custody of the plan's investments. As such, transactions between Empower and the plan qualify as party-in-interest transactions.

Pursuant to a service agreement between the plan sponsor and Empower, Empower remits certain service credits to the plan on a periodic basis. These service credits are used by the plan to pay administrative expenses. Service credits received by the plan, recorded as a credit to administrative expenses, were \$9,000 in 2024 and \$7,000 in 2023. Direct fees paid by the plan to Empower for record keeping and investment management services, recorded as a component of administrative expenses, were \$29,000 in 2024 and \$26,000 in 2023. Empower also receives indirect compensation from the plan's mutual fund investment providers for services Empower provides to the funds which reduces fees that would otherwise be owed by the plan to Empower for services provided. In addition, the plan pays direct fees to other third party service providers for certain investment and administrative services, recorded as a component of administrative expenses, which were \$36,000 in 2024 and \$31,000 in 2023.

Transactions related to employer contributions remitted to the ESOP and notes receivable from participants also qualify as party-in-interest transactions.

All such party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any discretionary employer contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted a TRA non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The opinion letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY EMPOWER

Management has obtained certifications from two of the Empower entities described at Note 1, which are qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan are complete and accurate.

- a. Investments held, and the fair and contract values of such, and notes receivable from participants as of December 31, 2024 and 2023;
- b. Dividends and interest income from investments, net appreciation (depreciation) in fair values of investments, income (losses) from self-directed brokerage accounts and interest income from notes receivable from participants during 2024 and 2023;
- c. Contributions to and withdrawals from accounts, and purchases, sales and interfund transfers of investments during 2024 and 2023; and
- d. The reports of individual participant accounts as of and for the years ended December 31, 2024 and 2023.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500S

As discussed in Note 1, the plan follows the accrual method of accounting for financial statement purposes. The Form 5500s are prepared on a cash basis. In addition, the financial statements differ from the Form 5500s due to the Form 5500s reporting defaulted loans as deemed distributions; whereby the financial statements only record the loan offsets when certain triggering events occur. As a result, the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended differ from the Form 5500s.
