NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

NOTE A - DESCRIPTION OF PLAN

The following description of Highly Marelli USA 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2021. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering all employees of Highly Marelli USA who have completed one month of service except for employees covered by a collective bargaining agreement, leased employees, foreign nationals on temporary assignment, co-op students, scholarship winners, and employees classified as provisional employees. Participants may enter the Plan on the first day of each month coinciding with or next following the date the service requirement is met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute on a pre-tax basis or post-tax (Roth) basis to the Plan up to 90% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution equal to 100% of participant contributions up to 6% of compensation. The Company may also make discretionary matching contributions and nonelective contributions to the Plan. To be eligible to receive a safe harbor matching contribution, discretionary matching contribution, if any, and a nonelective contribution, if any, participants must complete three months of service. To be eligible to receive a nonelective contribution, participants must also be employed on the last day of the Plan year. The Company did not make any discretionary matching contributions or nonelective contributions during the year ended December 31, 2024. Participants direct the investment of their Company contributions into various investment options offered by the Plan.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, discretionary matching contributions, if any, nonelective contributions, if any, and an allocation of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants vest immediately in their contributions and their Company safe harbor contributions, Company discretionary matching contributions, if any, plus actual earnings thereon. Vesting in the Company's nonelective contributions portion of their account balance is based on years of service as follows:

Less than 1	0%

2	40%

5	100%

If a participant dies or is disabled prior to attaining normal retirement age, the participant becomes 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments may be made in the form of lump sum distributions, installment payments, and partial withdrawals. Participants who terminate employment with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance. Effective January 1, 2024, participants who terminate employment with a balance of less than \$7,000, but more than \$1,000, may receive an automatic direct rollover of their account balance into an individual retirement account. Prior to January 1, 2024, participants who terminated employment with a balance of less than \$5,000, but more than \$1,000, may have received an automatic direct rollover of their account balance into an individual retirement account.

Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Forfeitures occurring during a Plan year may be used to pay Plan expenses at any time.

Forfeited Accounts (continued)

Any forfeitures not used to pay administrative expenses under the Plan shall be applied to reduce Company contributions in the immediately following Plan year. As of December 31, 2024 and 2023, the forfeiture balance was \$5,141 and \$5, respectively.

Forfeitures of \$5,164 were used to pay Plan expenses during the year ended December 31, 2024. Forfeitures of \$2,639 were used to reduce Company contributions during the year ended December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees for recordkeeping services, third-party administration and investment advisory services are included in administrative expenses. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

Reclassifications

Certain reclassifications have been made to the prior year to conform to the current year's presentation. The reclassifications had no effect on the reported net increase in the statement of changes in net assets available for benefits.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. During the year ended December 31, 2024, the group annuity contract with New York Life Insurance Company was changed to being valued at contract value based on the determination that it is a fully benefit-responsive investment contract. The investment was reclassified from a pooled separate account valued at fair value to a fully benefit-responsive investment contract valued at contract value. The investment was reclassified as of December 31, 2023 to conform to the current year presentation. There have been no other changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (and money market fund): Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Plan participants can invest in certain investments through a self-directed brokerage account. The underlying investments held in the self-directed brokerage accounts as of December 31, 2024 and 2023 are valued as follows:

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund held by the self-directed brokerage accounts is an open-ended fund that is registered with the SEC. The fund is required to publish its daily NAV and to transact at that price. The money market fund held by the self-directed brokerage accounts is deemed to be actively traded.

NOTE E – GROUP ANNUITY CONTRACT WITH NEW YORK LIFE INSURANCE COMPANY

The Plan offers an investment in a group annuity contract (“Anchor account”) through a fully benefit-responsive investment contract with New York Life Insurance Company (NYL). Contributions to the contract are invested in NYL’s Pooled Separate Account No. 25 that invests primarily in a diversified portfolio of high quality, fixed income securities, which are owned and managed by NYL. NYL is contractually obligated to repay principal and accumulated interest to the Plan. Interest is accrued daily and credited monthly as rates determined by NYL under the contract are based on the investment performance of the pooled separate account. The crediting interest rate is updated at least annually and not more frequently than daily and is guaranteed by NYL to not be less than zero.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by NYL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events would limit the ability of the Plan to transact at contract value. Such events include (1) termination of the Plan’s interest by the Plan Administrator with less than 12 months’ notice, (ii) termination of the Plan’s interest due to loss of qualified status or (iii) withdrawals or transfers of more than five percent of amounts held under the contract due to a Plan

Administrator event including, but not limited to, a total or partial plan termination, merger, spin-off, lay-off, early retirement incentive program, sale or closing of all or part of the Plan sponsor's operations, bankruptcy, or receivership. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G – TAX STATUS

The Plan adopted a non-standardized pre-approved defined contribution plan which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity Management Trust Company and its affiliates Fidelity Investments Institutional and Strategic Advisors, Inc. (collectively referred to as "Fidelity") are the third-party administrator, recordkeeper, advisor, and trustee of the Plan. Certain Plan investments are managed by Fidelity and are denoted on the supplemental schedule of assets (held at end of year). Fees paid to Fidelity have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Morgan Stanley Smith Barney LLC is the investment advisor of the Plan. Fees paid to Morgan Stanley Smith Barney LLC have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Notes receivable from participants and related interest income also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J – DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During the year ended December 31, 2024, participant contributions totaling \$53,127 were not remitted to the Plan until after the required time period and are considered prohibited transactions. The Company will correct the delinquent participant contributions as soon as administratively feasible. During the year ended December 31, 2023, participant contributions totaling \$323,275 were not remitted to the Plan until after the required time period and are considered prohibited transactions. The delinquent participant contributions from the year ended December 31, 2023 were corrected in 2025.

NOTE K – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain amounts included on Schedule H Part I and II of the Form 5500 have been classified differently for purposes of financial statement presentation.

There are no reconciling items between the financial statements and Form 5500 as of and for the years ended December 31, 2024 and 2023.

NOTE L – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events for recognition and disclosure through October 10, 2025 the date the financial statements were available to be issued.
