### Note 1. Description of the Plan

The following description of the Profit Sharing Plan of Ogletree, Deakins, Nash, Smoak & Stewart (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering all employees of Ogletree, Deakins, Nash, Smoak & Stewart, P.C. (the "Firm"), except associate attorneys, Of Counsel attorneys, and leased employees as defined in the Firms' shareholder management agreement. An eligible employee will become an active participant in the Plan as of the first January 1 or July 1 following the attainment of age 21 and the completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Fidelity Management Trust Company (the "trustee").

#### Contributions:

The Firm may, in its sole discretion, make a contribution to the Plan for each plan year for the benefit of eligible participants other than Class C Shareholders. The Firm will contribute to the Plan an amount not less than 3 percent of the compensation of all eligible Class C Shareholders. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective January 1, 1998, voluntary employee contributions to the Plan are neither permitted nor required. Participants direct the investment of their profit sharing contribution into various investment options offered by the Plan. During the year ended December 31, 2024, the Firm made \$15,024,412 in contributions to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

#### Participant accounts:

Each participant's account is credited with Firm contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting:

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Firm's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

#### Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is one percent above prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

### Note 1. Description of the Plan, Continued

#### Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or the installment options as provided by the Plan. All fully vested balances are available for distribution after the participant reaches the age of 63. Account balances of less than \$1,000 will automatically be paid in a lump-sum distribution upon termination.

#### Forfeited accounts:

The Plan requires that any amounts forfeited pursuant to the Plan shall then be applied to pay the Plan's administrative expenses for the Plan year and, next, to reduce the Firm contributions or to pay qualified nonelective contributions for the Plan year during which the forfeiture occurs or during the Plan year following the year of the forfeiture to the extent permitted by applicable law. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$85,985 and \$16,981, respectively. For the year ended December 31, 2024, there were \$244,000 of forfeitures used to reduce Firm contributions and \$70,885 of forfeitures used to pay administrative expenses.

### Note 2. Summary of Significant Accounting Policies

#### Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

#### Contributions:

Contributions from the Firm are recorded in the year in which participant compensation is earned.

#### Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Note 2. Summary of Significant Accounting Policies, Continued

#### Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### Payment of benefits:

Benefits are recorded when paid.

#### Expenses:

Certain expenses of maintaining the Plan are paid directly by the Firm and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent events:

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

#### Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

### Note 3. Trustee Certifications

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by the trustee and furnished to the plan administrator. The plan administrator has obtained certifications from the trustee that the information provided to the plan administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

The trustee also certified to the completeness and accuracy of \$17,058,739 of net appreciation in the fair value of investments and \$14,655,933 of interest and dividends, as well as \$100,694 of interest on notes receivable from participants for the year ended December 31, 2024.

### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator and investment advisor totaling \$60,849 which were not covered by revenue sharing. The Firm pays directly any other fees related to the Plan's operations.

### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Firm contributions.

### Note 7. Tax Status

The IRS has determined and informed the Firm by a letter dated February 25, 2016 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

### **Note 9. Plan Errors and Prohibited Transactions**

During 2024, the Firm received confirmation that the DOL has accepted the Firm's corrections with respect to \$12,420 of participant contributions which they had failed to deposit during 2022 within the required timeframe as required by the DOL. The Firm corrected these remittances through the DOL's Voluntary Fiduciary Correction Program. The Firm has filed Form 5330 with payment of the applicable excise tax with respect to the \$12,420 relating to 2022, which was paid from the Firm's general assets.
