Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of AGCO Corporation Hesston Employees' Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the AGCO Corporation Hesston Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of AGCO Corporation, Hesston Operations (the "Company") who meet the eligibility requirements. The Plan was initially established September 28, 1962, and was most recently amended and restated January 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by AGCO Corporation (the "Plan Sponsor") and is advised by the Retirement Committee whose members are appointed by the Board of Directors. The Retirement Committee serves as the Plan Administrator. Vanguard Fiduciary Trust Company ("Vanguard") serves as the trustee and record keeper of the Plan and is also the investment custodian.

Partial Plan Termination – During the year ended December 31, 2024, the Company experienced a significant reduction in workforce resulting in the involuntary termination of more than 20% of Plan participants. This event constitutes a partial plan termination. As a result, all affected participants will become 100% vested in their Company contributions, regardless of the Plan's regular vesting schedule.

Eligibility – The Plan is open to substantially all hourly (union) employees of the Company after 60 days of service. Participants enter the Plan on the first day of the month subsequent to meeting the eligibility requirements.

Contributions – Participants are automatically enrolled in the Plan unless the participant affirmatively elects otherwise. In the first year of participation, the automatic election is 3%, and increases in 1% increments on the first day of each subsequent Plan year up to a maximum of 15%. Participants may elect to contribute up to 20% of eligible compensation, on either a before-tax or after-tax basis, subject to certain Internal Revenue Code ("IRC") limitations. In addition, participants meeting certain age requirements may also make catch-up contributions. Matching contributions are made by the Company each pay period at a rate of 50% of the first 6% of pre-tax deferrals.

The Plan also provides that the Company shall contribute a minimum of 4% of participants' eligible compensation annually as a retirement contribution. As of December 31, 2024 and 2023, the employer contributions receivable includes \$1,437,270 and \$1,922,358, respectively.

Participant Accounts – Each participant's account is credited with the participant's before-tax and after-tax contributions, Company matching and Company retirement contributions, and an allocation of the Plan's earnings, and is charged with a participant's distributions and an allocation of Plan expenses. Earnings are allocated daily based on participant account balances.

Investment Options – Contributions are invested in such proportion as the participant directs to various mutual funds and common collective trusts offered by the Plan.

Vesting – Participants are immediately vested in their contributions at all times. Company contributions vest in 20% increments, with 20% vested after two years of service, 40% vested after the third year, etc. A participant is fully vested after 6 years of service. A participant is credited with a year of service after working 1 hour in any calendar year. A participant also becomes fully vested in the event of death, disability or attaining the age of 65. Participants affected by the partial plan termination will become 100% vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested. Non-vested balances of terminated employees are held by the Plan until there are 5 consecutive one-year breaks in service. Forfeiture amounts are allocated to the accounts of eligible participants in the proportion that each participant's compensation for the Plan year bears to the total compensation of all such participants for the Plan year. Participants are eligible for an allocation of forfeitures if they are employed on the last day of the Plan year, or whose employment was terminated during the Plan year due to retirement, disability or death. For 2024, forfeitures of \$9,420 were reallocated to participants. As of December 31, 2024 and 2023, unallocated forfeitures totaled \$537,523 and \$298,539, respectively.

Payment of Benefits – Upon termination of service, the participant, or in the case of death, the participant's beneficiary, may elect to receive the vested portion of their account in one of the following forms:

- a single sum payment, payable to either the participant or rolled over to another qualified Plan;
- monthly, quarterly or annual installments payable over a specified number of years;
- monthly, quarterly or annual installments of a designated amount payable until the account balance is exhausted; or
- any combination of the above.

If an installment method of payment is selected, the term of the payments may not exceed the participant's estimated life expectancy. If the participant's vested account balance is less than \$1,000, and the participant fails to elect a form of distribution, then the balance will be automatically distributed in a lump-sum. If the balance is less than \$5,000 but greater than \$1,000, and the participant fails to elect a form of distribution, then the participant's balance will be automatically rolled over to an individual retirement account.

In-Service Withdrawals – Participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined in the Plan Document and permitted by the IRC. Hardship withdrawals are limited to the participant's salary deferral contributions, which shall not include earnings thereon.

Participants who have attained the age of 59½ are allowed to receive a distribution of all or any portion of their participant contributions, and earnings thereon, in a single lump sum payment.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans may only be made from the participant's after-tax contribution account, before-tax contribution account or rollover contributions account. The maximum loan term is 5 years, unless the loan is for the purchase of the participant's principal residence, in which case the maximum term is 10 years. The loans are secured by the balance in the participant's account, and bear interest at the *Wall Street Journal Prime Rate*. A participant may only have one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions and must be made at least quarterly.

Administrative Expenses – The Company or the Plan may pay the administrative expenses of the Plan. During 2024, the Plan paid administrative expenses of \$121,178 related to recordkeeping and investment management fees.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan Document and under ERISA. In the event that the Plan should be terminated, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance is considered necessary.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Dividends are recorded on the ex-dividend date. Interest is accrued when earned. Purchases and sales of securities are recorded on a trade-date basis. See Note 3 for discussion of fair value measurements.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and the common collective trust funds (“CCT”) are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Risks and Uncertainties – The Plan invests in various securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Payment of Benefits – Benefit payments are reported in the year paid.

Transfers To and From Affiliated Plan – During the year ended December 31, 2024, assets of \$40,950 were transferred to the AGCO Corporation Savings Plan. This occurs when a participant changes employment classification from hourly (union) to salary (non-union).

During the year ended December 31, 2024, assets of \$446,378 were transferred into the Plan from the AGCO Corporation Savings Plan. This occurs when a participant changes employment classification from salary (non-union) to hourly (union).

Date of Management's Review – Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were available to be issued, and there were no events requiring additional recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

In accordance with Accounting Standards Codification 820, *Fair Value Measurements*, the inputs to valuation techniques used to determine fair value are categorized into a fair value hierarchy. Observable inputs (highest level) reflect market data obtained from independent sources, while unobservable inputs (lowest level) reflect internally developed market assumptions. The inputs are summarized in a three-level valuation hierarchy as follows:

Level 1 – Quoted prices for identical assets in active markets.

Level 2 – Quoted prices for similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; model-derived valuations in which all significant inputs are observable or can be corroborated by observable market data for substantially the full term of the investment.

Level 3 – Model-derived valuations in which one or more significant inputs are unobservable.

If the inputs used to value the investment fall within different levels of the hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the investment. Valuation techniques are designed to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Mutual funds are valued using the published quoted price, which is the net asset value (“NAV”) of the fund. The NAV is based on the fair value of the underlying securities.

Common/Collective Trusts – The investment manager calculates a unit value (similar to a NAV), which is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The fair values assigned to the Plan's investments are based upon available information and do not necessarily represent amounts which might ultimately be realized. Due to the absence of readily determinable fair values and the inherent uncertainty of valuations, the estimated fair values may differ significantly from values that would have been used had a ready market for the securities existed. The Plan Administrator believes the valuation methods are appropriate and consistent with other market participants.

The fair value of these assets approximates their carrying amounts in the accompanying financial statements due to the short-term maturity of the financial instruments.

4. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Net appreciation in fair value of investments
- Interest and dividend income
- Notes receivable from participants and related interest

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. TAX STATUS

The Plan obtained its latest determination letter from the Internal Revenue Service on October 7, 2015, stating the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. The Plan has since been amended. However, the Company believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are mutual funds and common collective trust funds managed by Vanguard. Vanguard is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest.

The Plan pays certain fees to Vanguard to administer the Plan. These transactions qualify as party-in-interest.

Notes receivable from participants are party-in-interest transactions.
