INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries of the
Mound, Cotton, Wollan & Greengrass 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mound, Cotton, Wollan & Greengrass 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTE A - DESCRIPTION OF THE PLAN

The following description of the Mound, Cotton, Wollan & Greengrass 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

[1] General:

The Plan is sponsored by Mound, Cotton, Wollan & Greengrass LLP (the "Partnership").

The Plan is a defined contribution plan covering all employees, as defined, of the Partnership who have completed six months of service prior to February 2024 and one month of service commencing February 2024 and are age twenty-one (21) or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Fidelity Management Trust Company ("Fidelity") serves as the Plan's trustee and manages the Plan's assets in a non-discretionary capacity.

[2] Participant accounts:

Each participant's account is adjusted to reflect the participant's contributions, the Partnership's profit-sharing contributions and Plan earnings/losses attributable to investment results of funds into which each participant has directed his or her current period contributions and prior period account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

[3] Self-directed accounts:

The Plan offers a self-directed program to participants. The self-directed program allows participants to invest their accounts balances in any investments desired that are offered by the Plan's custodian. Each participant account is credited with the participant's contributions, employer contributions and allocable investment income (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

[4] Eligibility:

Employees become eligible for participation in elective salary deferral contributions on the first day of the month coinciding with or following the date the employee completed six months of service prior to February 2024 and one month of service commencing February 2024 and attained the age of twenty-one (21).

[5] Contributions:

Participants may contribute up to 90% of their eligible pre-tax annual compensation, as defined by the Plan. In no event may participant pre-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and Roth contributions.

The Partnership may make contributions designated as "qualified non-elective contributions." In addition, the Partnership may make a discretionary non-elective employer contribution based on a cross-tested allocation formula utilizing participant allocation groups. Contributions are subject to certain limitations established by the Internal Revenue Code ("IRC"). To be eligible for the discretionary non-elective employer contribution, a participant must have earned 1,000 hours of service in the given Plan year and be employed on the last day of the Plan year. In 2024 and 2023, the Partnership did not make such a contribution.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

[5] Contributions: (continued)

Participants direct the investment of participant and employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and self-directed brokerage accounts as investment options for participants.

[6] Vesting:

Participants are 100% vested in their contributions and in employer discretionary contributions, plus actual earnings thereon.

[7] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rate on outstanding loan balances ranged from 5% to 9.5% at December 31, 2024 and was 5% at December 31, 2023. Principal and interest are paid ratably through direct payments to Fidelity, payroll deductions or other approved manner. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

[8] Payment of benefits:

On termination of service due to death, disability, or retirement, or upon attaining the age of 59½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments or annuities, as defined by the Plan. Vested balances of \$1,000 or less are to be paid out in a lump sum upon termination of service.

Prior to termination of employment, the Plan administrator may grant a participant's request for a hardship withdrawal, from the participant's deferral contributions account only, if (i) the Plan administrator determines that such withdrawal is necessary in light of the immediate financial needs of the participant and is in accordance with the requirements of the IRC, as amended, and the regulations promulgated thereunder and (ii) the Plan administrator receives written consent from a participant and spouse, if married, allowing the withdrawal.

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth by the Plan and by ERISA. In the event of plan termination, the Plan assets will be distributed to the participants or their beneficiaries in a single lump-sum payment or in such manner as the Plan administrator shall determine.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[2] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Subsequent events:

The Partnership evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

[5] Mutual fund fees:

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

Certain mutual funds held by the Plan have short-term redemption fees ranging from 0.75% to 1.00% for shares held less than 30 or 90 days.

[6] Payment of benefits:

Benefits are recorded when paid.

[7] Plan expenses:

The Partnership pays certain administrative expenses of the Plan.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Self-directed brokerage accounts – Accounts consist of investments including mutual funds, interest bearing cash, common stock, corporate debt instruments, exchange-traded funds and real estate investment trusts that are valued on the basis of readily determinable market prices. Accounts include certificates of deposit valued using pricing models maximizing the use of observable inputs for similar investments.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. There were no transfers into or out of Levels 1, 2 or 3.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee and custodian of the Plan and therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$7,419 for the year ended December 31, 2024.

NOTE F - TAX STATUS

In October 2021, the Plan adopted a Pre-Approved Defined Contribution Plan sponsored by Fidelity Management & Research Company. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the pre-approved defined contribution submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

NOTE F - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - NONEXEMPT PARTY-IN-INTEREST TRANSACTION

During the year ended December 31, 2024, it was discovered that certain amounts withheld in 2024 were not timely remitted to the Plan. The Plan administrator remitted \$2,542 in May 2024 and will determine interest to make the affected participant whole. The Plan administrator has remitted \$562 in October 2025 and will determine interest to make the affected participant whole.
