NOTE 1 – DESCRIPTION OF PLAN

Berridge Manufacturing 401(k) Plan (the Plan) is a qualified retirement plan adopted by Berridge Manufacturing Company (the Company) to provide eligible employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was adopted on July 1, 1998 and was most recently amended and restated effective January 1, 2022 to conform the Plan to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the plan's provisions.

Eligibility: All employees of the Company are eligible to participate in the Plan after attainment of age 21 and completion of one period of service. An employee's entry date will be the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date the employee satisfies the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as salary deferral. There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Total deferrals in any taxable year may not exceed the dollar limit which is set by law. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may make additional catch-up contributions. Participants may revoke their salary deferral elections at any time. Participants may make any other modification to their salary deferral elections on the first day of the plan year or the first day of the seventh month of the plan year. Participants are also permitted to deposit into the plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

The Company may make a discretionary matching contribution equal to a uniform percentage of participants' salary deferrals. For 2024, the Company made a matching contribution equal to 50% of participants' elective deferral contributions, limited to 6% of a participant's compensation.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions (b) Plan earnings and losses, and (c) forfeitures of discretionary matching contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are always 100% vested in their salary deferrals, rollover contributions, and actual plan earnings thereon. A participant's vested percentage for employer contributions is based on vested years of service. A participant is 100% vested after five years of service.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual funds and a guaranteed investment contract as investment options for participants. Participants may redirect future contributions or exchange existing balances among available investment securities at any time.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan for the following reasons: termination of employment, early retirement, normal retirement, disability, or death. Benefits under the Plan will be paid to participants in cash. If the vested account balance does not exceed \$5,000, then the vested account balance may only be distributed to a participant in a single lump-sum payment. If the vested account balance exceeds \$5,000, then the participant may elect to receive a distribution of their vested account balance in a single lump-sum payment or installments.

Participants may be entitled to receive an in-service distribution. Participant may receive a distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59½. Participants may also withdraw money for financial hardship to satisfy certain immediate and heavy financial needs.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant's accounts will become 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Forfeited Accounts: If a participant terminates employment before being fully vested, then the non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. The Company may use forfeitures to pay plan expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,694 and \$24,951, respectively. During 2024, there were no forfeitures used to pay plan expenses or to reduce employer contributions.

Subsequent Events: The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 – Quoted prices (adjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Mutual Funds: The fair values of mutual fund investments are determined using the market approach, which uses unadjusted quoted prices in active markets that the Plan has the ability to access. These are classified as Level 1 inputs within the fair value hierarchy.

There were no assets or liabilities measured at fair value on a non-recurring basis at December 31, 2024 and 2023. There were no transfers between levels for 2024 and 2023.

NOTE 5 – KEY GUARANTEED PORTFOLIO FUND

The Plan has a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (Empower), which is called the Key Guaranteed Portfolio Fund (Fund). Empower maintains the contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract value of the group annuity contract at December 31, 2024 and 2023 was \$802,479 and \$1,090,596, respectively.

Since the Fund is fully benefit-responsive traditional investment contract, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund. The Fund is presented on the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan’s ability to transact at contract value with Empower. Such events include the following: (1) premature termination of the contract by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, and (6) early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

Empower may not terminate the contract at any amount less than the contract value. Empower is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with Empower. Such interest rates are reviewed on a quarterly basis for resetting.

The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium to long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the Fund over the year.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds an investment contract with Empower. Empower is a service provide to the Plan and, therefore, these transactions and the Plan payment of fees to the Company qualify as party-in-interest transactions.

NOTE 7 – TAX STATUS

The IRS issued an opinion letter dated November 20, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan had been amended from the original prototype document, Plan management believes that the Plan was operated in accordance with the IRC.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
