INDEPENDENT AUDITOR'S REPORT

To The Plan Administrator of The White Oak 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The White Oak 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

General—The White Oak Global Advisors 401(k) Plan & Trust was established on January 1, 2013. Effective January 1, 2021, the White Oak Group of Companies 401(k) Plan merged into the White Oak Global Advisors 401(k) Plan & Trust, thus covering White Oak Global Advisors, LLC; White Oak Trade Finance, LLC; White Oak Trade Finance, II, LLC; White Oak Healthcare Finance, LLC; White Oak Merchant Partners, LLC; White Oak Aviation Management Services US LLC; White Oak Credit Services, LLC; White Oak Business Capital, Ltd.; White Oak Equipment Finance; White Oak Commercial Capital, LLC; White Oak Asset Based Lending, LLC; White Oak Healthcare Partners, LLC; White Oak Healthcare MOB; White Oak Commercial Finance, LP; and White Oak Real Estate Capital Management Services, LLC. Effective January 1, 2021, the White Oak Global Advisors 401(k) Plan & Trust was restated as The White Oak 401(k) Plan (the “Plan”). The Plan is a multiple employer plan subject to the rules of Code section 413(c) and the regulations thereunder.

The following description of the Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

The Plan is a defined contribution plan sponsored by White Oak Global Advisors, LLC (the “Company” or “Plan Sponsor”). The Board of Directors of the Company has appointed The White Oak 401(k) Plan Committee to oversee the administration of the Plan. Empower Trust Company, LLC (the “Trustee”) and Empower Annuity Insurance Company of America (“Insurance Carrier”) serve as the Plan’s trustee and insurance carrier, respectively. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) safe harbor and employer matching contributions made by the Company, (iii) nonelective contributions made by the Company, and (iv) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the Plan.

Participants may elect to contribute a percentage of their eligible compensation to the Plan each year, subject to the limitations, as defined in the Plan document. Such contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% on the first day of each subsequent Plan year, up to a maximum deferral percentage of 10%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution to each participant’s account equal to 100% of the amount of the participant’s salary reduction contribution. The maximum contribution amount

eligible to be matched is 4% of eligible compensation as defined by the Plan. Additional elective contributions may be contributed at the discretion of the Company. During the year ended December 31, 2024, the Company made no discretionary contributions to the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Employee contributions are recorded when withheld. Safe harbor matching contributions are recorded when earned.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution and related safe harbor matching and discretionary contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants may direct the investment of their contributions and any safe harbor matching or discretionary contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

Participants may also direct their investments through a self-directed brokerage account, which offers the option to invest in a variety of stocks and mutual funds. There was no participant balance in self-directed brokerage account as of December 31, 2024 and 2023.

Vesting—Participants are vested immediately in their contributions and employer contributions, plus actual earnings thereon.

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The interest rate on any loan is 1% over the Prime Rate published in the Wall Street Journal as determined on the first business day of the month the loan is originated. The loans are secured by the participant's vested interest in the Plan. Principal and interest are paid ratably through payroll deductions or as a lump-sum for the outstanding loan balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. As of December 31, 2024, participant loans have maturities through 2049 at interest rates ranging from 4.25% to 9.50%.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual or more frequent installments over a period not to exceed the joint life expectancy of the participant and his or her beneficiary. Participants are also eligible to make hardship withdrawals from their account in the event of certain financial hardships.

Forfeitures—The Plan document permits the use of forfeitures to either reduce future employer contributions or pay Plan administrative expenses for the plan year. As of December 31, 2024, the Company identified excess contributions made to the Plan in the amount of \$280,254. Upon identification of the excess contributions, the Company identified specific participant accounts that were credited with the erroneous contribution, in order to claw back those amounts subsequent to December 31, 2024. For participants who terminated, withdrawing their account balance from the Plan,

the Company was unable to recover those amounts. For participants with a remaining balance, the excess contributions, and any earnings thereon will be transferred to the forfeiture account in the amount of \$278,755 during 2025. As of December 31, 2024, \$78,468 was due from the Company in the form of a safe harbor matching contribution. This amount will be paid from forfeitures in 2025, and as a result, there is no receivable reflected in the statement of net assets. During 2024, no forfeiture balance was used to reduce the employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited accounts totaled \$40,471 and \$27,776, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value.

Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or the Plan Sponsor, as provided in the Plan document. Participants pay administrative costs for loans, distributions, and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to Empower under a fee levelization arrangement, which Empower in turn credits to the Plan participants who invested in the funds with revenue sharing. For the year ended December 31, 2024, \$71,304 was returned to the Plan participants who invested in the Plan investments with revenue sharing.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

Subsequent Events—Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued. No events occurred that require additional disclosure or adjustments to the Plan’s financial statements.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule of assets (held at end of year) that were prepared by or derived from information prepared by the Empower Trust Company, LLC and Empower Annuity Insurance Company of America, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustee and Insurance Carrier that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily

available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level within the fair value hierarchy a summary of the Plan’s investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a guaranteed investment contract (GIC) with the Insurance Carrier. The GIC meets the criteria of a fully benefit-responsive investment, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

Limitations on the Ability of the GIC to Transact at Contract Value—The GIC has certain restrictions that affect the ability of the Plan to collect the full contract value. For example, the contract prevents immediate and full payout of the contract value for Plan-initiated transactions, such as cessation. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance carrier may not terminate the contract at any amount less than the contract value.

Certain events limit the ability of the Plan to transact at contract value with the Insurance Carrier. Such events include premature termination of the contracts by the Plan, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable.

6. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. As of December 31, 2024 and 2023, the Plan's investment in Key Guaranteed Portfolio Fund is managed by Empower Annuity Insurance Company of America, an insurance carrier and thus a party-in-interest amounting to \$2,725,963 and \$2,374,557, respectively. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

See Note 2 for the description of Plan's revenue sharing agreement.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Participants are 100% vested in their accounts at all times.

8. FEDERAL INCOME TAX STATUS

The Plan uses a prototype Plan document prepared by third-party retirement plan administrators Atteberry/Searle, Incorporated, who received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

9. NONEXEMPT PARTY-IN-INTEREST TRANSACTION

During the year ended December 31, 2024, the Company and adopting companies remitted certain participant contributions and loan repayments of \$89,774 to the Trustee later than required by Department of Labor (DOL) Regulation 2510.3-102. The Company has filed Form 5330 with the IRS and paid the required excise tax on the transaction during 2024. In addition, participant accounts have been credited with the amount of investment income that would have been earned had the participant contribution been remitted on a timely basis. 2023 late contributions of \$442,749 were remediated during 2024, resulting in credits to participant accounts of less than \$403.


