We have performed audits of the financial statements of Eagle Fire Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of Plan**

The following description of the Eagle Fire Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering all employees of Eagle Fire Inc. and Building Systems Technology Inc. (collectively, the “Company”), excluding leased employees, non-resident aliens, and employees covered by collective bargaining agreements. Employees are eligible to participate in deferral contributions upon reaching age 18. Participants are eligible to receive Company contributions upon completion of one year of service, as defined. Ascensus Trust Company (“Ascensus”), a qualified institution, serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Contributions***

Each year, participants may contribute eligible compensation as pretax or Roth deferrals, as defined, up to the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may contribute to the Plan in the form of discretionary matching contributions. Discretionary matching contributions may be made to participants who have completed 1,000 hours of service during the Plan year and are employed by the Company on the last day of the Plan year, as defined. The Plan also provides discretionary profit-sharing contributions. There were no profit-sharing contributions during 2024. For the year ended December 31, 2024, the Company made a matching contribution equal to 50% of a participant’s contribution, up to a maximum of 4% of eligible compensation. Participants may direct their contributions into various investments offered by the Plan. Contributions are subject to certain limitations.

Effective January 1, 2025, discretionary matching contributions may be made to participants who have been employed for three consecutive months, calculated quarterly.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant’s account is credited with the participant’s and the Company’s contribution, allocations of Plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching contribution and profit-sharing contribution, plus actual earnings thereon, is based on years of service. A participant is 20 percent vested after two years of credited service and 100 percent vested after 6 years of credited service. A participant is 100 percent vested upon reaching full retirement age, death or disability.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years unless the note is for purchase of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant's account and bear interest at the Prime rate plus 2%. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution or partial payments equal to the value of the participant's vested interest in his or her account, as defined. In addition, in-service withdrawals are permitted upon reaching age 59 ½, as defined. Mandatory distributions are required of vested balances \$5,000 or less for terminated participants. Hardship withdrawals are also permitted from employee deferrals, subject to provisions described in the Plan document.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,806 and \$9,444, respectively. Forfeited balances of terminated participants' non-vested accounts may be used to reduce employer contributions or pay Plan expenses. During 2024, forfeitures of \$11,463 were used to reduce employer contributions.

***Transfers***

On December 31, 2024, assets of the CANA COMMUNICATIONS 401(k) plan totaling \$1,999,683 were transferred to the Plan.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, as well as disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation

***Note Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Benefit Payments***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the individual securities are traded.

**Stable Value Collective Trust Fund**

The Plan invests in a stable value collective trust fund for which quotes prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (“NAV”) provided by the custodian as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

Ascensus is the trustee as defined by the Plan, and therefore any transactions qualify as party-in-interest transactions. There were no party-in-interest transactions for the year ended December 31, 2024. Fees paid to the third-party administrator for administrative services were \$23,337 for the year ended December 31, 2024.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the IRS stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (the "IRC"). Effective January 1, 2021, the Plan is relying on the IRS approval of the non-standardized pre-approved profit-sharing plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the non-standardized pre-approved profit sharing plan was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Contingencies, Risks and Uncertainties**

The Plan invests in investment securities, which are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
