I am writing this letter to attach to Form 5500 Annual Report for calendar plan year 2024 for UNIVERSAL TECH OF WI, INC PS RETIREMENT PLAN (the Plan). The Plan Sponsor is Universal Technologies of Wisconsin, Inc. with EIN 39-0172770.

Field 5 of the Plan's Form 5500 Annual Report shows that there were 124 participants at the beginning of the plan year 2024, which requires the Plan to file an audit report with its Form 5500 Annual Report for the first time in the Plan's history.

I kindly request a waiver of the audit report requirement for plan year 2024 due to the following unique facts and circumstances:

The Plan had a set of 17 small balance accounts created near end of Plan Year 2022. Our intent was to get these balances distributed via the small amounts force out provision, to which we had worked to put a direction on file with Vanguard Ascensus (the Plan's Recordkeeper) during our transition to Vanguard Ascensus from Principal Financial Group in 2020. There appears to have been miscommunication between the Plan and Vanguard Ascensus about the filing of this direction, as these small balances were not auto processed out of the Plan during 2023. As a result, we began plan year 2024 in excess of the threshold of 120 participants that would require the Plan to file an audit report with its Form 5500.

I kindly request a waiver of the audit report requirement for plan year 2024 due to the preceding unique facts and circumstances. The Plan would have remained below the threshold of 120 participants at the beginning of the plan year 2024 had this miscommunication between the Plan and Vanguard Ascensus been resolved, and the Plan is working with Vanguard Ascensus to resolve this matter. To that end, we expect all remaining small amount participant balances, that would otherwise have been addressed and distributed via small amount force out provision, to resolve in the present year as we are winding down the Plan due to acquisition of the Plan Sponsor in April 2025.
