Basis for Opinion

1. DESCRIPTION OF PLAN

The following description of PrecisionCare (the “Company”) PrecisionCare 401(K) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2019, and amended during 2019 to comply with current provision in the law, covering all eligible employees of Orthopedic Associates of Long Island and Advanced Orthopedics, both divisions PrecisionCare. The effective date of participation is the first day of each seventh month following the date of satisfaction of the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company, as Plan administrator, has appointed AdvisorTrust, Inc, as the trustee of the Plan. PCS Retirement, LLC. provided recordkeeping and other administrative services for the Plan.

Eligibility

All employees, of the Company are eligible to participate the first day of the seventh month coinciding with satisfying the minimum eligibility of completing one year of service.

Participants Contributions

Participants may contribute up to 100% of their pretax compensation each year, as defined in the Plan document, not to exceed the annual limit established by the Internal Revenue Code (“IRC”). Participants who attain age 50 before the end of the calendar year are eligible to make additional catch-up contributions. The Company is required under the safe harbor provisions to make fully vested minimum contributions to eligible employees. In return, the Company avoids the restrictive nondiscrimination provisions that limit the permissible amount of annual salary deferrals by highly compensated employees. The Company may make qualified non-elective contributions to the Plan determined at its discretion. Rollover contributions are accepted into the plan, even if the employee is not yet a participant. The Plan also has Roth provisions.

Participant Accounts

Each participant’s accounts is credited with the participant’s contribution and allocations of Plan investment earnings or losses, and are charged with an allocation of administrative fees. Allocations are based on the participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's qualified non elective contributions portion of their accounts, if any, plus actual earnings thereon, is based on years of continuous service. With respect to the company's discretionary portions, if any, a participant is 0% vested fewer than two year of continuous service increasing annually to 100% after six year or more of credited service.

1. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000, or 50% of their vested account balance. Participants are allowed to have one outstanding loan at a time. The loans, in the form of promissory notes, are secured by up to 50% of the balance in the participant's account and bear interest at reasonable rates. Principal and interest are paid through direct payroll deductions. Loans must normally be repaid within such period as agreed to between the participant and plan administrators. Interest rates on loans are determined by the Administrator and will bear interest at a rate consistent with the provisions of Section 4975(d)(1) of the Internal Revenue Code. As of December 31, 2024 and 2023, there were nine loans amounting to \$30,853 and \$28,529, respectively.

Payment of Benefits

On termination of service by reason of retirement, death, or disability, a participant (or their beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or as selected by the participant or beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In service and hardship distributions are permitted by the Plan.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants may be reclassified as distributions based on the terms of the Plan document. The Plan recognizes interest income from the notes receivable as earned.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Dividends are recorded on the ex-dividend date. Interest is included in income when earned, based on the terms of the investments and the periods during which the investments are owned. Purchases and sales of securities are recorded on a trade-date basis. The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Company has elected to pay certain administrative expenses out of the Plan assets. Fees charged to process participant loan requests are charged directly to the participant's account and are included in administrative expenses as provided by the Plan document. Investment related expenses are included in net appreciation of fair value investments.

3. INVESTMENT INFORMATION CERTIFIED BY PLAN'S TRUSTEE

The following is a summary of the investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared or derived by Advisor Trust, Inc., the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained a certification from the trustee that such information is complete and accurate.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions to any of the various investment options offered by the Plan. Participants may change their investment options at any time.

4. FAIR VALUE MEASUREMENTS

The Plan accounts for financial instruments measured at fair value in accordance with accounting guidance for fair value measurements and disclosures which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

4. FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds: Mutual funds are stated at fair value based on unadjusted quoted prices in an active market for each share held by the Plan.
- Common collective trust fund: Common collective trust funds are stated at fair value, which is determined by the trustee of the common collective trust based on the underlying assets, which represents the net assets value of units held by the trust. The common collective trust fund invests primarily in bonds and equity securities (corporate debt instruments, government issued securities and equity securities). The common collective trusts do not have any unfunded commitments related to its investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

5. PARTY-IN-INTEREST

Certain plan investments are recorded managed by Professional Capital Services, LLC. Professional Capital Services, LLC is the recordkeeper of the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for recordkeeping services are included in the net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Fees paid by the participants of the Plan for administrative expenses amounted to \$50,903 for the year ended December 31, 2024.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. TAX STATUS

The Plan is a prototype non-standardized defined contribution plan. The Plan has obtained an opinion letter on the prototype plan dated March 29, 2012, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the “Code”). Generally, the Plan administrator and the Plan may rely on the opinion letter as to the form of the Plan qualifying under the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

8. RISKS AND UNCERTAINTIES

The Plan’s investments are concentrated in funds that invest in marketable equity securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain equity securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available for issuance.
