**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Envoy 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Envoy Global Inc., CIP, and Rise Foundation, PC (the “Affiliated Companies” or, collectively, the “Plan Sponsor”) who are 21 years of age or older and have completed one month of service. During 2021 the plan amended its eligibility, requiring any new participants to be full-time employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute the maximum allowable by law of pretax, or after-tax Roth annual compensation, as defined in the 401(k) plan provisions. Eligible employees are automatically enrolled into the Plan contributing 6% of eligible compensation, unless participation is declined. The Plan has an auto-escalation program which increases a participant's contribution by 1% each year until they reach a contribution level not to exceed 10% of the participants pay. Participants may opt out of the auto escalation program. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants over the age of 50 are also permitted catch-up contributions subject to statutory limitations. Employer matching contributions are discretionary. The Plan Sponsor may also make non-elective contributions at the option of the Plan Sponsor's Board of Directors. No non-elective contributions were authorized at the Affiliated Companies for the current Plan year. Contributions are subject to certain limitations. Plan participants direct the investment of their contributions and the employer matching contributions and non-elective contributions into the various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Plan Sponsor's contributions and (b) Plan earnings and is charged with his or her withdrawals and an allocation of (a) plan losses and (b) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Notes Receivable from Participants: Participants who have met the Plan's eligibility and entry date requirements may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance of loans during the one-year period ending on the day before the new loan is made or the greater of 50% of the participants vested account balance less any outstanding loan balance on the date the new loan is made or \$10,000 less any outstanding loan balance on the date the new loan is made. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions.

Vesting: Participants are immediately vested in their contributions, rollovers, employer matching contributions, and any discretionary employer contributions.

Forfeitures: Forfeitures of Affiliated Company contributions are first used to pay administrative expenses. Remaining forfeitures shall then be applied to reduce the earliest employer contributions that were made after the forfeiture occurred.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Plan Sponsor.

Payment of Benefits: On separation of service due to termination, death, disability, or retirement, a participant will receive a lump-sum payment equal to the value of the participant's vested interest in his or her account if their vested account is less than \$5,000. If the vested balance is greater than \$5,000 a participant can choose from three different forms of payment. Hardship and other in-service withdrawals are permitted if certain criteria are met.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 3 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the trustee of the Plan), and Principal Life Insurance Company, as agent for Principal Global Investors Trust Company.

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

*Mutual Funds* – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trust Funds* – The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

**NOTE 4 – FAIR VALUE MEASUREMENTS** (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

\* Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds a traditional fully benefit-responsive investment contract with Principal Life Insurance Company (Principal; Issuer). Principal maintains the contributions in its general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Plan Sponsor, and certain other Affiliated Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan.

If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The Fixed Income Guaranteed Option Fund is a group annuity contract issued by Principal Life Insurance Company. The contract maintains a minimum guaranteed interest rate that cannot be less than 0.15% or more than 3%. On a semi-annual basis, Principal determines the declared interest rate which will be applicable to all monies invested in the Fixed Income Guaranteed Option funding such calendar year. Assets under the contracts will be credited with the greater of the declared interest rate and the applicable minimum guaranteed interest rate.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain plan investments are invested in funds and guaranteed investment contracts administered by Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Company, or their affiliates. As Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Company are service providers of the Plan, these investments qualify as party-in-interest investments. Fees paid by the Plan to Principal Life Insurance Company and other services providers also qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE 9 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure October 14, 2025, which is the date the financial statements were available to be issued.
