## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Covenant Health 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Covenant Health 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

#### NOTE 1--DESCRIPTION OF PLAN

The following brief description of Covenant Health 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan established by Covenant Health (the Plan sponsor) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Plan sponsor and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

Employees of the Plan sponsor and certain of its subsidiaries who have completed 90 days of service and are 21 years of age or older are eligible to participate in the Plan. Upon satisfying the eligibility requirements, employees may participate in the Plan immediately upon eligibility.

*Contributions:* Participants may elect to contribute to the Plan, through salary reduction, a percentage of their eligible compensation for the Plan year up to the Internal Revenue Service (IRS) limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective January 1, 2024, the Plan was amended to permit Roth (after-tax) deferral contributions to the Plan. The following contribution types are allowed by the Plan:

- Rollover contributions
- Elective deferrals
- Employer matching
- Roth deferrals

The Plan sponsor and subsidiaries may contribute to the Plan a matching contribution of 3 to 6 percent of compensation for qualified participants employed at year end. Participants direct the investment of all contributions into various investment options offered by the Plan.

*Participant Accounts:* Each participant's account is credited with the participant's contributions, the Plan sponsor's matching contributions, and an allocation of Plan earnings or losses; it is also charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the vested benefit of their account balance.

*Vesting:* Participants are immediately vested in their salary reduction contributions, including catch-up contributions, rollover contributions from other plans, plus actual earnings thereon. Participants are vested in matching contributions based on years of credited employment and employment date as follows:

*Forfeitures:* Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Plan sponsor contributions to be used to reduce future employer contributions.

As of December 31, 2024 and 2023, forfeiture balances totaled \$578,500 and \$623,114, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$1,027,635 were used to reduce employer contributions.

*Notes Receivable from Participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum balance or percent subject to IRS limits. The loans are secured by the balance in the participant's account and bear interest at rates between 3.25% and 8.50% as of December 31, 2024. The term of a loan is no longer than five years unless the loan is used to purchase a principal residence. Principal and interest are paid through payroll deductions.

*Contributions:* Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

*Payment of Benefits:* Upon termination of service due to death, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. A participant or their beneficiary may elect to receive either a lump-sum amount equal to the participant's account balance or annual installments over a specified period. For termination of service due to other reasons, a participant may receive their account balance as a lump-sum distribution. Distribution of a deceased participant's account will be made to the designated beneficiary.

The following types of distributions are also allowed by the Plan:

- Hardship
- In service, Age 59 ½
- Involuntary cash-outs
- Termination partial withdrawal

*Administrative Expenses:* Administrative expenses related to maintaining participant accounts and third-party administration are paid by the Plan and deducted from participant funds. Other Plan expenses may be paid by either the Plan or the Plan sponsor, as provided by the Plan document. Expenses paid directly by the Plan sponsor are excluded from these financial statements.

*Plan Termination:* Although it has not expressed any intent to do so, the Plan sponsor has the right under Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants become immediately vested in their account balance.

#### NOTE 2--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting:* The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates:* The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition:* Investments in shares of registered investment companies are reported at fair value based on the quoted market values of the shares held by the Plan as determined by the trustee.

Units of interest in collective trust funds are reported at the net asset value of the underlying assets in the trust. The net asset value is used as the practical expedient to estimate fair value as participant transactions occur daily at this value. This practical expedient would not be used if it was determined to be probable that the redemption of units would be at a different value.

Money market funds are stated at cost which equals fair value.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are stated at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recognized as benefits paid to participants based upon the terms of the Plan document.

*Payment of Benefits:* Benefits are recorded when paid.

#### NOTE 4--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The investment valuation methods described in Note 2 may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Investments Measured Using the Net Asset Value as a Practical Expedient:* The Plan offers a collective trust investment option to participants through Fidelity Management Trust Company's Managed Income Portfolio (the Portfolio). The Portfolio's investment objective is to preserve the principal investment and earn a level of income that is consistent with this objective. The Portfolio invests primarily in U.S. government and agency securities and nonconvertible bonds. The Portfolio strives to maintain a \$1 net asset value through entering into various wrap contracts with third-party banks and insurance companies. Participants may initiate contributions to or withdrawals from the Portfolio daily at the net asset value. Withdrawals initiated by the Plan sponsor must be preceded by a redemption notice of up to 12 months.

#### NOTE 5--RELATED PARTY TRANSACTIONS AND TRANSACTIONS WITH PARTIES-IN-INTEREST

Parties-in-interest as defined by DOL regulations include service providers to the Plan. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor. Certain Plan investments are shares of registered investment companies or units of interest in collective trust funds managed by Fidelity Management Trust Company or related organizations. Fidelity Management Trust Company is the trustee as defined by the Plan, and therefore, these transactions

qualify as party-in-interest transactions. Certain fees paid by the Plan for investment management services are included in the net depreciation in fair value of investments.

During the year ended December 31, 2024, the Plan made direct payments to Fidelity Management Trust Company and Fidelity Investments Institutional Operations Company, the recordkeeper as defined by the Plan, of \$274,072.

#### NOTE 6--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and could materially affect participants' account balances as well as the amounts reported in the statement of net assets available for benefits.

#### NOTE 7--INCOME TAX STATUS

The Plan sponsor adopted a plan that received a favorable letter from the Internal Revenue Service dated October 11, 2011, which states that the Plan is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan Administrator has evaluated the tax positions taken by the Plan and determined there are no uncertain tax positions as of December 31, 2024, that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 8--SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any material recognizable subsequent events that required recognition or disclosure in the financial statements.
