Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Buyers Barricades, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

Opinion

Notes to the Financial Statements December 31, 2024 and 2023

Note 1 – Plan Description

The following description of the Buyers Barricades, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution benefit plan that provides retirement savings benefits to all eligible employees of Buyers Barricades, Inc. (the “Employer” or “Company”). The Plan commenced January 1, 2011, and was amended and restated effective January 1, 2021, to comply with the latest rules and regulations, and again effective April 30, 2021, to permit hardship withdrawals. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodians and Trustees

Effective March 15, 2024, American United Life Insurance Company (“AUL”), a OneAmerica Financial company, was appointed as the new custodian of the Plan and OneAmerica Retirement Services LLC was appointed as the new recordkeeper. Prior to March 15, 2024, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America (collectively, “Empower”) served as the Plan’s custodian and Empower Retirement, LLC served as the recordkeeper. Collectively, AUL and Empower are referred to herein as the “Custodians”. Certain officers of the Employer serve as Trustees of the Plan.

The Custodians maintain custody of all investments held by the Plan, maintain the Plan’s participant account balances, and provide recordkeeping services to the Plan. Among other duties, the Custodians receive contributions, hold and invest the fund assets in accordance with the directions of participants, and make distributions as directed by the Plan Administrator.

As a result of the change in Custodians noted above, the Plan’s assets were transferred from Empower to AUL and the Plan experienced a blackout period from March 8, 2024 to March 31, 2024. During this blackout period, participants could not direct or diversify their investments nor obtain a distribution from the Plan.

Eligibility

Certain employees are excluded from participation in the Plan, including those under collective bargaining agreements and non-resident aliens. All other employees aged 21 and older become eligible to participate in the Plan upon completing 60 days of service. Eligible employees are permitted to enter the Plan beginning the first date of the Plan year quarter coinciding with or next following the date all requirements are satisfied.

Participant Contributions

Participants may elect to defer, on a pre-tax or Roth basis, a certain percentage or dollar amount of their eligible compensation, up to the maximum amount permitted for deferral annually by the IRC, which was \$23,000 for 2024. Participants who reach the age of 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually under the IRC, which was \$7,500 for 2024.

Note 1 – Plan Description (continued)

Rollover Contributions

Rollover contributions may also be accepted by the Plan on behalf of participants from other plans qualified under Section 401(a) of the IRC, provided that such rollover contributions are approved by the Plan Administrator.

Employer Contributions

The Plan provides for Safe Harbor Employer matching contributions. For the 2024 Plan year, the Company made Safe Harbor Employer matching contributions to the Plan on behalf of participants in an amount equal to 100% of a participant's elective contributions up to a maximum of 4% of such participant's eligible compensation as defined by the Plan. The Plan also permits the Employer to make discretionary matching contributions. No such contributions were made for the 2024 Plan year.

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants may direct their account balances to one or more of these investment options, which vary in type of investment, rate of return, and investment risk.

Vesting

Participants are immediately 100% vested in their own contributions and the Company's Safe Harbor Employer matching contributions, plus actual earnings thereon. Vesting in Employer discretionary matching contributions is based on years of service, with a participant becoming 20% vested after two years of service and increasing by 20% each year thereafter, reaching full vesting after 6 years of service.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant receives a lump sum amount equal to the value of the participant's vested interest in his or her account. If the terminated participant's vested account balance exceeds \$5,000, the participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. Distributions to terminated participants with a vested account balance that does not exceed \$5,000 are made as a lump sum as soon as administratively feasible. Effective April 30, 2021, the Plan permits hardship distributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Note 2 – Summary of Significant Accounting Policies (continued)

Basis of Accounting (continued)

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses incurred by, or attributable to, a specific participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are as follows:

Note 3 – Fair Value Measurements (continued)

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs that are unobservable inputs for the assets or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Pooled Separate Accounts** – Valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodians. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations are carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

Note 4 – Information Certified by the Custodians

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Effective March 11, 2024, the Plan changed its qualified institution from Empower Trust Company, LLC, and Empower Annuity Insurance Company of America to American United Life Insurance Company, a OneAmerica Financial company.

Accordingly, Empower Trust Company, LLC; Empower Annuity Insurance Company of America; and American United Life Insurance Company, a OneAmerica Financial company, have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

Note 5 – Guaranteed Investment Contract

The Plan has a guaranteed investment contract with Empower Insurance Annuity Company of America and American United Life Insurance Company (collectively, the “Issuers”) in the form of a group annuity contract that invests contributions in a general account product (the “Fixed Account”). Interest earned on the Fixed Account value is compounded daily to the effective annual interest rate. The interest rate to be credited to the Plan will be determined by the Issuer prior to the last day of the previous calendar quarter. The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. This guaranteed investment contract is a traditional investment contract. The Issuers are contractually obligated to repay the principal and interest at a specified interest rate guaranteed to the Plan. The crediting rate is based on a formula established by the Issuer, but may not be less than 1%, and the rate is reviewed for resetting on a quarterly basis. The contract cannot be terminated before the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the Issuer. Such events include: (a) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

Note 6 – Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts, and a guaranteed investment contract managed by the Custodians. These transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any unvested Employer contributions.

Note 8 – Tax Status

The Plan operates under a volume submitter profit-sharing plan (the “Volume Submitter Plan”) sponsored by Loren D. Stark Company. The Internal Revenue Service (“IRS”) informed the Volume Submitter Plan sponsor by letter dated November 30, 2020, that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of Section 401 of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. As such, they believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 – Prohibited Transactions

The Company failed to remit the Plan’s Custodians certain participant contributions totaling \$12,178 within the period prescribed by the DOL’s Rules and Regulations. Delays in remitting contributions were due to unintentional administrative errors, and the Company is in the process of making contributions to the affected participants to compensate for potential lost earnings due to the delays.

Note 11 – Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements presented herein were available to be issued.
