### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of PDG 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PDG 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

#### **Opinion**

### ***Basis for Opinion***

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about PDG 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 – Description of the Plan

The following description of the PDG 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document, as amended, for a more complete description of the Plan's provisions.

**General** – The Plan is a 401(k) salary deferral plan originally established on January 1, 2022, by Process Distribution Group (formerly known as PDG) (the Company). The Plan is sponsored and administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In 2023, the Company was acquired by GBE2, LLC, a subsidiary of Graybar Electric Company, Inc. (Graybar). Since the acquisition, the Plan has been amended and restated, which served to align the terms and conditions of the Plan with the applicable terms of the profit sharing and savings plan sponsored by Graybar, including the creation of a Company match feature.

In 2024, the Company announced the assets and participant account balances of the Plan would be merged into the Profit Sharing and Savings Plan of Graybar Electric Company, Inc. (Graybar Plan) effective January 1, 2025 pursuant to an executed merger agreement. In accordance with the terms of the merger agreement, substantially all Plan assets were transferred to the Graybar Plan by wire on the first business day of January 2025, except for assets held in the Plan's fully benefit-responsive investment contract (FBRIC) assets and contributions receivable from the last pay period of the year.

**Eligibility** – Employees of the Company are eligible to participate in the Plan immediately upon hire with no minimum age. Employees are eligible to receive an employer matching contribution after the completion of six months of service.

### Contributions

*Participant contributions* – Each year, participants may contribute between 2% and 50% of pretax annual compensation, as defined in the Plan, subject to regulatory limitations. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 20%.

*Employer matching contributions* – The Company shall make before-tax matching contributions equal to 50% of employee pre-tax and Roth contributions which do not exceed 6% of the participants compensation for such payroll period. In no event shall the company matching contribution for any payroll period exceed three percent (3%) of the participants compensation for such payroll period. There were \$344,161 of employer matching contributions for the year ended December 31, 2024.

**Participant accounts** – Each participant’s account is credited with the participant’s contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon.

Effective December 1, 2023, employer matching contributions are fully vested after three years of service.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time. Under the terms of the Plan agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rate of interest on outstanding loans ranged from 4.25% and 9.50%, with various maturities through October 2029.

**Payment of benefits** – On termination of service due to death, disability, reaching age 59½, or retirement, a participant (or their beneficiary) may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. For participants with account balances less than \$5,000, the Plan administrator may distribute the amount as a lump sum or roll it into an individual retirement plan, unless otherwise directed by the participant.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan, must be used in the subsequent year and will be used to pay the Plan’s administrative expenses.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value and contract value. The Plan’s custodians, Empower Annuity Insurance Company of America (Empower) and Empower Trust Company, LLC (Empower Trust), certify the value of investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

With the exception of fully benefit-responsive investment contracts subject to a put period, contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because it represents the amount participants would typically receive if they initiated permitted transactions under the terms of the Plan.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** –Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** –Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** –Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methods used for assets measured at fair value. During the year ended December 31, 2024, the valuation methodology for the fully benefit-responsive investment contract (FBRIC) changed from contract value to fair value following the commencement of the put period in connection with the Plan's anticipated merger into the Graybar Plan, effective January 1, 2025. This change was made because the Plan ceased to retain the contractual right to transact at contract value with the issuer or participants as of that date.

*Common trust funds* – Units held in common trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

*Guaranteed investment contract* – Fair value for FBRICs subject to a put period is determined using Level 2 inputs within the fair value hierarchy. These inputs include quoted prices for similar instruments in active markets and other observable market data such as relevant interest rates and yield curves. When quoted prices for identical contracts are not available, the fair value is estimated using market-based valuation models that maximize the use of observable inputs.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Below is the investment strategy for the common trust funds investment that represent more than 5.00% of net assets as December 31, 2023:

*BlackRock Equity Index Fund CL 1* – The Fund seeks to achieve investment results that are similar to the price and yield performance, before fees and expenses, of the S&P 500 Index. To implement this objective, the Fund will be invested in the Equity Index Fund F (the Underlying Fund) managed by BlackRock Institutional Trust Company, N.A.

*Indexselect Moderate 2025 Fund CL I* – The Fund seeks to provide long-term investors with an asset allocation strategy designed to maximize assets for retirement consistent with the risk level and projected retirement date associated with each fund. The funds are designed automatically to adjust their risk over time in order to reduce the risk of investment in equity securities and shift from a focus on capital appreciation to one of capital preservation, while maintaining some exposure to capital appreciation asset classes.

*Indexselect Moderate 2035 Fund CL I* – The Fund seeks to provide long-term investors with an asset allocation strategy designed to maximize assets for retirement consistent with the risk level and projected retirement date associated with each fund. The funds are designed automatically to adjust their risk over time in order to reduce the risk of investment in equity securities and shift from a focus on capital appreciation to one of capital preservation, while maintaining some exposure to capital appreciation asset classes.

*Indexselect Moderate 2045 Fund CL I* – The Fund seeks to provide long-term investors with an asset allocation strategy designed to maximize assets for retirement consistent with the risk level and projected retirement date associated with each fund. The funds are designed automatically to adjust their risk over time in order to reduce the risk of investment in equity securities and shift from a focus on capital appreciation to one of capital preservation, while maintaining some exposure to capital appreciation asset classes.

*Large Cap Value Fund CL I1* – The strategy seeks to outperform the market over time by employing a value-oriented approach to identify potential opportunities for revaluation for fundamental improvement. flexPATH Strategies, LLC, has recommended, and the Trustee has approved the Putnam Large Cap Value Trust as the underlying fund.

*Large Cap Growth Fund III CL I1* – The Fund seeks long-term capital growth by investing in equity securities of large cap growth companies. To implement this objective, the Fund will be invested in the AB US Large Cap Growth Collective Trust (the Underlying Fund), a fund of the AB Collective Investment Trust Series.

*International Stock Fund* – The Fund seeks total return over full market cycles by investing in the PIMCO RAE Internation CIT (Underlying Fund), for which Great Gray Trust Company, LLC, is trustee and Pacific Investment Management Company LLC (with its affiliate Research Affiliates LLC) is subadviser. Under normal circumstances, the Underlying Fund invests at least 80% of its assets in investments that are economically tied to foreign (non-U.S.) countries.

### **Note 4 – Guaranteed Investment Contract with Insurance Company**

In 2020, the Plan entered into a FBRIC with Empower, formerly known as Great-West Life & Annuity Insurance Company. Empower maintains the contributions in a general account, crediting earnings on the underlying investments and charging for participant withdrawals and administrative expenses. The contract issuer is obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, with a minimum of 0%. The rate is reviewed and reset quarterly and declared at least 48 hours in advance of each reset. The contract prohibits the issuer from terminating the agreement prior to the scheduled maturity date, except as provided by specific contractual provisions.

The underlying investments supporting the contract are held in the Empower Investments Fixed Account. The fund seeks to achieve consistent returns to support a competitive crediting rate. Bonds in the general account segment have an average maturity between three and seven years and are diversified across a range of fixed-income asset classes, including asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgages, and private placements.

Contract value is the relevant measure for FBRICs as this typically reflects the amount received by participants for permitted transactions. Contract value represents contributions made, plus earnings, less participant withdrawals and administrative expenses. Participant transactions at contract value are generally permitted, except as modified during the put period.

The Plan's ability to receive amounts due depends on the issuer's financial strength, which may be affected by future economic and regulatory conditions.

Certain events may limit the Plan's ability to transact at contract value, including: (1) amendments to the Plan documents (e.g., termination or merger), (2) changes to competing investment option restrictions, (3) sponsor bankruptcy or divestitures causing significant Plan withdrawals, (4) failure of the trust to maintain exempt status, or (5) premature contract termination. No such events, other than initiation of the put period in connection with the merger, are probable as of December 31, 2024.

In connection with the Plan's merger into the Graybar Plan effective January 1, 2025, the Plan initiated the put period on the FBRIC beginning November 12, 2024, and requested payout of assets on November 12, 2025 (or the next business day if the put expiration falls on a weekend, holiday, or during a market closure), in accordance with the contract.

As a result of the initiation of the put period in November 2024, the Plan's ability to transact at contract value with the issuer and participants has terminated. Accordingly, due to the status of the put period and the related restrictions, as of December 31, 2024, the FBRIC is reported at fair value on the statement of net assets available for benefits.

The FBRIC will remain in the Plan until the expiration of the contractual put period, which is anticipated to be in November 2025.

#### **Note 5 – Tax Status**

The Plan document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service dated January 15, 2021, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits. At times, the balance of cash may be in excess of insured limits.

#### **Note 7 – Certified Investment Information**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower and Empower Trust, the custodians of the Plan, have certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.
- Schedule of reportable transactions for the year ended December 31, 2024.

### Note 8 – Party-In-Interest Transactions

Certain Plan investments are managed by Empower and Empower Trust, the custodians of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

### Note 9 – Plan Merger

Effective January 1, 2025, the Plan will be merged into the Graybar Plan. Upon completion of the merger, the Plan will cease to exist as a separate plan, and all assets and participant accounts will be transferred to the Graybar Plan, subject to the provisions of ERISA. The Company reserves the right to discontinue contributions and terminate the Plan prior to the effective merger date, but has not expressed any intent to do so.

### Note 10 – Reconciliation to Form 5500

Effective January 1, 2025, the Plan will be merged into the Graybar Plan. On the first business day of January 2025, substantially all Plan assets, except for the Plan's FBRIC assets and contributions receivable from the last pay period of the year, were transferred via wire to Vanguard, the custodian of the Graybar Plan.

As of December 31, 2024, the accompanying statement of net assets available for benefits include the FBRIC assets, and a balance of non-interest bearing cash representing participant account balances that were scheduled for transfer to the Graybar Plan. The transfer was directed as soon as administratively practicable after the effective merger date of January 1, 2025. The assets of the Plan in the accompanying statement of net assets available for benefits presented at December 31, 2024, reflect the assets under the control of the Plan at that date in accordance with GAAP. The actual wire transfer of the cash balance occurred on the first business day of January 2025, resulting in a timing difference between the financial statements and the reporting of remaining Plan assets on the Form 5500.

For Form 5500 Schedule H reporting purposes, only the residual FBRIC assets remaining in the Plan after the transfer were reported as Plan assets at year-end, consistent with regulatory reporting requirements and the legal completion of the Plan merger. Accordingly, the net assets available for benefits presented in these financial statements differ from the net assets reported on Form 5500 Schedule H as of December 31, 2024, due to the timing of the asset transfer and differences in reporting methodologies.
