

## SPECIALEYES OPTOMETRY CASH BALANCE PENSION PLAN, PLAN ID 002

A deficiency is reported for the minimum required contribution (MRC) for the 2024 plan year in accordance with prevailing guidance that IRS disaster relief for the LA County wildfires did not explicitly extend the Section 430 funding deadline. The plan actuary advised reporting this deficiency and filing Form 5330 to address excise tax liability.

The plan sponsor relied on the statutory intent of IRC Section 7508A, Revenue Procedure 2018-58, Section 8, IRS CA-2025-01, IRS News Release IR-2025-10, and the CA FTB Emergency Tax Relief which are designed to extend deadlines for disaster victims to perform 'time-sensitive acts.' The deadline was extended to October 15, 2025. Section 404(a)(6) states: Employer contributions paid to a qualified pension, profit-sharing, or stock bonus plan after the close of the taxable year but not later than the time prescribed by law for filing the return for such year (including extensions thereof) shall be considered made on the last day of such year. The sponsor relied on broad IRS guidance, that disaster relief extensions covered the Section 430 deadline.

The plan sponsor funded the plan on October 3, 2025, believing the MRC due date was extended until October 15, 2025. The sponsor respectfully requests IRS and PBGC consideration for reasonable cause and abatement of the excise tax given disaster conditions and prompt corrective action undertaken in good faith.
