Opinion

(1) Description of Plan

The following brief description of the ValSource, Inc. (the Company) Employee Stock Ownership Plan (ESOP or the Plan) is provided for general information purposes only. Participants should refer to the trust agreement for a complete description of the Plan's provisions.

General

The Company established the Plan effective January 1, 2016. The ESOP is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Trustee, appointed by the Company's Board of Directors, is responsible for oversight of the Plan.

The Company acquired full ownership of Concordia ValSource, LLC as of December 31, 2019. The employees of Concordia ValSource, LLC are eligible for participation in the Plan beginning January 1, 2020, subject to the same eligibility requirements outlined below.

In 2016, the Plan purchased 98,803 shares of the Company's preferred stock.

On December 21, 2020, the preferred stock owned by the ESOP and the remaining outstanding preferred stock of the Company were converted to common stock.

On December 23, 2020, the Plan purchased the remaining 144,351 shares of the outstanding common stock of the Company for an aggregate purchase price of \$28,994,989 from existing stockholders. The majority of the transaction was financed with a loan from the Company (Note 4).

Borrowing by the Plan

The borrowings are collateralized by the unallocated shares of common stock and are guaranteed by the Company. The unallocated shares are held in escrow and not allocated to any single participant. During the period the Plan has a loan outstanding, Company contributions to the Plan are first allocated to make the required payments under the loan. As the Plan repays the loan, the shares are released in proportion to the amount of the principal plus interest paid each plan year in relation to the total principal and interest payments over the term of the loan.

Eligibility

Employees of the Company are generally eligible to participate in the Plan after attaining age 21 and upon completion of 1,000 hours of service during the plan year. A participant's entry date is the January 1 immediately preceding the later of the completion of 1,000 hours of service during an eligibility computation period or the date the employee attains the age of 21. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year. Effective January 1, 2017, an employee who is a participant in the Company's 401(k) plan and is eligible to receive a safe harbor contribution from the 401(k) plan, as defined, is eligible to participate in the Plan regardless of hours of service.

Employer Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payment of principal and interest on its loans. The Company may also make safe harbor contributions to the Plan as provided by the Company's 401(k) plan.

Payment of Benefits

Employees who terminate employment with the Company on or after normal retirement age (age 65) or upon death or disability, will receive distributions no later than the last day of the plan year following the event. Other terminated participants may elect to receive distributions commencing no later than one year after the fifth year following the plan year in which such termination occurs. Participants who terminate employment with the Company with vested balances of \$1,000 or less will receive such benefits in a lump sum by the end of the plan year following the plan year in which such termination occurs.

Distributions are made in Company stock or cash. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to certain matters, and is notified by the trustee prior to the time that such rights are to be exercised. The trustee shall vote such allocated shares of Company stock as instructed by participants. Allocated shares for which no instruction is received shall be voted by the trustee at their discretion.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be fully vested and will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan and the IRC. Upon termination of the Plan, the trustee will pay all liabilities and expenses of the trust fund and sell shares of financed stock, if any, held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loans.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of shares released from unallocated to allocated, any Company contributions or dividends not used for debt payments, and any forfeitures. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations of Company contributions and forfeitures are based on a participant's eligible compensation, relative to total eligible compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase, with interest, over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Vesting

Subject to certain provisions as fully described in the plan document, the portion of the participant's account that is vested (nonforfeitable) on any specified date shall be determined on the basis of his or her years of service in accordance with the following schedule:

A participant's account shall also become 100% vested and nonforfeitable upon the participant's attainment of his or her normal retirement age while employed by the Company, or upon the participant's death or disability while employed by the Company.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 and with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered over a six-year period commencing in the year the participant qualifies to diversify. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify are provided the ability to invest proceeds into at least three options provided by the Plan or another plan sponsored by the Company, or to elect to receive cash.

Forfeited Accounts

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants totaled \$317,584 during the year ended December 31, 2024.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated), and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

The common stock of the Company is stated at estimated fair value. Estimated fair value is determined by an annual independent appraisal. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is accrued on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan Trustee controls and manages the operations of the Plan. Certain administrative expenses of maintaining the Plan are paid by the Company.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

ValSource, Inc. common stock: The Company's stock is not actively traded and significant other observable inputs are not available. Thus, the fair value of the common stock is determined by an annual independent appraisal. This appraisal is based upon a combination of the market and income valuation techniques consistent with prior years. The valuation process involves the selection of an appraiser approved by the Trustee and Board of Directors. Plan management accumulates the data for the appraiser from financial information of the Company, including historical and projected cash flows and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. Plan management, the Trustee and the Board of Directors review and approve the appraisal report before it is finalized. As of December 31, 2024 and 2023, the common stock was valued at \$192.93 and \$210.61, respectively. The Company stock is the only investment held by the Plan as of December 31, 2024 and 2023, respectively, and is categorized as level 3.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value of Level 3 Investments

During 2024 and 2023, there were no purchases or transfers into or out of the investment included in level 3 of the fair value hierarchy. The unrealized gain (loss) on the Company's common stock is included in net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits.

In 2020, the Plan entered into a \$28,092,800 term loan agreement bearing interest at 1.31% with the Company. The proceeds of the loan were used to purchase 144,351 shares of the Company's common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year principal and interest payments divided by the total of the current year principal and interest payments plus all future years' principal and interest payments. The agreement provides for the loan to be repaid in 25 equal installments of principal plus interest through 2045.

The Company has made cash prepayments on the loan in previous years and as a result, there are no required scheduled principal payments on the loan for 2025 and 2026.

(5) Related Party Transactions and Party-In-Interest Transactions

The Plan invests in Company stock. As discussed in Note 2, the Company also pays certain expenses related to the Plan's operations directly. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Certain administrative functions of the Plan are performed by officers or employees of the Company. No officer or employee receives compensation from the Plan.

(6) Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated April 12, 2018, stating that the Plan is qualified under the IRC and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the code and as such is exempt from federal taxes.

(6) Tax Status, Continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions.

(7) Risks and Uncertainties

The Plan's investment in Company common stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with this investment, it is at least reasonably possible that changes in the value of Company common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
