Scope and Nature of the *ERISA Section 103(a)(3)(C)* Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of UMC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Opinion on the 2024 Financial Statements

- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about UMC 401(k) Plan 's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at the end of the year as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated October 8, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note A – Description of the Plan

The following brief description of the UMC 401(k) Plan (“the Plan”) provides general information only. Participants should refer to the underlying Plan documents for a more complete description of the Plan’s provisions.

General

The Plan was established on April 1, 1998, and was most recently restated on March 17, 2022. The Plan is a defined contribution plan sponsored by UMC Group (USA) and United Microtechnology Corporation, its sister company (collectively the “Company”), covering all employees of the Company who have attained the age of 18 or older, except employees who are residents of Puerto Rico and independent contractors not entitled to benefits under the Plan. The Plan is voluntary and provides that a participant or their beneficiary will receive the balance in their account upon retirement, employment termination, disability, or death. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Company and Fidelity Management Trust Company (“FMTC”), a third party administrator, to perform primary administrative, recordkeeping and asset management functions on behalf of the Plan.

Contributions

Participants may elect to make pre-tax contributions withheld from eligible compensation, subject to an annual limit of the lesser of 60% of eligible compensation or the annual limit of \$23,000 for 2024. The Plan provides that participants who are projected to be age 50 or older by the end of the taxable year and who are making deferral contributions to the Plan may also make catch-up contributions of up to \$7,500 for 2024. Participants will be eligible to designate some or all of their contribution as a Roth deferral contribution at the time participants make their deferral election. Eligible participants may begin contributing effective as of the first day of each month.

The Company makes a non-discretionary matching contribution of 25% of a participant’s deferral contribution subject to a maximum of 18% of a participant’s eligible compensation contributed to the Plan.

Participant Accounts

Each participant is credited with the participant’s contributions and an allocation of the Company’s contribution, plan earnings or losses, and charged with an allocation of administrative expenses. Allocations may be based on participant account balances or as further defined in the Plan document. Participants who have taken a distribution or note are charged a participant direct fee for processing of these transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s matching and non-discretionary contributions is based on a year of continuous service. Participants who complete one year of service are 100% vested; participants who terminate prior to completing one year of service forfeit the non-vested portion of their accounts. Forfeitures are used to reduce future Company contributions.

Forfeitures

As of December 31, 2024 and 2023, the balances of forfeited non-vested accounts were \$0. Forfeitures are used to reduce future employer contributions. For the year ended December 31, 2024, \$6,315 of employer matching contributions were reduced by forfeitures.

Note A – Description of the Plan (Continued)

Payment of Benefits

Each participant's share of the net assets of the Plan is segregated in an individual account. Distribution of each participant's vested interest in the Plan can be made, either as a lump-sum amount or annuity payments, at the earlier of death, disability, retirement, or upon termination of employment. Additionally, a participant may withdraw vested amounts from their account arising from salary deferral contributions prior to termination of employment after demonstrating financial hardship, as defined in the Plan document.

On termination of service due to death, disability or retirement, participants may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or annual installments over a period not exceeding the joint life expectancies of the participant and beneficiary. For termination of service due to other reasons, participants may receive the value of the vested interest in their account as a lump sum distribution. The Plan allows for automatic lump sum distributions of participant vested account balances that are equal to or below \$1,000. If a participant's vested account balance is greater than \$1,000 but equal or less than \$7,000, and the participant does not consent to the distribution, the Plan will automatically roll over the amount to an individual retirement account in the participant's name as designated by the Plan administrator.

Notes Receivable from Participants

Plan participants are permitted to borrow up to 50% of their vested account balance, subject to a minimum of \$1,000 and maximum of \$50,000. The term of the note cannot exceed five years, unless the note is used to purchase a principal residence, in which case the repayment period cannot exceed ten years. Participants may only have one note outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest rates, which are commensurate with rates of similar loans as determined by the Plan Administrator. As of December 31, 2024 and 2023, the outstanding notes receivable from participants balance was \$47,393 and \$57,523, respectively.

Administrative Expenses

Certain expenses of the Plan are paid by the Plan, unless otherwise paid by the Company.

Revenue Sharing Agreement

Effective June 1, 2022, the Company amended the Plan to enter into an agreement with FMTC to create an allowance arrangement to hold revenue sharing funds the Plan received from FMTC pursuant to a revenue sharing agreement. These funds are available to pay qualified plan administrative expenses. During the year ended December 31, 2024, the gross receipts from FMTC was \$53,870 which was used to pay administrative expenses totaling \$53,870.

Note B – Summary of Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Note B – Summary of Accounting Policies (Continued)

Use of Estimates

The preparation of the financial statements in accordance with U.S.GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investment funds are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments include the Plan's gains and losses on investments bought, sold and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Note C – Fair Value Measurements

U.S. GAAP provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note C – Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at fair value based on quoted market prices in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note D – Certified Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at the end of the year).

Note E – Party-In-Interest Transactions

The Plan allows notes receivable from participants, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Certain plan investments are managed by FMTC, the trustee as defined by the Plan. These transactions qualify as exempt party-in-interest transactions. See supplemental schedule H, line 4i for investments managed by FMTC.

Fees paid by the Plan for investment management services were \$53,870 for the year ended December 31, 2024.

Note F – Plan Termination

Although it has not expressed any intent to do so, the Companies have the right to terminate the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, all amounts credited to a participant’s account will become 100% vested. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

Note G – Income Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) issued a favorable opinion letter indicating the Plan qualifies under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), and therefore, the underlying trust is exempt from tax under Section 401(a) of the IRC. Consequently, a provision for income taxes has not been included in the Plan’s financial statements. Subject to future events and circumstances, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Company believes it is no longer subject to income tax examinations for years prior to 2020.

Note H – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan's investment options include funds that invest in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

Note I – Reconciliation of Financial Statements to Form 5500

There are no reconciling items between the financial statements at December 31, 2024, and the Form 5500.

Note J – Subsequent Events

The Plan's management has evaluated subsequent events through October 14, 2025, the date of which the Plan's financial statements were available to be issued.
